#### **RACING INCIDENTS**

**(Race No. 91 - 100)**

**GOING : Good**  
**Penetrometer Reading : 3.7 Cms**  
**Positioning of Railings : Railings fixed at average width of 3.5 Metres from 1600 Metres to the Winning Post from its original position.**

#### **1<sup>st</sup> Race: 91. The Amba Vilas Palace Plate (About) 1400 Metres. Horses rated 00 to 25 (15 Runners):**

As Jockey Sameer Qureshi, the declared rider of HERE I COME could not arrive to fulfill his riding engagement due to reasons beyond his control. Permission was granted to Trainer Mr. Joseph B Awale to substitute Jockey Afsar Khan to ride HERE I COME, in place of the declared rider.

GOLD CHARM (S John) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey H G Rathod, the rider of SCARLET PRINCESS was reprimanded for shifting in and inconveniencing D FIGHTER (Shreyas Singh) on his inside which in turn passed it onto FELICITA (Noorulla) soon after jumping out of the starting gates.

SALLY'S GIFT (R Ajay Kumar) jumped awkwardly inwards and inconvenienced AIR VELOCITY (Nazar Alam) on its inside soon after jumping out of the starting gates.

Jockey Noorulla, the rider of FELICITA was fined **Rs.1,000/-** for shifting in and causing interference to SO FAR (Sarvan Kumar), on his inside along the rails, passing the 1000 Metres.

Routine Sample was taken for analysis from the winner b g GAME BOY.

#### **2<sup>nd</sup> Race: 92. The Karighatta Stakes (About) 1600 Metres. Horses rated 20 to 45 (10 Runners):**

CIVITAVECCHIA (B Harish) after jumping out abruptly swerved towards the left thereby taking out the horses on its outside viz. VANDAN (Hindu Singh), FUN AND LAUGHTER (R Shiva Kumar) and WHISKEY SOUR (P Trevor) to the

outer sand track and dislodged its rider. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behavior improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the Race Track.

It was reported after the race that WHISKEY SOUR (P Trevor) burst its blood vessels during the race. Trainer Mr. Vinesh V Naik was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that CIVITAVECCHIA (B Harish) pulled up lame on left hind. Trainer Mr. Aditya K was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

**3<sup>rd</sup> Race: 93. The Nadir Plate (About) 1400 Metres. Horses rated 20 to 45, 5 years old and over (15 Runners):**

CALIFORNIA GOLD (Salman Khan) jumped out awkwardly at the Start.

Jockey Angad, the rider of COUNTRY'S PACE reported that he accidentally lost his whip passing the 150 Metres.

**An enquiry is being held into the vastly improved performance of BEAT THE ODDS trained by Mr. P C Tejaswi and ridden by Jockey Mohammed Mushraf the winner of the above race as compared to its previous run in Race No.80 of the Mysore Summer Races 2022, i.e., The Tapatthi Plate – Div I (About) 1400 Metres, for horses rated 20 to 45 run on Eleventh Day, Wednesday, 27<sup>th</sup> July, 2022, when ridden by Jockey B Harish, it ran unplaced.**

Routine Sample was taken for analysis from the winner ch m BEAT THE ODDS.

**4<sup>th</sup> Race: 94. The Jayachamaraja Wadiyar Golf Club Trophy (About) 1200 Metres. For Maiden Indian Horses 3 years old only (9 Runners):**

Permission was granted to Trainer Mr. Monnappa C D to **withdraw** MYSTIC DIVINE (Vivek G) on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. Eshwer M to **withdraw** ELLE VA (B Harih) on veterinary grounds as it fell over in the saddling enclosure and was found to be trotting lame on hind quarters. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

MEADOW FLOWER (Angad) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Girinath C was informed that he must not accept with it again until its behavior improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the Race Track.

WHITE LIES (Kiran Naidu) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Pratap Kamath M was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

PININFARINA (G Rohith) jumped awkwardly outwards, at the Start.

Jockey Hindu Singh, the rider of MAYBURY was severely reprimanded for coming in sharply and cutting across the field before passing the **Red Marker Post**.

Jockey Nazerul Alam, the rider of DESERT ROMANCE was fined **Rs.2,000/-** for shifting out and causing interference to ELEVADO (Sarvan Kumar) on his outside approaching the 350 Metres.

Jockey Sarvan Kumar, the rider of ELEVADO reported that his mount was hanging in throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Johnson S M was informed to take appropriate corrective measures before accepting with it again.

**5<sup>th</sup> Race: 95. The Ursu Gymkhana Club Trophy (About) 1400 Metres. Horses rated 40 to 65 (15 Runners):**

Permission was granted to Trainer Mr. Md. Sajid Qureshi, to substitute Jockey G Rohith to ride GOOD EARTH, in place of Jockey Sameer Qureshi, the declared rider.

Jockey B Harish, the rider of POWER OF THEA was fined **Rs.2,000/-** for travelling wide throughout the race for no apparent reason.

Jockey Shreyas Singh, the rider of D THIRTEEN TWELVE, reported that he did not get a clear run, between the 450 Metres and the 350 Metres due to closing of the gap along the railings and as such, he had to pull out his mount from the railings and ride out his mount, due to which he lost some ground. His explanation was noted. Jockey Shreyas Singh also reported that thereafter, his mount was "hanging in". The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Monnappa C D was informed to take appropriate corrective measures before accepting with it again.

**6<sup>th</sup> Race: 96. The Kanteerava Narasimharaja Sports Club Trophy – Div- I (About) 1100 Metres. Horses rated 20 to 45 (12 Runners):**

VIJAYA SARATHI (Koshi Kumar) did not raise a fluent gallop soon after jumping out of the Starting Gates and thereafter, ran detached from the field, till about rounding the final bend. In view of its behaviour, Trainer Mr. Vikram Appachu was informed that he must not accept with it again until its behavior improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the Race Track.

Jockey Angad, the rider of SPARKLES, was reprimanded for not keeping a proper course, throughout the Race.

Jockey Hasib Alam, the rider of COUNTRY'S FLASH reported that he accidentally lost his whip passing the 400 Metres.

**An enquiry is being held into the vastly improved performance of FURIOUS FUN trained by Mr. Aditya K and ridden by Jockey Salman Khan the winner of the above race as compared to its previous run in Race No.74 of the Mysore Summer Races 2022, i.e., The Manasarovara Plate (About) 1400 Metres, for horses rated 40 to 65 run on Tenth Day, Wednesday, 20<sup>th</sup> July, 2022, when ridden by Jockey R Shiva Kumar it ran unplaced.**

Routine Sample was taken for analysis from the winner ch f FURIOUS FUN.

**7<sup>th</sup> Race: 97. The Equine Veterinarians Trophy (About) 1600 Metres. Horses rated 60 to 85 (10 Runners):**

NOTORIETY (Angad) was extremely fractious, dislodged the rider on its way to the starting gates and bolted clockwise and round the course. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's orders.

**8<sup>th</sup> Race: 98. The Hemavathi Million 2022 (About) 2000 Metres. For Indian Horses 4 years old and over (5 Runners):**

Jockey Yash Narredu, the rider of EMELDA reported that he accidentally lost his whip passing the 400 Metres.

Jockey Hindu Singh, the rider of TRUST BOND was reprimanded for slowing down the pace between the 1700 Metres and the 1500 Metres, for no apparent reason.

Jockey Ramandeep S Bal, the rider of HAVELOCK CRUISE reported that his mount was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However,

Trainer Surender G T was informed to take appropriate corrective measures before accepting with it again.

**9<sup>th</sup> Race: 99. The Mysore Race Club Million 2022 (About) 1600 Metres. For Indian 3 Years old Horses (Foaled in 2019) (8 Runners):**

As Jockey Angad the declared rider of GREAT HOPE was certified medically unfit to ride after his fall in the 7<sup>th</sup> Race, permission was granted to Trainer Mr. Monnappa C D to substitute Jockey J H Arul to ride GREAT HOPE in place of the declared rider.

Jockey Suraj Narredu, the rider of ASHWA YUDHVIR was fined **Rs.2,000/-** for shifting in and causing interference to ACHOOK (Hindu Singh) on his inside passing the 1500 Metres.

Routine Sample was taken for analysis from the winner b c STILL I RISE.

**10<sup>th</sup> Race: 100. The Kanteerava Narasimharaja Sports Club Trophy – Div- II (About) 1100 Metres. Horses rated 20 to 45 (11 Runners):**

As Jockey R Shiva Kumar, the declared rider of VIJAYA SURABHI was certified medically unfit after his ride in the 2<sup>nd</sup> race and as no suitable substitute rider was available, permission was granted to Trainer Mr. Tejaswi P C to **withdraw** VIJAYA SURABHI from the above race.

Jockey Arul J H replaced the indisposed Jockey Angad on KALAHARI GOLD.

LUCKY SUN (H Zeeshan) took a fly jump at the Start.

Jockey Arul J H, the rider of KALAHARI GOLD was fined **Rs.2,000/-** for shifting in and causing interference to THINK N FLY (Saqlain S) on his inside approaching 900 Metres.

LUCKY SUN (H Zeeshan) had to be checked by its rider to avoid striking the front runner thereby shifting out and taking out the horse on its outside viz. INFINITE GRACE (R Manish) and D FIRE (Hasib Alam), passing the 900 Metres.

Jockey Nazerul Alam, the rider of GABRIELLA was fined **Rs.2,000/-** for shifting in and causing interference to EWANDOR (Koshi Kumar) on his inside approaching 600 Metres.

VIJAYA SARATHI (Koshi Kumar) – Swerved to left after jump out and lost few lengths.

#### **7<sup>th</sup> Race: 97. The Equine Veterinarians Trophy (About) 1600 Metres.**

NOTORIETY (Angad) – Was permitted to be withdrawn before coming under Starter's Order as the mare bolted on its way to Starting Gates dislodging the rider.

### **SIXTH DAY, WEDNESDAY, 22<sup>nd</sup> JUNE, 2022**

#### **RACE NO. 40: THE KODLIPET PLATE (ABOUT) 1400 METRES. HORSES RATED 40 TO 65, 5 YEARS OLD AND OVER:**

The Stipendiary Stewards reported Jockey Sameer Qureshi to the Stewards, vide Charge Sheet No. 288, dated 29<sup>th</sup> July, 2022 for breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing [Unsatisfactory Riding], on his mount LEAP OF FAITH, in the above Race; The Stewards, at their meeting held on Wednesday, 3<sup>rd</sup> August, 2022, examined the rider of the horse, Jockey Sameer Qureshi and Trainer Md. Sajid Qureshi; After repeatedly watching the CCTV footage of the above Race and after due deliberations, the Stewards decided as follows;

- a) To suspend the Jockey's License granted to Jockey Sameer Qureshi, **from 25-08-2022 to 15-09-2022** [both days inclusive] for unsatisfactory Riding [breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing] on his mount, LEAP OF FAITH, in the above Race [He is permitted to ride work and was informed of his right to appeal]; and
- b) To fine Trainer Mr. Md. Sajid Qureshi a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)**, for the unsatisfactory running of his charge, LEAP OF FAITH (Sameer Qureshi), in the above Race and for the unsatisfactory explanation tendered by him, during the above enquiry. Trainer Mr. Md. Sajid Qureshi was informed of his right to appeal.

The Stipendiary Stewards reported Jockey Ahsan Qureshi to the Stewards, vide Charge Sheet No. 289, dated 29<sup>th</sup> July, 2022 for breach of Rule No.101(ii) of the Mysore Race Club Limited Rules of Racing [negligence in the discharge of his duties as a licensed professional], the declared rider of LEAP OF FAITH, in the above Race, in that he failed to fulfill his riding engagement for the day and for not producing the requisite medical certificate to the Stipendiary Stewards despite having been told to do so, by them; The Stewards, at their meeting held on Wednesday, 3<sup>rd</sup> August, 2022, examined Jockey Ahsan Qureshi; After due deliberations, the Stewards

decided to **a)** fine Jockey Ahsan Qureshi **Rs.2,000/-** for not honouring his acceptance to ride LEAP OF FAITH, in the above Race (negligence in the discharge of his duties as a licensed professional); and **b)** To caution him not to repeat this mistake in future, failing which appropriate action shall be initiated against him. Jockey Ashan Qureshi was informed of his right to appeal.

HORSES RATED 20 TO 45:**

The Stipendiary Stewards reported Trainer Mr. Ashwin S Rao to the Stewards, vide Charge Sheet No. 290, dated 29<sup>th</sup> July, 2022 for breach of Rule No.114 (b)(i) of the Mysore Race Club Limited Rules of Racing [negligence in the discharge of his duties as a licensed professional], pertaining to the faulty saddling of his charge, DARK SECRET (G Vivek), in the above Race. ; The Stewards, at their meeting held on Wednesday, 3<sup>rd</sup> August, 2022, examined Mr. Ashwin S Rao; After due deliberations, the Stewards decided to **a)** fine Trainer, Mr. Ashwin S Rao a sum of **Rs.20,000/-** (Rupees Twenty Thousand only), for the negligence in the discharge of his duties as a licensed professional, pertaining to the faulty saddling of his charge, DARK SECRET (G Vivek), in the above Race (breach of Rule No. 114 (b) (i) of the My.R.C. Ltd., Rules of Racing); and **b)** To caution him that a repetition of this mistake in future, would be dealt with appropriately.
