1st Race: 1. The Lavasa Plate - Div. II (About) 1400 metres. Horses rated 00 to 25 (14 Runners):

Permission was granted to Trainer Mr. Rakesh to <u>withdraw</u> LADY WANNABE on veterinary grounds as it was lame on left fore due to tendon inflammation. He was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with it again.

AIRVELOCITY (Rajesh K) jumped awkwardly outwards, swerved towards the outer sand track, dislodged the rider and thereafter, ran rider-less on the outer sand track. In view of its behaviour, Trainer Mr. Md. Sajid Qureshi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

MEGA SUCCESS (Vivek) stumbled while jumping out of the starting gates.

Jockey A Ayaz Khan, the rider of JAGUAR, reported that he accidentally dropped his whip, passing the 300 Metres.

Jockey Abhishek Mhatre, the rider of ARMAMENT, was reprimanded for shifting 'in' and inconveniencing GABRIELLA (M Rajesh Kumar) on his inside, passing the 250 Metres.

It was observed that MEGA SUCCESS (Vivek) was not galloping fluently throughout the Race. The horse was impounded for veterinary examination, but, no abnormality was reported.

Jockey V R Jagdeesh, the rider of RUSSIAN ROMANCE, reported that his mount was hanging 'in' throughout the race. The horse was impounded for veterinary examination and it was reported that the examination of the mouth of the horse

revealed sharp molars. Trainer Mr. Rajendra Singh M was fined **Rs.3,000/-** for his negligence **[First Infringement]**.

Jockey Vivek G, the rider of COUNTRY MAGIC, reported that his mount was hanging 'out' after entering the straight. The horse was impounded for veterinary examination, but, no abnormality was reported. However, Trainer Mr. Feroz M Khan was informed to take appropriate corrective measures before accepting with it again.

It was reported after the Race that UNITY (M Naveen) burst its blood vessels. Trainer Mr. Santosh Rao S was informed that he must produce a <u>Fitness</u> <u>Certificate</u> from the Club's Veterinary Officer before accepting with it again.

NATURAL FLY (Inayat) sustained linear superficial injury on his right hind tendon.

Routine Sample was taken for analysis from the winner, ch g COUNTRY MAGIC.

2nd Race: 2. The B K Krishnadevaraj Urs Memorial Trophy (About) 1200 metres. Horses rated 40 to 65, 5 years old and over (12 Runners):

LUCKY POINT (Brahmmesh S) jumped awkwardly inwards thereby inconveniencing SPIRITUAL FORCE (Arshad Alam), on its inside, at the start.

Jockey Shreyas Singh, the rider of CHISOX, was reprimanded for shifting 'in' and inconveniencing horses on his inside, viz., SUPER RUFFIAN (S Antony Raj), INFINITEPOSIBILITY (M Rajesh Kumar) and GOLD CREST (Inayat) respectively, in the last 100 Metres of the Race.

AIR DISPLAY (P P Dhebe) was hanging `out' after entering in the straight. The horse was impounded for veterinary examination and it was reported that the examination of the mouth of the horse revealed sharp molars. Trainer Mr. Inayathulla S was fined **Rs.3,000/-** for his negligence **[first infringement].**

It was reported after the Race that COASTAL CRUISE (Koshi Kumar) burst its blood vessels. Trainer Mr. Surender G T was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the Race that CRIMSON FIRE (Likith Appu K G) splayed its left hind shoe during the race.

3rd Race: 3. The Star of Mysore Trophy (About) 1400 metres. Horses rated 40 to 65, confined to Mysore based horses (14 Runners):

Permission was granted to Trainer Bobby M to <u>withdraw</u> GILDED BUTTERFLY on veterinary grounds as it was lame on right fore due to shoulder sprain. He was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with it again.

TRUST BOND (Md. Sameer) planted and lost many lengths at the Start. In view of its behaviour, Trainer Mr. Dinesh Pujar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

TOM CRUISER (Arshad Alam) jumped awkwardly inwards, thereby, inconveniencing horses on its inside, viz., CLETUS (T Pavan) and SIR CALCULUS (Y S Srinath), soon after the start.

Jockey P P Dhebe, the rider of LAND OF GOLD, was reprimanded for shifting 'in' and inconveniencing CLETUS (T Pavan) on his inside, which, in turn, went onto BRAXTON (Hasib Alam), on its inside, passing the 500 Metres.

It was observed that GINTOKI (Shreyas Singh) was hanging 'in' very badly in the straight. The horse was impounded for veterinary examination, but due to its extremely fractious behaviour, it could not be examined. However, Trainer Mr. C D Monnappa was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that BRAXTON (Hasib Alam) pulled up lame on left fore. Trainer Mr. Md. Sajid Qureshi was informed that he must produce a <u>Fitness</u> <u>Certificate</u> from the Club's Veterinary Officer before accepting with it again.

CLETUS (T Pavan) sustained small injury on the left fore fetlock and also splayed its left fore shoe, during the race.

4th Race: 4. The H. H. Sri Jayachamaraja Wadiyar Memorial Trophy (About) 1200 metres. Horses rated 80 and above (12 Runners):

Jockey Saqlain S, the rider of GALACTICAL, was reprimanded for shifting 'in' and inconveniencing POLISHED GIRL (Vinod Shinde), on his inside, which went onto VIJAYA FALCON (Vivek G) on its inside, approaching the 1100 Metres.

Jockey Vivek G, the rider of VIJAYA FALCON, was fined **Rs.1,000/-** for shifting `out' and causing interference to CAVAROZZI (P P Dhebe) on his outside, between the 300 Metres and the 200 Metres.

It was reported after the Race that COLD PURSUIT (Shamaz Shareef) burst its blood vessels. Trainer Mr. Bobby M was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Surprise Sample was taken for analysis from ch m ASHTAR.

5th Race: 5. The Srikantadatta Narasimharaajawadiyar Memorial Multi Million 2023 (About) 1400 Metres. For 3 year old Indian horses (Foaled in 2020) (10 Runners):

TOUCH OF GREY (Yash Narredu) slightly stumbled soon after jumping out of the Starting Gates. The horse was impounded for veterinary examination, but no abnormality was reported.

Jockey Hindu Singh, the rider of NEZIAH, was reprimanded for shifting 'in' and inconveniencing PRANA (P Trevor) on his inside, passing the 1000 and again passing the 800 Metres.

Jockey P Trevor, the rider of PRANA, was fined **Rs.2,000/-** for coming `in' and causing interference to MORISET (S Antony Raj) on his inside, passing 400 Metres.

Jockey P Trevor, the rider of PRANA, was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the Race **[First Infringement].**

GALAHAD (Akshay Kumar) sustained small injury on left hind outer coronet.

Routine Sample was taken for analysis from the winner, b c PRANA.

6th Race: 6. The Lavasa Plate - Div. I (About) 1400 metres. Horses rated 00 to 25 (15 Runners):

LEAD SINGER (A R Pradeep) jumped awkwardly inwards thereby inconveniencing RUMOUR LADY (T Pavan) at the Start.

SPARKLING NIGHT (Inayat) jumped out awkwardly, at the Start.

FEARLESS JOEY (P Tejeshwer) jumped out awkwardly, at the Start.

Jockey A R Pradeep, the rider of LEAD SINGER, was reprimanded for suddenly shifting course, between the 400 Metres and the 300 Metres.

Routine Sample was taken for analysis from the winner, ch g FEARLESS JOEY.

7th Race: 7. The Varada Plate (About) 1100 metres. Horses rated 20 to 45, confined to Mysore based horses (12 Runners):

EVERLY (P Kiran Rai) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Girinath C was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey P P Dhebe, the rider of EMPYRIAN reported that his mount was making a roaring noise throughout the race. The horse was impounded for veterinary examination, but no abnormality was reported.

Routine Sample was taken for analysis from the winner, gr m INEFFABLE.

The Board of Appeal, at its meeting held on Tuesday, 8 th August,, 2023 considered the Appeal, dated 10 th June, 2023 filed by Trainer Mr M. Pratap Kamath against the decision of the Stewards Stewards to suspend his license from 17-06-2023 to 16-09-2023 (both days inclusive) for breaching Rule Nos. 114(b) (i)(ii), 202(vi) (vii) (xii) and (xvi) of the Rules of the Racing of MyRC Ltd, Clause No. 3 of the Calendar Notification of the Racing Calendar, under the heading "TRAINERS LICENSES" and Rule Nos 2,6,23 (a) (b) and (c) of the Medication Rules of the Racing Calendar of Mysore Race Club Ltd., under the heading "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL" and to fine a sum of Rs 1,00,000. The relevant Rules of Racing are reproduced hereunder;

RULES OF RACING

RULE NO. 114:-

- (b) In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-
- (i) If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing.
- (ii)If he shall misconduct himself in any way.

XXXXXXXX

RULE NO. 202:-

The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(vi):- Any Owner, Nominator, Trainer, Jockey, Lessee, Apprentice, Stable Hand, Bookmaker or Bookmaker's Assistant or any person, who either wilfully refuses to attend and give evidence at an enquiry when requested by the Stewards/

Stewards of the Club/ Stipendiary Stewards to do so, or knowingly gives evidence, which is false or misleading in any particular.

- (vii):- Any person, who gives at any Enquiry or Appeal any evidence, which, in their opinion, is false or misleading in any manner.
- (xii) Any person guilty of improper or insulting behaviour at any time towards the Stewards or Stewards of the Club or any Official in relation to their or his duties.
- (xvi):- any person, who infringes any of the provisions of a licence issued to him or any regulations issued in the Racing Calendar be liable to such other punishment as the Stewards or the Stewards of the Club think fit to impose.

CALENDAR NOTIFICATION OF THE RACING CALENDAR UNDER THE HEADING TRAINERS LICENSES:

CLAUSE 3:- To take full responsibility of the horses in his charge and to be responsible to the Stewards of the Club for any irregularities or breaches in the Rules, Regulations or Notices in connection with any of the horses in his charge.

MEDICATION RULES:

UNDER THE HEADING, "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"

Rule No. 2:-

Any person who takes part in any matter or race meeting coming within the Rules of Racing agrees to be bound by and comply with them.

Rule No.6:-

Only Veterinarians, duly approved by the Stewards of the Club are permitted to administer medicines. Except for such Veterinarians, it is forbidden for any other person to administer any medication or to bring a syringe or a hypodermic needle where racehorses are sheltered.

Xxxxxxxxx

Rule No. 23:

The Trainer shall always be responsible and accountable at all times for: -

- (a) The management, administration, supervision, security and control of horses and of stable employees under his/her charge.
- (b) The feeding, feed supplements, treatment, stable routine, management, protection and security of the horses in his/her stable.
- (c) For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his/her care.

In this connection, the Board considered the following:

- **a]** The Minutes of the Meeting of the Stewards of the Mysore Race Club Limited, held on 5th June, 2023.
- **b]** The written Grounds of Appeal, dated 5^{th} August, 2023 submitted by Trainer Mr. M.Pratap Kamath.
- **c]** The oral submissions made by Riding boy Mr Hemath Omraj Chandaragiri. The Board further examined Trainer M.Pratap Kamath.

After consideration of all the above and the oral submission made by Trainer M.Pratap Kamath, and Riding Boy Mr Hemath Omraj Chandaragiri, and after detailed deliberations, the Board of Appeal decided as follows:

a] To Reject the appeal so as to.

b] To uphold the decision of Stewards of Mysore Race Club Limited and revise the period of suspension as to suspend the license granted to Mr M.Pratap Kamath from 01-09-2023 to 30-11-2023 (both days inclusive) for breaching Rule Nos. 114(b) (i)(ii), 202(vi) (vii) (xii) and (xvi) of the Rules of the Racing of My.R.C. Ltd, Clause 3 of the Calendar Notification under the heading "TRAINERS LICENSES" and Rule Nos 2, 6 and 23 (a) (b) and (c) of the Medication Rules of the Racing Calendar of Mysore Race Club Ltd., under the heading "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL" and to fine Trainer Mr. Pratap Kamath M, a sum of Rs 1,00,000 [Rupees One Lakh only], for the above offence.

c] To forfeit the deposit of Rs.10,000/- paid by Trainer M.Pratap Kamath

The Board authorised the Secretary of the Board of Appeal to issue a detailed order to Trainer M.Pratap Kamath

RACE NO. 24: THE RANIBENNUR PLATE (ABOUT) 1400 METRES. FOR HORSES RATED 20-45:

The Board of Appeal, at its meeting held on Tuesday,8th August, 2023 considered the Appeal, dated 19th June, 2023, filed by Jockey J.H.Arul against the decision of the Stewards to suspend the Jockey's Licence granted to Jockey J.H Arul for the period from **26-6-2023 to 31-03-2024** (both days inclusive) for breach of Rule Nos. 159 (a) and (b) of the Mysore Race Club Rules of Racing [for not permitting his mount to run on its merits] on his mount MILOS, in the above race. The relevant Rules of Racing are reproduced below;

Rule No. 159 (a):-

Every horse shall run on its merits.

Rule No. 159 (b):-

The Rider of every horse shall take all reasonable and Permissible measures throughout the race to ensure that, his horse is given full Opportunity to win or to obtain the best possible place in the field.

In this connection, the Board considered the following:

- **a]** The Minutes of the Meeting of the Stewards of the Mysore Race Club Limited, held on 16^{th} June, 2023
- **b]** The written Grounds of Appeal, dated 3rd August, 2023 submitted by Jockey J.H.Arul.
- **c]** The oral submissions made by Mr Y.S. Srinath spokesperson for Jockey J.H.Arul.

The Board further examined Mr M.Eshwer the Trainer of the horse MILOS.

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a] To partially allow the appeal so as to.

b] To modify the order of the Stewards as and charge him for Unsatisfactory riding, breaching Rule No. 161(ii) of MyRC Ltd Rules of Racing. on his mount MILOS and suspend his Jockey's license from 01-09-2023 to 29-09-2023 (both days inclusive) (permitted to ride work). The Relevant Rules of Racing is reproduced here under:

RULE NO. 161:-

Any Rider shall be punished either by fine, suspension from riding or by disqualification for such period as the Stewards may think fit if, in the opinion of the Stewards:-

ii) The rider of any horse who rides in an incompetent, unsatisfactory, erratic, indifferent or an injudicious manner.

c] To forfeit the deposit of Rs.10,000/- paid by Jockey J.H.Arul.

The Board authorised the Secretary of the Board of Appeal to issue a detailed order to Jockey J.H.Arul

The Stipendiary Stewards questioned Trainer Mr. Sharat Kumar, pertaining to reversal of form of his charge SMILE AROUND (S John), the winner of the above Race, as compared to its previous run in Race No. 41 of the Mysore Summer Races 2023, i.e., The Golden Fantasy Plate (About) 1200 Metres, for horses rated 40 to 65, 5 years old and over, run on Sixth Day, Friday, 30th June, 2023, when ridden by Jockey M Naveen, it ran unplaced. After due enquiry and after

repeatedly viewing the CCTV replay of the above Race and not being satisfied with the explanation tendered by Trainer Mr. Sharat Kumar, the Stipendiary Stewards decided as follows;

- **a)** To fine Trainer Mr. Sharat Kumar a sum of **Rs.10,000/- (Rupees Ten Thousand only)**, for the reversal of form of his charge SMILE AROUND, in the above Race.
- **b)** To caution Trainer Mr. Sharat Kumar that a repetition of a similar manner of running of his charges in future would entail him being reported to the Stewards for appropriate action.

- **b)** To caution Jockey J Paswan to be more judicious while riding his mounts in future and that a repetition of a similar manner of riding would entail him being reported to the Stewards for appropriate action.
