1st Race: 50. The Bird Sanctuary Plate – Div. II (About) 1100 Metres. Horses rated 40 to 65 (8 Runners):

Jockey M J Gautam Raj Urs, the rider of PROUD reported that his mount accidentally brushed the gates while jumping out thereby he lost his left stirrup momentarily which he regained within a few strides.

It was observed that FLYING FALCON (Rajesh K) drifted out after passing the final 300 Metres and raced on the centre of the grass track. Trainer Mr. Bipin V Salvi was informed to take appropriate corrective measures before accepting with it again.

Jockey Vinod Shinde, the rider of EAGLE BUFF was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race **(1st Infraction)**.

2nd Race: 51. The Nelamangala Plate(About) 1400 Metres. Horses rated 00 to 25 (13 Runners):

EMPYRIAN (Sham Kumar) jumped out awkwardly and lost few lengths at the start. In view of its behaviour, Trainer Mr. G T Surenderwas informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

CODE OF HONOUR (M Prabhakaran) was slowly away, lost many lengths at the start and thereafter, ran detached from the field till rounding the final bend. In view of its behaviour, Trainer Mr. M Bobby was informed to ensure better performance of his charge in future and that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

GENTLEMAN'S WORD (Ajeetkumar) drifted out alarmingly after rounding the final bend and finished the race on the outer sand track after passing the final 100 Metres. In view of its behaviour, Trainer Mr. Santosh S Rao was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

THE ANGEL POWER (S K Paswan) drifted out after rounding the final bend and raced on the outer portion of the grass track thereafter. In view of its behaviour, Trainer Mr. Santosh S Rao was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

An enquiry is being held into the running and riding of FREE SPIRITED, trained by Mr. C D Monnappa and ridden by Jockey Faiz in the above race.

CODE OF HONOUR (M Prabhakaran) was impounded for veterinary examination but no abnormality was reported.

GENTLEMAN'S WORD (Ajeet Kumar) was impounded for veterinary examination but no abnormality was reported.

Surprise sample was taken for analysis from b g KNOTTY METHODS.

Routine sample was taken for analysis from the winner b g PETTE'S CHOICE.

3rd Race: 52. The Bird Sanctuary Plate – Div. I (About) 1100 Metres. Horses rated 40 to 65 (8 Runners):

NEVADA GOLD (Ankit Pal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vinesh V Naik was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Angad, the rider of KENSINGTON COURT reported that his mount was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. S Ramsh was informed to take appropriate corrective measures before accepting with it again.

An enquiry is being held into the running and riding of KENSINGTON COURT, trained by Mr. S Ramesh and ridden by Jockey Angad in the above race.

4th Race: 53. The Nandidurga Plate (About) 1100 Metres. Horses rated 20 to 45, 6 years old and over, at the time of starting (7 Runners):

Permission was granted to Trainer Mr. Mansoor Khan to **withdraw** NATURAL WARRIOR (Ankit Pal) from the above Race on veterinary grounds, as it was found to be trotting lame on left hind and bruises in left hock. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. G T Surender to **withdraw** TRUMP BABY (A Ayaz Khan) from the above Race on veterinary grounds, as it was found to be suffering from fever. He was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

As Jockey S Imran, the declared rider of ARMAMENT was certified medically unfit to ride, permission was granted to Trainer Mr. Ranjeet Shinde to substitute Jockey S K Paswan to ride ARMAMENT in place of the declared rider.

ELEVADO (Faiz) reared up as the gates opened and lost many lengths at the start. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

On a written complaint by Trainer Mr. Bipin V Salvi an enquiry is being held into the manner of riding of Jockey Fiaz, on his mount ELEVADO in the above race.

An enquiry is being held into the running and riding of ARMAMENT, trained by Mr. Ranjeet Shinde and ridden by Jockey S K Paswan in the above race.

An enquiry is being held into the reversal of form and the resultant improved performance of WORDLY WISE, trained by Mr. G T Surender and ridden by Jockey J Paswan, the winner of the above race as compared to its previous run in Race No. 28, i.e The Crown Treasure Plate (About) 1400 Metres, for horses rated 40 to 65, 5 years old and over run on Fourth Day, Wednesday, 4th December, 2024 when ridden by Jockey S Imran it ran unplaced.

Routine sample was taken for analysis from the winner b g WORDLY WISE.

5th Race: 54. The Chamundi Million (About) 2000 Metres. For Indian horses 4 years old and over, at the time of starting (8 Runners):

Jockey Koshi Kumar, the rider of CONFIDENT GAME was reprimanded for shifting out and inconveniencing SEA THE SUN (Saqlain S) on his outside in the final 25 Metres of the race.

It was reported after the race that PRINCE COROPRATE (P Ajeet Kumar) burst its blood vessels during the race. Trainer Mr. Rakesh was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

6th Race: 55. The Rajendravilas Plate (About) 1800 Metres. Horses rated 60 and above (5 Runners):

Jockey Y S Srinath, the rider of FERRETTI reported that his saddle shifted back after entering the straight. After due examination of the saddle after the race which was found to be in serviceable condition, Trainer Mr. M Eshwer was fined **Rs.3,000/-** for faulty saddling.

It was observed that Jockey L Alex Rozario, the rider of AABUSHAN momentarily lost his reins in the final 100 Metres of the race which he regained in a few strides.

7th Race: 56. The Taj Mahal Plate (About) 1600 Metres. Horses rated 20 to 45 (11 Runners):

Jockey S K Paswan replaced the indisposed Jockey S Imran on RUN HAPPY RUN.

Trainer Mr. Bipin V Salvi was fined **Rs.2,000/-** for sporting **Red Hood** on his charge D LORD in the above race for which prior permission had not been obtained. Subsequently it was removed from the horse before it left the paddock.

POLAR WIND (Faiz) took a fly jump, at the Start.

RUN HAPPY RUN (S K Paswan) planted and lost many lengths at the start and thereafter, ran detached from the field. In view of its behaviour, Trainer Mr. Ruben P was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Ajeet Kumar, the rider of TIGERKING was fined **Rs.1,000/-** for shifting out and causing interference to WHAT IS THIS (Angad) on his outside passing 400 Metres.

Jockey Abhishek Mhatre, the rider of D LORD was fined **Rs.2,000/-** for not maintaining a straight course in the final 200 Meters of the race.

Jockey Vinod Shinde, the rider of COYOTE GIRL accidentally lost his whip in the final 150 Metres of the race.

An enquiry is being held into the reversal of form and the resultant improved performance of WHAT IS THIS, trained by Mr. S Ramesh and ridden by Jockey Angad, the winner of the above race as compared to its previous run in Race No. 3, i.e The B R Hills Plate – Div II (About) 1200 Metres, for horses rated 20 to 45 run on First Day, Wednesday, 13th November 2024 when ridden by Jockey M Rajesh Kumar it ran unplaced.

RACE NO. 44:THE SKYLINE PLATE (ABOUT) 1400 METRES. HORSES RATED 20 TO 45, 5 YEARS OLD AND OVER:

The Stipendiary Stewards reported Jockey Md. Imran Ashraf to the Stewards, vide Charge Sheet No. 341, dated 31stDecember, 2024 for breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing [Unsatisfactory Riding], on his mount SARVOTTAM, in the above Race; The Stewards, at their meeting held after the last race on Friday, 3rd January, 2025, examined Jockey Md. Imran Ashraf, the Trainer Mr. Rakesh and Trainer Mr. Vishal Yadav (deputizing for Trainer Mr. Rakesh on 25th December, 2024); And as Jockey Md. Imran Ashraf has admitted to the breach of the Rule, the Stewards decided as follows;

- a) To suspend the Jockey's License granted to Jockey MdImran Ashraf for Two Race days on **15-1-2025 and 22-1-2025**for Unsatisfactory Riding [breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing] on his mount, SARVOTTAM,, in the above Race [He is permitted to ride work and was informed of his right to appeal]; and
- b) To caution him that and that a repetition of a similar manner of riding on his mounts in future, would be dealt with appropriately by them.

RACE NO. 47:THE P M CHANNABASAVANNA MEMORIAL TROPHY (ABOUT) 1200 METRES. HORSES RATED 60 AND ABOVE:

The Stipendiary Stewards reported Jockey Ankit Pal to the Stewards, vide Charge Sheet No. 342, dated 31stDecember, 2024 for breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing [Unsatisfactory Riding], on his mount SILVER SPRING, in the above Race; The Stewards, at their meeting held after the last race on Friday, 3rd January, 2025 examined the rider of the horse Jockey Ankit Pal and Trainer Mr. Vinesh V Naik; After repeatedly watching the CCTV footage of the above Race and after due deliberations, the Stewards decided as follows:

- a) To suspend the Jockey's License granted to Jockey Ankit Pal for three Race days on **6-2-2025, 12-2-2025 and 18-2-2025**for Unsatisfactory Riding [breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing] on his mount SILVER SPRING, in the above Race [He is permitted to ride work and was informed of his right to appeal]; and

- b) To caution him that and that a repetition of a similar manner of riding on his mounts in future, would be dealt with appropriately by them.

RACE NO. 44:THE SKYLINE PLATE (ABOUT) 1400 METRES. HORSES RATED 20 TO 45, 5 YEARS OLD AND OVER:

The Stipendiary Stewards questioned Trainer Mr. Vinesh V Naik for the reversal of form and the resultant improved performance of his charge NATURAL TORNADO ridden by Jockey Ankit Pal in the above race as compared to its previous run in Race No. 23 i.e The Lalbagh Plate (About) 1100 Metres, for horses rated 20 to 45, 5 years old and over run on Fourth Day, Wednesday, 4th December, 2024 when ridden by the same Jockey it ran unplaced. The Trainer stated as follows: **a)** That the races were delayed by 40 mins due to a technical glitch that day and **b)** That his horse suffered an eye injury due to kick back and as such his horse did not perform up to his expectations. His explanations were noted.

RACE NO. 45:THE PANAJI PLATE (ABOUT) 1100 METRES. HORSES RATED 00 AND 25:

The Stipendiary Stewards questioned Trainer Mr. Bipin V Salvi for the reversal of form and the resultant improved performance of his charge ELEVADO ridden by Jockey Abhishek Mhatre in the above race as compared to its previous run in Race No. 3, i.e The B R Hills Plate – Div II (About) 1200 Metres, for horses rated 20 to 45 run on First Day, Wednesday, 13th November, 2024 when ridden by Jockey M Chandrashekar it ran unplaced. Not being satisfied with the explanations tendered by Trainer Mr. Bipin V Salvi, he was fined **Rs.5,000/-**. He was cautioned to be more judicious in the running of his charges and that a similar manner of running of his charges in future would entail him being reported to the Stewards for appropriate action.

ORDER OF THE BOARD OF APPEAL

ELEVENTH DAY, WEDNESDAY, 9TH OCTOBER 2024

RACE NO. 66: THE GOOL & SOLI POONAWALLA MEMORIAL TROPHY (ABOUT) 1600 METERS. FOR HORSES RATED 40 to 65:

The Board of Appeal, at its meeting held on Monday, 30th December, 2024 and on Friday, 3rd January, 2025, considered the Appeal dated 14th December, 2024, filed by Trainer Mr. Vikram Appachu, against the decision of the Stewards, which had declared Trainer Mr. Vikram Appachu a disqualified person, for the period from **15-12-2024 to 14-12-2025 (both days inclusive)** for contravention of Rule No. 202 (i) of the My.R.C. Ltd Rules of Racing [Improper Practice and Dishonourable Action], read with Rule No. 114(b)(i) [negligence in the discharge of his duties as a licensed Trainer] and Rule No. 202(xvi) of the My.R.C. Ltd Rules of Racing and read with Clause 3 of the Calendar Notification under the heading Trainers Licenses, pertaining to his charge JEWEL THIEF [as mentioned in Charge Sheet No. 335], in the above race. The Board examined Trainer Mr. Vikram Appachu and took on record the submissions made by him before the Board on Monday, 30th December 2024;

The Board considered the following:

- (a) Appeal dated 14th December 2024 from Trainer Vikram Appachu;
- (b) Letter dated 19th December, 2024, requesting for grant of Stay on the punishment meted out by the Stewards;
- (c) Order of the Board of Appeal, dated 20th December;
- (d) Charge Sheet No.335 dated 5th December 2024 issued to Trainer Vikram Appachu together with the Annexure thereto;
- (e) Minutes of the Meeting of the Stewards of the Club held on 11th December 2025 in this regard;
- (f) The Club's letter no. Ref: Admn/1516/2024-25 dated 20th December 2024 and letter no. Ref: Admn/1530/2024-25 dated 23rd December 2024 addressed to Trainer Mr. Vikram Appachu;
- (g) Grounds of Appeal submitted by Trainer Mr. Vikram Appachu vide his letter dated 22nd December 2024;
- (h) Email dated 29th December, 2024, received from Mr. Vijeth Bhandari;
- (i) Past racing records and history of Trainer Mr. Vikram Appachu;
- (j) The submissions made by Trainer Mr. Vikram Appachu before the Board of Appeal, on Monday, 30th December, 2024;

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a] To uphold the decision of the Stewards taken on 11th December 2024 and accordingly reject the appeal made by Trainer Mr. Vikram Appachu against the Order of the Stewards disqualifying him.

Trainer Mr. Vikram Appachu's deposit of Rs.10,000/- plus GST towards the appeal stands forfeited;

b] Since the punishment meted out by the Stewards had been stayed by the Board of Appeal, until the final hearing and disposal of his appeal, the Board decided to revise the period of disqualification of Trainer Mr Vikram Appachu and shall now commence from 04-01-2025 to 03-01-2026 (both the days inclusive);

c] The Board decided to uphold the decision of the Stewards which ordered Trainer Mr. Vikram Appachu to take away the horses under his charge from the premises of the Mysore Race Club Ltd by 25th January 2025. However, taking into consideration the welfare of the horses which are under Trainer Mr Vikram Appachu's charge, he may shift the horses to any "A" licensed Trainer under MyRC Rules of Racing from 4th January 2025, till the horses leave the MyRC premises, not later than 25th January 2025. Consequent to his disqualification, the horses under the charge of Trainer Mr Vikram Appachu, as on date, will not be permitted to race under the MyRC Ltd. Rules of Racing.

d] If he does not adhere to the condition contained in point (c) as above and if suitable action is initiated against him by the Stewards, then the My.R.C. Ltd., will not be held responsible in any way.

The relevant Rules of Racing are reproduced below;

Rule No. 202. The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any improper practice and dishonourable action in connection with racing anywhere;

Rule No. 114. (b); In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-

(i) If his conduct or negligence or neglect in the performance of his duties as a licenced professional has led or could have led to a breach of the Rules of Racing;

Rule No. 202 (xvi); Any person, who infringes any of the provisions of a licence

issued to him or any regulations issued in the Racing Calendar be liable to such other punishment as the Stewards or the Stewards of the Club think fit to impose.

Read with clause 3 of the Calendar Notification, under the heading, TRAINERS LICENSES, reading as under;

TRAINERS LICENCES

Trainers are notified that telegraphic applications for licences or renewal of licences will not be entertained. Applications for licences under Rule 113 must be made by letter and must be accompanied with a list of horses under the charge of the applicant with the names of the Owners together with the licence fee and clearance from the recognised Club or Club in the country in which the applicant last held a trainer's licence. In the event of a licence being granted to the applicant, he must undertake:

3. To take the full responsibility of the horses in his charge and to be responsible to the Stewards of the Club for any irregularities or breaches in the Rules, Regulations or Notices in connection with any of the horses in his charge.

MISBEHAVIOUR OF TRAINER, Mr. TEJASWI P C, TOWARDS THE CHAIRMAN AND THE OFFICIAL OF THE CLUB, ON 5TH DECEMBER, 2024, INSIDE THE CHAIRMAN'S CHAMBER, AT THE MYSORE RACE CLUB LTD.:

The Board of Appeal, at its meeting held on Monday, 30th December, 2024 and on Friday, 3rd January, 2025, considered the Appeal dated 13th December, 2024, filed by Mr. P C Tejaswi, against the decision of the Stewards, which had declared Mr. P C Tejaswi a disqualified person, for the period from **15-12-2024 to 14-12-2027** (both days inclusive) for contravention of Rule No. 202 (xii) of the MyRC Ltd Rules of Racing [behaving in an insulting and improper manner], read with Rule No. 202(i) of the MyRC Ltd Rules of Racing [Dishonourable Action] pertaining to his insulting and improper behaviour towards the Chairman and the Official concerned inside the Chairman's Chamber on 5th December 2024. The Board examined Mr. P C Tejaswi and took on record the submissions made by him on Monday, 30th December, 2024;

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a]To reject the appeal made by Mr. P C Tejaswi against the Order of the Stewards in disqualifying him.

Trainer Mr. P C Tejaswi's deposit of Rs.10,000/- plus GST towards the appeal stands forfeited;

b]To uphold the decision of the Stewards, who declared Mr. P C Tejaswi a disqualified person from 15-12-2024 to 14-12-2027(both days inclusive);

c] The Board of Appeal decided to uphold the decision of the Stewards which ordered Mr P C Tejaswi to take away the horses under his charge from the premises of the Mysore Race Club Ltd by 25th January 2025. However, taking into consideration the welfare of the horses which are under Mr P C Tejaswi's charge, he may shift the horses to any "A" licensed Trainer under MyRC Rules of Racing from 4th January 2025, till the horses leave the MyRC premises, not later than 25th January 2025. Consequent to his disqualification, the horses under the charge of Mr P C Tejaswi, as on date, will not be permitted to race under the MyRC Ltd Rules of Racing.

**RACE NO. 78: THE K THAMMANNA GOWDA MEMORIAL TROPHY (ABOUT) 1200 METERS.
FOR HORSES RATED 40 to 65, CONFINED TO MYSORE BASED HORSES:**

The Board of Appeal, at its meeting held on Monday, 30th December, 2024 and on Friday, 3rd January, 2025, considered the Appeal dated 13th December, 2024, filed by Mr. P C Tejaswi, against the decision of the Stewards, which had declared Mr. P C Tejaswi a disqualified person, for the period from **15-12-2027 to 14-06-2028** (both days inclusive) for contravention of Rule No. 202 (i) of the My.R.C. Ltd Rules of Racing [Improper Practice and Dishonourable Action], read with Rule No. 114(b)(i) [negligence in the discharge of his duties as a licensed Trainer] and Rule No. 202(xvi) of the My.R.C. Ltd Rules of Racing and read with Clause 3 of the Calendar Notification under the heading Trainers Licenses, pertaining to his charge PERFECT PERFECTO [as mentioned in Charge Sheet No. 336], in

the above race. The Board examined Mr. P C Tejaswi and took on record the submissions made by him on Monday, 30th December, 2024;

b] To uphold the decision of the Stewards, who declared Mr. P C Tejaswi a disqualified person from 15-12-2027 to 14-06-2028 (both days inclusive);

The relevant Rules of Racing are reproduced below;

Rule No. 202. The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any improper practice and dishonourable action in connection with racing anywhere;

Rule No. 114. (b); In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-

(i) If his conduct or negligence or neglect in the performance of his duties as a licenced professional has led or could have led to a breach of the Rules of Racing;

Rule No. 202 (xvi); Any person, who infringes any of the provisions of a licence issued to him or any regulations issued in the Racing Calendar be liable to such other punishment as the Stewards or the Stewards of the Club think fit to impose.

Read with clause 3 of the Calendar Notification, under the heading, TRAINERS LICENCES, reading as under;

TRAINERS LICENCES

Trainers are notified that telegraphic applications for licences or renewal of licences will not be entertained. Applications for licences under Rule 113 must be made by letter and must be accompanied with a list of horses under the charge of the applicant with the names of the Owners together with the licence fee and clearance from the recognised Club or Club in the country in which the applicant last held a trainer's licence. In the event of a licence being granted to the applicant, he must undertake:

3. To take the full responsibility of the horses in his charge and to be responsible to the Stewards of the Club for any irregularities or breaches in the Rules, Regulations or Notices in connection with any of the horses in his charge.
