Positioning of Railings : Railings fixed at an average width of 3.5 Metres from 1600 Metres to the Winning Post from its original position.

1st Race: 15. The Pattadakal Plate (About) 1600 Metres. Horses rated 00 to 25 (7 Runners):

MIRACLE HONEY (A Ayaz Khan) did not raise a fluent gallop soon after jumping out of the Starting Gates and thereafter, ran detached from the field till about passing the 150 Metres. In view of its behaviour, Trainer Mr. Ashwin Rao S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

THE WELCOME (N Ramesh Kumar) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. G T Surender was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey N Ramesh Kumar, the rider of THE WELCOME was fined **Rs.2,000/-** for travelling wide till the 1000 Metres and for taking a unduly long lead for no apparent reason.

It was observed that LEAD SINGER (M Prabhakaran) accidentally stumbled in the final 150 Metres of the race.

2nd Race: 16. The Sahyadri Plate – Div. II (About) 1400 Metres. Horses rated 20 to 45 (12 Runners):

SATIN LASS (Bharat Mal) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Majid Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

COORG HILLS (C A Brisson) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. G T Surender was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

WILD CHILD (Anil Baandal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M Bobby was informed that he must not accept

with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey B Darshan Anthony, the rider of TRUMP BABY reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f SIRA.

3rd Race: 17.The Fame and Glory Plate (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over (12 Runners):

FARA (S Mubarak) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

COOL WINTER (Anil Baandal) jumped awkwardly inwards at the start.

It was observed that the saddle on SD QUEEN (K Sai Kiran) shifted back passing the 900 Metres. On due examination of the equipment, Trainer Mr. Yogesh R was fined **Rs.3,000/-** for faulty saddling **[1st offence]**.

Jockey N Darshan, the rider of CHOICE was fined **Rs.3,000/-** for the improper use of whip whereby he used the whip on the neck of the horse.

KNOTTY IN BLUE (Afsar Khan) sustained bumping injuries on both hind back of fetlock.

Routine Sample was taken for analysis from the winner dk b g CHOICE.

4th Race: 18. The Sahyadri Plate – Div. I (About) 1400 Metres. Horses rated 20 to 45 (9 Runners):

Trainer Mr. Somashekar K was fined **Rs.2,000/-**for declaring Jockey P Vikram to ride his charge SHEER BLISS without the prior consent of the Jockey. Subsequently, permission was granted to him to substitute Jockey A A Vikrant to ride SHEER BLISS in place of the declared rider.

Permission was granted to Trainer Mr. Bipin V Salvi to **withdraw** D ROMAN POWER (K Sai Kiran) on veterinary grounds as it was found to be trotting lame on left hind due to joint sprain. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

DABEET (S Imran) was examined at the Starting Gates by the Club's Veterinary Officer and was found to be trotting lame on left hind as it got kicked by another horse at the gates. Under the circumstances it was permitted to be withdrawn on Veterinary Grounds before coming under Starters orders. Trainer Mr. Ganesh J was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

SEIKO KATSU (C Umesh) walked out of the gates and lost many lengths at the start. In view of its behaviour, Trainer Mr. K S Mandanna was informed that he

must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Anil Baandal, the rider of SHEER BLISS was fined **Rs.2,000/-** for coming in and causing interference to ANUSHTUBHA (Inayat) on his inside along the rails passing the 1000 Metres.

Jockey R Ravi, the rider of ELEGANT TIME was fined **Rs.2,000/-** for not following the post-race paddock formalities pertaining to placed horses to be unsaddled in their designated placing area.

An objection was lodged by Jockey R Ravi, the rider of ELEGANT TIME placed second by the Judge against Jockey Anil Baandal, the rider of SHEER BLISS placed first for, "Inside the final 200 Metres, my horse was galloping strongly the winner (SELMA) came on to me and bumped me and I was totally unbalanced which cost me a certain race". The Stewards held an enquiry immediately after the Race and examined Jockey R Ravi and Jockey Anil Baandal. After due deliberations and after repeatedly watching the CCTV replay of the Race, the Stewards decided to **Overrule** the objection.

Jockey R Ravi, the rider of ELEGANT TIME was fined **Rs.5,000/-** for shifting in and bumping CODE OF HONOUR (M Prabhakaran) on his inside approaching the 150 Metres.

Jockey Anil Baandal, the rider of SELMA was fined **Rs.5,000/-** for shifting out and taking out CODE OF HONOUR (M Prabhakaran) on his outside which further shifted out and bumped ELEGANT TIME (R Ravi) on its outside passing 150 Metres.

Surprise Sample was taken for analysis from b g ELEGANT TIME.

5th Race: 19.The Dr. R Rajendra Prasad Memorial Trophy (About) 1200 Metres. Horses rated 80 and above (7 Runners):

Jockey J Chinoy, the rider of GOLD KITE was reprimanded for shifting out and inconveniencing ALDGATE (S Antony Raj) on his outside passing the 1000 Metres.

It was observed that ALDGATE (S Antony Raj) did not get a clear run between the 400 Metres and 300 Metres due to a wall of horses in front of him.

Jockey Gagandeep Mann, the rider of SANTORINO reported that he accidentally dropped his whip passing the 350 Metres.

Jockey K Mukesh Kumar, the rider of CZAR was reprimanded for shifting in and inconveniencing ALDGATE (S Antony Raj) on his inside in the final 150 Metres of the race.

It was reported after the race at SANTORINO (Gagandeep Mann) burst its blood vessels during the race. Trainer Mr. K Dhyan Subbaiah was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

6th Race: 20.The Sangam Plate (About) 1600 Metres. Horses rated 40 to 65 (10 Runners):

Permission was granted to Trainer Mr. Ranjeet Shinde to **withdraw** IGNORANCE IS BLISS on veterinary grounds as it was found to be trotting lame on left hind due to inflammation of cannon. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

Permission was granted to Trainer Mr. Rakesh to **withdraw** BOUNTIFUL BEAUTY on veterinary grounds as it was found to be suffering from tied up. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

Jockey K Rajesh, the rider of NATURAL WARRIOR was reprimanded for shifting out and taking out AURELE (S Antony Raj) on his outside passing the 800 Metres.

Jockey K Rajesh, the rider of NATURAL WARRIOR was reprimanded for shifting in and inconveniencing SOUND OF CANNON'S (B Darshan Anthony) on his inside along the rails passing the 600 Metres.

Routine Sample was taken for analysis from the winner b g SEEKING ALPHA.

7th Race: 21.The Bandipur Plate (About) 1100 Metres. Horses rated 40 to 65, 5 years old and over (12 Runners):

THALAIVAA (A Ayaz Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Ashwin Rao S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Brijesh Kumar V, the rider of SPARKLING NIGHT was fined **Rs.1,000/-** for shifting out and bumping O MANCHALI (Rajesh K) on his outside passing the 1000 Metres.

Jockey P Siddaraju, the rider of MOONLIGHT QUEEN reported that his mount was trying to run out throughout the race despite his best efforts to keep it on an even course and eventually drifted out to the outer portion of the grass track after rounding the final bend. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Monnappa C D was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b m FLASHING FAMOUS.

Permission was granted to trainer Mr. Majid Khan to deputise on behalf of Trainer, K Somashekar who was unable to attend the Day's Races.

RACE NO. 41: THE SHIMSHA PLATE (ABOUT) 1600 METRES. FOR HORSES RATED 00 TO 25:

The Stipendiary Stewards reported Jockey S Sachin to the Stewards, vide Charge Sheet No. 388 dated 1ST December, 2025, for breach of Rule No. 161 (ii) of the Mysore Race Club Ltd., Rules of Racing, [Unsatisfactory Riding] pertaining to his riding, on his mount SHOCK AND AWE, in the above Race. The Stewards, at their meeting held on 3rd December, 2025 immediately after the last Race, held an enquiry and examined Jockey S Sachin and the trainer of the horse, viz., Mr. Neil Devaney.

After due deliberations and after repeatedly viewing the CCTV replay of the above Race and acting on their own observations, the Stewards decided as follows;

a) To suspend the Jockey's License granted to Jockey S Sachin, under the My. R.C. Ltd., Rules of Racing, for the year 2025-26, **for Four Race Days of the Mysore Winter Races 2025-26, i.e., on 17th December, 2025, 24th December 2025, 31st December, 2025 and 7th January, 2026,** for breach of Rule No. 161 (ii) of the Mysore Race Club Ltd., Rules of Racing, [Unsatisfactory Riding] pertaining to his riding, on his mount SHOCK AND AWE, in the above Race;

b) To caution Jockey S Sachin that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;

c) To note the explanations tendered by Trainer Mr. Neil Devaney for future reference.

Jockey S Sachin was informed that he is permitted to ride work and was also informed of his Right to Appeal.

The Stipendiary Stewards reported Trainer Mr. Neil Devaney to the Stewards, vide Charge Sheet No. 389 dated 1ST December, 2025, for breach of Rule No. 167 (b) of the Mysore Race Club Ltd., Rules of Racing, [For not voluntarily reporting to the Stipendiary Stewards, the manner of riding of Jockey S Sachin] pertaining to Jockey S Sachin's riding on his charge SHOCK AND AWE, in the above Race. The Stewards, at their meeting held immediately after the last Race on 3rd December, 2025, held an enquiry and examined Trainer Mr. Neil Devaney.

After due deliberations, the Stewards decided as follows;

a) To Fine Trainer Mr. Neil B Devaney a sum of **Rs.15,000/- [Rupees Fifteen Thousand only]** for breach of Rule No. 167 (b) of the Mysore Race Club Ltd., Rules of Racing, for not voluntarily reporting to the Stipendiary Stewards the riding of Jockey S Sachin, who rode his charge SHOCK AND AWE, in the above Race;

b) To caution Trainer Mr. Neil B Devaney that a repetition of a similar manner of offence in future would entail severe action against him by the Stewards;

Trainer Mr. Neil B Devaney was informed that his Right to Appeal.

RACE NO. 46: THE INDRADHANUSH PLATE (ABOUT) 1100 METRES. HORSES RATED 20 TO 45, 5 YEARS OLD AND OVER CONFINED TO MYSORE BASED HORSES:

The Stipendiary Stewards reported Jockey A Ramu to the Stewards, vide Charge Sheet No. 386, dated 14th November 2025, for breach of Rule Nos. 159 (a) and (b) of the My.R.C. LTd., Rules of Racing [For not permitting his mount to run on its merits], pertaining to his riding on his mount THE LADY EMPORIO, in the above race, as detailed below;

"Charge Sheet

[Allegation of a breach of the My.R.C. Rules of Racing]

Venue: Mysuru

Race No. 46

Date: 25th September, 2025

Defendant: A Ramu

Designation: Jockey

The My.R.C. Stipendiary Stewards allege that the above named defendant committed a breach of:

159 (a) and (b) of the My.R.C. LTd., Rules of Racing [For not permitting his mount to run on its merits], pertaining to his riding on his mount THE LADY EMPORIO, in the above race.

In that, as a rider of THE LADY EMPORIO,

a) Whereas, your riding instructions were to take a good jump and sit in 4th or 5th position as the race will be fast and to ride out and do your best after entering the Straight.

b) Whereas, Your mount THE LADY EMPORIO opened a favourite at 3 to 1 and closed at 13 by 10, which denotes that it was heavily fancied by the public;

c) Whereas, you have not been alert at the Start and instead of leaning forward and sitting well up near the neck of the horse in a balanced position, as is the actual practice followed by any rider in a Race, you have sat back on the saddle of the horse and not given it a loose rein, as is very evidently seen in the CCTV

footage of the back camera of the Starting Gates, which has resulted in your mount planting in the gates and losing more than a distance, at the Start;
d) Whereas, by impeding it to take a good jump, your mount has also taken a fly jump and lost all its chances at the Start;
d) Whereas, after the poor start, to make up the lost ground, you have ridden the horse to the ground, to catch up with the front runners, knowing very well that you will be using up your mount even before it entered the Straight;
e) After entering the Straight, your mount totally fizzled out as it had nothing left in the tank, thereby finishing dead last, about 12 ¼ lengths from the 2nd last horse, viz., SAFFRON BREEZE (Faiz). Thus, all your negative riding efforts has resulted in a lot of public money going down the drain;

Thus, in the opinion of the Stipendiary Stewards you are guilty of not riding your mount according to its merits thus breaching Rule Nos. 159 (a) and (b) of the My.R.C. Ltd., Rules of Racing, pertaining to your riding on your mount THE LADY EMPORIO, in the above Race.

The Stewards, at their meeting held immediately after the last Race, on 3RD December 2025, conducted an enquiry and examined the Jockey A Ramu and the Trainer of the horse, Mr. Ranjeet Shinde.

The Stewards also considered the following:

- a)** The Charge Sheet No. 386, dated 14TH November, 2025, issued to Jockey A Ramu by the Stipendiary Stewards;
- b)** The proceedings of the preliminary enquiry dated 25TH September, 2025, conducted by the Stipendiary Stewards and the submissions made on that day, by Jockey A Ramu and the Trainer of the horse, viz., Mr. Ranjeet Shinde;
- c)** The complaint letter dated 26th September, 2025, received from Trainer Mr. Ranjeet Shinde, pertaining to the riding of Jockey A Ramu, on his charge THE LADY EMPORIO, in the above Race;
- d)** The submissions made by Jockey A Ramu and Trainer Mr. Ranjeet Shinde made before them on this day, i.e., on 3rd December, 2025;

The Stewards of the Club, after detailed discussions and great deal of deliberations and after repeatedly viewing all the available angles the CCTV replay of the above Race, with particular reference to the start of the above Race, both in slow motion as well as regular speed and after carefully studying the My.R.C., Ltd. Rules of Racing, unanimously concluded as follows;

i) That Jockey A Ramu appears to have been deliberately not alert on his saddle to take good jump and he has sat back on his saddle, not given a long rein to his mount THE LADY EMPORIO to take a good jump, thus losing more that a distance at the Start and also for riding contrary to his Trainer's riding instructions, which was to take a good jump and sit in 4th or 5th position;

ii) Whereas, after the poor start, to make up the lost ground, Jockey A Ramu has ridden the horse to the ground, to catch up with the front runners, knowing very well that he will be using up his mount even before it entered the Straight and after entering the Straight, his mount totally fizzled out as it had nothing left in the tank, thereby finishing dead last, about 12 ¼ lengths from the 2nd last horse,

viz., SAFFRON BREEZE (Faiz). Thus, all his negative riding efforts have resulted in a lot of public money going down the drain;

iii) The Stewards also noted that Trainer Mr. Ranjeet Shinde had also given a written complaint pertaining to the riding of Jockey A Ramu, in his charge, THE LADY EMOPRIO, in the above Race. They also noted the explanations of Trainer Mr. Ranjeet Shinde who also happened to be an Ex-Jockey himself, before he became a Trainer, who also confirmed that if a rider sits back on his saddle instead of crouching and sitting forward on the neck of the horse, the horse is bound to miss the jump;

in view of the forgoing facts, the Stewards concluded that Jockey A Ramu has certainly not permitted his mount to run on its merits thereby breaching Rule Nos. 159 (a) and (b) of the My.R.C. Ltd., Rules of Racing;

In the light of the above, the Stewards decided as follows;

a) To declare Jockey A Ramu a disqualified person for a period of one year, i.e., from **13/12/2025 to 12/12/2026** (both days inclusive), for breach of Rule Nos. 159 (a) and (b) of the My.R.C. Ltd., Rules of Racing [For not permitting his mount to run on its merits], pertaining to his riding on his mount THE LADY EMPORIO, in the above race;

b) Thus all the disabilities that is applicable to a disqualified person, in terms of the My.R.C. Ltd., Rules of Racing, shall apply to Jockey A Ramu;

c) To note the explanations tendered by Trainer, Mr. Ranjeet Shinde.

Jockey A Ramu was informed of their Right to Appeal.

I) CHARGE SHEET NO. 391, DATED 1ST DECEMBER, 2025 ISSUED TO TRAINER Mr. BIPIN V SALVI FOR BREACH OF RULE NO. 114 (b) (i) OF THE My.R.C. LTd., RULES OF RACING READ WITH CALENDAR NOTIFICATION UNDER THE HEADING "TRAINERS AND JOCKEYS LEAVE OF ABSENCE":

The Stipendiary Stewards reported Trainer Mr. Bipin V Salvi for breach of Rule No. 114 (b)(i) of the My.R.C. Ltd., Rules of Racing read with Calendar Notification under the heading "TRAINERS AND JOCKEYS LEAVE OF ABSENCE", for frequently absenting himself and for having been absent for morning Track Work, from 26th October, 2025 to 10th November, 2025 without informing the Stipendiary Stewards to take their consent, neither orally or in writing and also for not handing over his horses to an "A" Licensed Trainer, during his absence.

The Stewards, at their meeting held immediately after the last Race on 3rd December, 2025, held an enquiry and examined Trainer Mr. Bipin V Salvi.

After due deliberations, the Stewards decided as follows;

a) To Fine Trainer Mr. Bipin V Salvi a sum of **Rs.25,000/- [Rupees Twenty Five Thousand only]** for breach of Rule No. 114 (b)(i) of the My.R.C. Ltd., Rules of Racing read with Calendar Notification under the heading "TRAINERS AND JOCKEYS LEAVE OF ABSENSE";

b) To caution Trainer Mr. Bipin V Salvi that a repetition of a similar manner of offence in future would entail severe action against him by the Stewards;

Trainer Mr. Bipin V Salvi was informed that his Right to Appeal.

II) CHARGE SHEET NO. 392 ISSUED TO TRAINER Mr. BIPIN V SALVI FOR BREACH OF RULE No 114 (b)(i) [Negligence in the discharge of his duties as a licensed Trainer pertaining to Stable Management] READ WITH RULE NO. 202 (i) OF THE MyRC Ltd., RULES OF RACING AND CLAUSE 3 OF THE CALENDAR NOTIFICATION UNDER THE HEADING "TRAINERS LICENSES" PERTAINING TO WORKING HIS CHARGE, LEO (Track No. 271) and ABSOLUTE GOLD (Track No. 004) at 8.56 a.m., ON 13th NOVEMBER, 2025, AFTER THE STIPULATED TRACK CLOSURE TIME OF 8.30 a.m.:-

The Stipendiary Stewards reported Trainer Mr. Bipin V Salvi for breach of Rule No 114 (b)(i) [Negligence in the discharge of his duties as a licensed Trainer pertaining to Stable Management] read with Rule No. 202 (i) of the MyRC Ltd., Rules of Racing and Clause 3 of the Calendar Notification under the heading "TRAINERS LICENSES" pertaining to working his charge, LEO (Track No. 271) and ABSOLUTE GOLD (Track No. 004) at 8.56 a.m., on 13th November, 2025, after the stipulated track closure time of 8.30 a.m.

The Stewards, at their meeting held immediately after the last Race on 3rd December, 2025, held an enquiry and examined Trainer Mr. Bipin V Salvi.

After due deliberations, the Stewards decided as follows;

a) To caution Trainer Mr. Bipin V Salvi that he is being given the benefit of doubt and with a word of caution that he should more judicious towards his responsibilities as a Licensed Trainer in future;

b) The Stewards also informed Trainer Mr. Bipin V Salvi that a repetition of a similar manner of offence in future would entail severe action against him by the Stewards;

Trainer Mr. Bipin V Salvi was informed that his Right to Appeal.
