#### **RACING INCIDENTS**

**(Race No. 8 - 14)**

<b>Positioning of Railings:</b>	<b>Railings are fixed at an average width of 3.0 Metres from 1600 Metres to the Winning Post from its original position.</b>

#### **1<sup>st</sup> Race: 8. The Kolar Plate – (About) 1400 Metres. Horses rated 20 to 45 (8 Runners):**

ELEVADO (Salman Khan) took a fly jump at the start.

AMAZING JOY (Hasib Alam) was slowly away at the Start, did not raise a fluent gallop, lost many lengths at the start and ran detached from the field, thereafter. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Bharat Mal, the rider of SUNWAY LAGOON reported that he accidentally lost his whip, approaching the 400 Metres.

Jockey Bharat Mal, the rider of SUNWAY LAGOON was reprimanded for not exercising sufficient control over his mount, thereby allowing it to drift out, in the final 300 Metres of the race.

Jockey Faiz, the rider of AASHIRVAD was fined **Rs. 3,000/-** for the excessive use of the whip on his mount during the race (**1<sup>st</sup> Infraction**).

It was reported after the race that ELEVADO (Salman Khan) burst its blood vessels during the race. Trainer Mr. Bipin V Salvi was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

SUNWAY LAGOON (Bharat Mal) was impounded for veterinary examination but no abnormality was reported.

**An enquiry is being held into the relative performance of SAIGON (Sah Farid Ansari) and SAPIENT (Vinod Shinde), trained by Mr. Pillay J S, in the above Race.**

Routine Sample was taken for analysis from the winner b g STAR IS BACK.

**2<sup>nd</sup> Race: 9. The Nagamangala Plate – Div. II (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (7 Runners):**

It was observed that RED FALCON (L Alex Rozario) was extremely fractious in the Gates, reared up and flipped over as a result got cast in the gates for a considerable period of time. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

GEMINI (Madhu Sudhan S) jumped awkwardly inwards at the start.

An objection was lodged by Jockey Ankit Pal, the rider of NATURAL TORNADO, placed Second by the Judge against Jockey H M Akshay, the rider of AURELE placed First by the Judge for, "From the last 300 Metres the winner took me out till the finish line which cost me a certain race". The Stewards held an enquiry immediately after the Race and examined the Jockeys concerned. After due deliberations and after repeatedly watching the CCTV replay of the Race, the Stewards decided to **overrule** the objection.

Jockey Ankit Pal, the rider of NATURAL TORNADO was fined **Rs.2,000/-** for shifting out and causing interference to DABEET (Vinod Shinde) on his outside which in turn passed it onto SERGEANT RECKLESS (Faiz) passing the 200 Metres.

It was reported after the race that SERGEANT RECKLESS (Faiz) pulled up lame on left fore. Trainer Mr. C D Monnappa was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

RED FALCON (L Alex Rozario) sustained injuries inside both thigh region.

GEMINI (Madhu Sudhan S) sustained gum injuries.

**3<sup>rd</sup> Race: 10. The Balamuri Plate – (About) 1400 Metres. Horses rated 00 to 25 (10 Runners):**

Jockey Bharat Mal, the rider of THE WELCOME was fined **Rs.1,000/-** for shifting out and causing interference to CZAREVITCH (M J Gautam Raj Urs) on his outside passing the 1100 Metres.

Routine Sample was taken for analysis from the winner dk b g D ADMIRAL.

**4<sup>th</sup> Race: 11. The Prince Regent Plate – (About) 1200 Metres. Horses rated 20 to 45 5 years old and over (11 Runners):**

MAGIC CIRCLE (G Umesh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Faiz, the rider of CLOUDY HILLS was fined **Rs.2,000/-** for dropping hands and completely easing up his mount, in the final 150 Metres of the race.

It was observed that SARO GOLD MINE (Rahil Akhtar) ran detached after passing the 200 Metres. Trainer Mr. Somashekar K was advised to ensure better performance of his charge in future.

**An enquiry is being held into the running and riding of DRISANA, trained by Mr. J S Pillay and ridden by Jockey A Ayaz Khan in the above race.**

**An enquiry is being held into the weight discrepancy of THE GOLDEN SUNRISE (N B Kuldeep), trained by Mr. Santosh S Rao, in the above Race.**

Routine Sample was taken for analysis from the winner b m FELICITA.

**5<sup>th</sup> Race: 12. The Star Supreme Trophy – (About) 1200 Metres. Horses rated 80 and above (12 Runners):**

Routine Sample was taken for analysis from the winner b g ALDGATE.

**6<sup>th</sup> Race: 13. The Nagamangala Plate – Div. I (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (9 Runners):**

ONE DIAMOND (Faiz) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. C D Monnappa was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Brijesh Kumar V, the rider of AMAZING ARISE was fined **Rs.1,000/-** for shifting out and bumping IGNORANCE IS BLISS (Siddaraju P) on his outside soon after jumping out of the Starting Gates.

Jockey Rahil Akhtar, the rider of DECACORN was fined **Rs.2,000/-** for not exercising sufficient control over his mount, thereby allowing it to drift out under the use of the whip on the right and taking out SIR CALCULUS (L Alex Rozario), on his outside, in the closing stages of the race.

It was observed that AMAZING ARISE (Brijesh Kumar V) ran detached from the field after passing the 300 Metres. Trainer Mr. Mansoor Khan was informed to ensure better performance of his charge in future.

**7<sup>th</sup> Race: 14. The Red Satin Plate – (About) 1200 Metres. Horses rated 40 to 65 (12 Runners):**

RAPIDUS (Shankar Lal H) was slowly away, did not raise a fluent gallop and lost many lengths at the start. In view of its behaviour, Trainer Mr. Bobby M was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

NATURAL SPEED (H M Akshay) after jumping out did not raise a fluent gallop and thereafter, ran detached from the field, throughout the race. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

#### **FOURTEENTH DAY, WEDNESDAY, 12<sup>th</sup> FEBRUARY 2025**

##### **Race No. 91: The Tuticorin Plate (About) 1400 Metres. Horses rated 00 to 25:**

The Stipendiary Stewards questioned Jockey N Arvind Kumar pertaining to his riding, on his mount THE ANGEL POWER, in the presence of Trainer Mr. Santosh S Rao, in the above race. after due enquiry, the Stipendiary Stewards decided as follows;

- a) To fine Jockey N Arvind Kumar a sum of **Rs. 5,000/-** for not sufficiently persevering with his mount in the Straight. He was also cautioned that a repeat of a similar manner of riding on his mount in future, would entail him being reported to the Stewards for appropriate action.
- b) To accept the explanations tendered by Trainer Mr. Santosh S Rao.

#### **ELEVENTH DAY, WEDNESDAY, 22<sup>ND</sup> JANUARY 2025**

##### **RACE NO. 73: THE UJIRE PLATE – DIV. I (ABOUT) 1100 METRES. HORSES RATED 00 TO 25:**

The Stipendiary Stewards reported Trainer, Mr. Santosh S Rao to the Stewards vide Charge Sheet No. 352, dated 21<sup>st</sup> May, 2025 for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, [Negligence in the discharge of his duties as a licensed Trainer] pertaining to the running of his charge GENTLEMAN'S WORD (P Sai Kumar), in Race No. 73 of the Mysore Winter Races 2024-25, run on Eleventh Day, Wednesday, 22<sup>nd</sup> January, 2025 as compared to its previous run in Race No. 51 of the Mysore Winter Races 2024-25, run on Eighth Day, Friday, 3<sup>rd</sup> January, 2025, when ridden by Jockey Ajeet Kumar, it ran unplaced. The Stewards, at their meeting dated 27<sup>th</sup> May, 2025, considered the above Charge Sheet issued to Trainer Mr. Santosh S Rao and examined him. After repeatedly viewing the CCTV replays of Race No. 73 as well as Race No. 51 and after due enquiry and not being satisfied with the explanations tendered by Trainer Mr. Santosh S Rao, the Stewards decided as follows;

- a) To fine Trainer Mr. Santosh S Rao a sum of **Rs.25,000/- (Rupees Twenty Five Thousand only)** for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, [Negligence in the discharge of his duties as a

licensed Trainer] pertaining to the running of his charge GENTLEMAN'S WORD (P Sai Kumar), in the above Race; and

**b)** To caution Trainer Mr. Santosh S Rao that a repeat of a similar manner of offence by him in future, would be dealt with, appropriately by the Stewards.

**RACE NO. 71: THE UJIRE PLATE – DIV (II) (ABOUT) 1100 METRES. HORSES RATED 00 TO 25:**

The Stipendiary Stewards reported, Trainer, Mr. Surender G T to the Stewards, vide Charge Sheet No. 354, dated 22<sup>nd</sup> May, 2025, for breach of Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd., with regards to blood oozing out from the left jugular vein due to needle prick, observed at the Gates, pertaining to his charge AMRON TIGRESS (Vinod Shinde),, in the above race, as detailed below;

The My.R.C. Stipendiary Stewards allege that the above named defendant committed a breach of:

Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd., with regards to blood oozing out from the left jugular vein due to needle prick, observed at the Gates, pertaining to his charge AMRON TIGRESS (Vinod Shinde), in the above race.

**ANNEXURE TO, AND FORMING PART OF CHARGE SHEET NO. 354 DATED 22<sup>nd</sup> MAY, 2025, ISSUED TO TRAINER Mr. G T SURENDER ;**

### **In that, as a Licensed Trainer,**

In Race No. 71 of the Mysore Winter Races 2024-25, run on 22<sup>nd</sup> January, 2025, the Club's Handler, the Stipendiary Steward along with the Veterinary officer noticed that your charge, AMRON TIGRESS, which was running in the Race, i.e., Race No. 71, The Ujire Plate – Div. II (About) 1100 Metres, for horses rated 00 to 25, was observed to have blood on left jugular vein and under the neck region at the Gates. Upon examination by the Club's Veterinary Officer, it was found to have a needle prick on the Left Jugular Vein. The Club's Veterinary Officer confirmed that the bleeding was due to the needle Prick, which had opened up due to the dislodging of the Clot. Subsequently the horse was not permitted to Race in the above Race and a urine sample was taken from your charge, AMRON TIGRESS.

During the course of the enquiry by the Stipendiary Stewards and the Chief Veterinary Officer, you have failed to give a proper explanation as to how the needle prick has occurred on your charge, AMRON TIGRESS and on the contrary, you have kept on tendering misleading evidence, during the course of the enquiry. You have also failed to conduct your own enquiry pertaining to the above incident amongst your Stable Staff.

In view of the above, the Stipendiary Stewards find that,

- a) You are guilty of mal-practice of administering injection to your charge, AMRON TIGRESS, without the knowledge of the Club's Veterinary Officer or a Private Veterinary Practitioner, approved by the Club;
- b) You are guilty of dishonest, corrupt, fraudulent, or improper practice or dishonourable action and for tendering false and misleading evidence during the preliminary enquiry conducted by the Stipendiary Stewards and the Chief Veterinary Officer.

Thus, in the opinion of the Stipendiary Stewards, you have breached Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd., reading as follows;

#### **MEDICATION RULES**

#### **under the heading, "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"**

##### **Rule No.6**

Only Veterinarians, duly approved by the Stewards of the Club are permitted to administer medicines. Except for such Veterinarians, it is forbidden for any other person to administer any medication or to bring a syringe or a hypodermic needle where racehorses are sheltered.

##### **Rule No. 7**

**PROHIBITED SUBSTANCES:** Prohibited Substances are substances capable at any time of causing an action or effect, or both an action and effect, within one or more of the following mammalian body systems:

1. The Nervous system;
2. The Cardiovascular system;
3. The Respiratory system;
4. The Digestive system;
5. The Urinary system;
6. The Reproductive system;
7. The Musculoskeletal system;
8. The Blood system;
9. The Immune system except for licensed vaccines against infectious agents;
10. The Endocrine system;
11. The Eyes and ears.

### **Rule No. 13**

Any person committing a breach of any of the practices mentioned below will be guilty of an offence under these Rules and shall be liable to penalty under these Rules. The practices mentioned below are indicative and not exhaustive rule 13 (a) to (i) :-

(b) Subjecting horses to medical or surgical procedures outside of a valid and transparent Owner-Trainer-Veterinarian relationship and those inconsistent with providing medical and / or welfare benefits to the horse;

(c) Use of physical or veterinary procedures or medication treatments to mask the effects or signs of injury so as to allow training or racing to the detriment of the horse's health and welfare;

(f) All treatments are the responsibility of the Trainer and must be administered under veterinary supervision. All treatments must be administered in the best interests of the horse and not to facilitate the continuation of training. In the case of substances controlled by Government regulation, these may only be administered by, or on the prescription of, an Approved Veterinarian;

### **Rule No. 19:**

A trainer must record in his log book (hand written) any medication or treatment administered to any horse in the trainer's care by midnight on the day on which the administration was given.

- (1) For the purpose of this Rule, each record of administration must include the following information:-
  - (a) the name of the horse;
  - (b) the date and time of administration of the treatment or medication;

- (c) the name of the treatment or medication administered (brand name or active constituent);
  - (d) the route of administration including by injection, stomach tube, paste, topical application or inhalation;
  - (e) the amount of medication given (if applicable);
  - (f) the duration of treatment (if applicable);
  - (g) the name and signature of the person/s administering and/or authorizing the administration of the treatment or medication.
- (2) For the purposes of this rule "treatment" includes:-
- (a) shock wave therapy;
  - (b) acupuncture (including laser treatment);
  - (c) chiropractic treatment;
  - (d) the use of any electrical stimulation device (including transcutaneous electrical nerve stimulation (TENS));
  - (e) magnetic field therapy;
  - (f) ultrasound;
  - (g) any form of oxygen therapy, including hyperbaric oxygen therapy;
  - (h) the taking of a blood sample.
- (3) For the purposes of this rule "medication" includes:-
- (a) all Controlled Drugs administered by an approved veterinarian;
  - (b) all Prescription Animal Remedies;
  - (c) all Prescription Only Medicines, prescribed and/or dispensed by an Approved Veterinarian for off-label use;
  - (d) all injectable medicines (intravenous, intramuscular, subcutaneous, intra-articular) not already referred to above;
  - (e) all Pharmacist Only medicines;
  - (f) all veterinary and other medicines containing other scheduled and unscheduled prohibited substances;
  - (h) all herbal/ayurvedic preparations;
  - (i) all homeopathic medicines.
- (4) Any person who breaches this Rule is guilty of an offence and may be penalized.

### **Rule No. 23:**

The Trainer shall always be responsible and accountable at all times for: -

- (c) For ensuring that only Veterinarians approved by the Stewards inject or otherwise treat horses in his/her care;

### **Rule No.24:**

- (1) A person must not, without the permission of the Stewards: -
  - (a) administer; or
  - (b) cause to be administered, any medication to a horse at any time on a race day prior to the commencement of a race in which the horse is engaged to race.

(c) any person who breaches this Rule is guilty of an offence and may be penalized.

**Rule No. 27:- INJECTIONS AND MEDICATIONS PROHIBITED AT CERTAIN TIMES**

- (1) A person must not, without the permission of the Stewards:-
  - (a) inject;
  - (b) cause to be injected;
  - (c) attempt to inject; or
  - (d) be a party to the injection or attempted injection of, a horse engaged to run in any race:
    - (i) at any time during the 72 hours prior to the scheduled race for any substance;
    - (ii) at any time during the 14 days prior to 12.00am on the day of the scheduled race for corticosteroids administered intra-articularly.
- (2) If a person breaches sub-rule 1 or the Stewards reasonably suspect that such a breach has been committed, they may order the scratching of the horse from the relevant race.
- (3) If a person breaches sub-rule 1 , but the horse competes in the race, the horse may be disqualified from the race.
- (4) For the purposes of this rule:-
  - (a) "inject" includes, but is not limited to, the insertion of a hypodermic needle into a horse;
  - (b) it is not necessary to establish whether any substance was injected, or the nature of any substance injected.
- (5) **Specific requirements regarding bisphosphonates as per the IFHA Article 6D:**

Any bisphosphonate is not to be administered to a racehorse:

- under the age of three years and six months as determined by its recorded date of birth; and
- on the day of the race or on any of the 30 days before the day of the race in which the horse is declared to run.

There must be a diagnosis determined by a veterinary surgeon that supports the use of a bisphosphonate as an appropriate treatment, and such treatment must be administered by a veterinary surgeon.

**RULES OF RACING**

**RULE NO. 114**

- (a) Any person, training a horse in contravention of this Rule, may be warned off the course and then shall be subject to all disabilities specified under the Rules.
- (b) In addition to or in lieu of any other penalties or punishments, as may be

laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-

(i) If his conduct or negligence or neglect in the performance of his duties as a licenced professional has led or could have led to a breach of the Rules of Racing;

**RULE NO. 202:-**

The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any dishonest, corrupt, fraudulent, or improper practice or dishonourable action in connection with racing anywhere;

(vi) Any Owner, Nominator, Trainer, Jockey, Lessee, Apprentice, Stable Hand, Bookmaker or Bookmaker's Assistant or any person, who either wilfully refuses to attend and give evidence at an enquiry when requested by the Stewards/ Stewards of the Club/ Stipendiary Stewards to do so, or knowingly gives evidence, which is false or misleading in any particular.

**XXXXXXXXXX**

(vii) Any person, who gives at any Enquiry or Appeal any evidence, which, in their opinion, is false or misleading in any manner.

**XXXXXXXXXX**

(x) (a) Any person, who, at any time, administers or attempts to administer or allows or causes to be administered or connives at the administration to a horse of any quantity of any substance, which is a Prohibited Substance for any purposes including any of the following purposes:

(i) For the purpose of affecting the performance or behaviour of a horse in a Race or of preventing its starting in a Race;

The Stewards, at their meeting held on 27<sup>th</sup> May 2025, conducted an enquiry and examined the Trainer, Mr. Surender G T, as also the Assistant to Trainer, Mr. Manoj Sharma pertaining to the above incident.

The Stewards also considered the following:

- a)** The Charge Sheet No. 354, dated 22<sup>nd</sup> May, 2025, issued to Trainer, Mr. Surender G T by the Stipendiary Stewards;
- b)** The proceedings of the preliminary enquiry dated 6<sup>th</sup> April, 2025, conducted by the Advisor, Racing, the Stipendiary Stewards and the Club's Veterinary Officer and the submissions made on that day, by Trainer Mr. Surender G T, his Assistant, Mr. Manoj Sharma, the Riding Boy Mr Arjun Singh and the Syce of the horse, Mr. Kamleshwar;
- c)** The proceedings of the continuation of the preliminary enquiry dated 10<sup>th</sup> May, 2025, conducted by the Advisor, Racing, the Stipendiary Stewards and the Club's Veterinary Officer and the submissions made on that day, by Trainer Mr. Surender G T, his Assistant, Mr. Manoj Sharma and the handlers of MyRC, Mr. Keerthi Raj and Mr. H Prakash;
- d)** The Photographs of neck of the said horse, AMRON TIGRESS, taken behind the Starting Gates, when the needle prick wound with blood oozing out from it, was noticed, just before the Start of the Race in question, i.e., Race No. 71 of the Mysore Winter Races 2024-25, i.e., The Ujire Plate – Div (II) (About) 1100 Metres, for horses rated 00 to 25;

The Stewards of the Club, after detailed and great deal of deliberations and after carefully studying the My.R.C., Ltd. Rules of Racing and Calendar Notification, unanimously concluded as follows;

- i)** That the horse in question, i.e., AMRON TIGRESS, under the charge of Trainer Mr. Surender G T was injected with an unidentified substance and that Trainer Mr. G T Surender is vicariously responsible for this incident as this has happened when the horse was under his care and as such, he is guilty of and in contravention of relevant Medication Rules under the heading, "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL", as mentioned by the Stipendiary Stewards in the Charge Sheet No. 354, issued to Trainer Mr. G T Surender and it is clear that Trainer Mr. G T Surender has not brought the above incident to the knowledge of the Club's Veterinary Officer nor is there any records of the same in the horse's Medication Logbook;
- ii)** That Trainer Mr. Surender G T is guilty of dishonest act and dishonourable action and for tendering false and misleading evidence during the preliminary enquiry conducted by the Stipendiary Stewards and the Chief Veterinary Officer, thus breaching Rule No. 202 (i), Rule No. 202 (vi) and Rule No. 202 (x) (i) of the Mysore Race Club Rules of Racing;
- iii)** That Trainer, Mr. Surender G T's act of tendering unsatisfactory explanation to the Stipendiary Stewards, feigning ignorance pertaining to the Syringe prick on his charge, AMRON TIGRESS, that was found on his charge behind the Gates, before the Start of the above Race amounts to breaching Rule No. 202 (vii) read

with Rule No. 114 (a) (b) (i) of the Mysore Race Club Rules of Racing [Negligence in the discharge of his duties as a licensed Trainer];

Thus, the Stewards concluded that Trainer Mr. Surender G T is guilty of contravention of Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd. with regards to blood oozing out from the left jugular vein due to needle prick, observed at the Gates, pertaining to his charge AMRON TIGRESS (Vinod Shinde), in the above race;

**iv)** The Stewards also considered the role played by Mr. Manoj Sharma, Asst. to Trainer Mr. G T Surender, pertaining to the above incident. The Stewards also felt that Mr. Manoj Sharma was also vicariously responsible for the above incident as he has accompanied the horse on the Race Day, from the stables to the Equine Hospital [The horse was saddled at the equine hospital as it was very fractious] and from the Equine Hospital till the entrance of the Paddock. He had also feigned ignorance of the needle prick wound and also tendered unsatisfactory explanations during the course of the enquiry conducted by the Stipendiary Stewards and the Club's Veterinary Officer.

Thus the Stewards concluded that Asst. to Trainer Mr. Manoj Sharma is also vicariously responsible for the above incident and also concluded that Asst. to Trainer Mr. Manoj Sharma is guilty of contravening all the relevant Medication Rules of the My.R.C. Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** as mentioned above, read with Rule Nos. 202 (i), 202 (vi), 202 (vii) & 202 (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd, as mentioned above.

In the light of the above, the Stewards decided as follows;

**a)** To declare Trainer Mr. Surender G T a disqualified person, from **06/06/2025 to 05/06/2026** (both days inclusive), for contravention of Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading **"MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL"** read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd. with regards to blood oozing out from the left jugular vein due to needle prick, observed at the Gates, pertaining to his charge AMRON TIGRESS (Vinod Shinde), in the above race, which amounts to dishonest act and dishonourable action and for tendering unsatisfactory explanation to the Stipendiary Stewards, tendering misleading evidence by feigning ignorance of the needle prick, observed at the Gates, pertaining to his charge AMRON TIGRESS (Vinod Shinde), in the above Race;

**b)** To declare Mr. Manoj Sharma, Asst. to Trainer, Mr. G T Surender, as a disqualified person, from **06/06/2025 to 05/12/2025** (both days inclusive),

for being vicariously responsible for the above incident involving Trainer Mr. G T Surender, as mentioned above;

**c)** Thus all the disabilities that is applicable to a disqualified person, in terms of the My.R.C. Ltd., Rules of Racing, shall apply to Trainer Mr. G T Surender and Asst. to Trainer Mr. Manoj Sharma;

Trainer, Mr. Surender G T and Asst. to Trainer Mr. Manoj Sharma were informed of their Right to Appeal.

The Stipendiary Stewards reported Trainer, Mr. M Bobby to the Stewards vide Charge Sheet No. 353, dated 21<sup>st</sup> May, 2025 for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, [Negligence in the discharge of his duties as a licensed Trainer] pertaining to the running of his charge CODE OF HONOUR (A Ramu), in the above Race as compared to its previous run in Race No. 51 of the Mysore Winter Races 2024-25, run on Eighth Day, Friday, 3<sup>rd</sup> January, 2025, when ridden by Jockey M Prabhakaran, it ran unplaced. The Stewards, at their meeting dated 27<sup>th</sup> May, 2025, considered the above Charge Sheet issued to Trainer Mr. M Bobby and examined him. After repeatedly viewing the CCTV replays of Race No. 84 as well as Race No. 51 and after due enquiry the Stewards decided as follows;

- a)** To accept the explanations tendered by Trainer Mr. M Bobby, pertaining to the running of his charge CODE OF HONOUR (A Ramu), in the above Race; and
- b)** To caution Trainer Mr. M Bobby that a repeat of a similar manner of offence by him in future, would be dealt with, appropriately by the Stewards.
