RACING INCIDENTS

(Race No. 15 - 21)

Weather:	Clear
Track Condition:	Good Going
Penetrometer reading:	2.9cms
Positioning of Railings:	Railings are fixed at an average width of 4.5 Metres from 1600 Metres to the Winning Post from its original position.

1st Race: 15. The Tapathi Plate – (About) 1100 Metres. For maiden Indian horses, 3 years old only (7 Runners):

Trainer Mr. M Eshwer was fined a sum of **Rs.10,000/-** for having entered his charge ZILFEE to run in the above race when it was under Veterinary ban. Subsequently permission was granted to him to scratch it from the above race.

MISTY WARRIOR (C Umesh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. K S Mandanna was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Varun, the rider of FALCON FURY was reprimanded for not maintaining a straight course thereby allowing his mount to drift out passing the 400 Metres.

It was observed that ADENA (Anil Baandal) was trying to run out throughout the race despite the best efforts of the Jockey to keep it on an even course and subsequently went on to the outer portion of the grass track and thereafter, ran detached after passing the final 200 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Feroz M Khan was informed to take appropriate corrective measures before accepting with it again.

Jockey K Rajesh, the rider of BOUNTIFUL BEAUTY reported that his mount was hanging out badly after passing the 400 Metres and finished the race on the outer portion of the grass track despite his best efforts. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Rakesh was informed to take appropriate corrective measures before accepting with it again.

Surprise sample was taken for analysis from b g MYSORE PHAROAH.

2nd Race: 16. The Queen of the Hills Plate, Div.II – (About) 1200 Metres. Horses rated 00 to 25 (11 Runners):

Trainer Mr. C D Monnappa was fined **Rs.2,000/-** for failing to produce the declared colors in respect of his charge POLAR QUEEN (C A Brisson) in the

above race. Subsequently All Black emergency colors were permitted to be used.

Jockey C A Brisson, the rider of POLAR QUEEN was fined **Rs.3,000/-** for riding an indifferent race.

It was observed that MIRACLE HONEY (Koshi Kumar) was trying to run out from the 800 Metres despite the best efforts of the Jockey to keep it on an even course and subsequently finished the race on the outer portion of the grass track. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Ashwin S Rao was informed to take appropriate corrective measures before accepting with it again.

An enquiry is being held into the running and riding of BASIC INSTINCT, trained by Mr. J Ganesh and ridden by Jockey N B Kuldeep in the above race.

3rd Race: 17. The Diabolical Plate – (About) 1400 Metres. Horses rated 40 to 65 (8 Runners):

NATURAL WARRIOR (Ankit Pal) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

It was observed that Jockey Ankit Pal, the rider of NATURAL WARRIOR, accidentally struck the whip of Jockey Koshi Kumar, the rider of SILVER DAYS AGAIN as such Jockey Koshi Kumar dropped his whip in the final 50 Metres of the race.

An enquiry is being into the running and riding of SHEROUK, trained by Mr. J S Pillay and ridden by Jockey Sah Farid Ansari in the above race.

Surprise sample was taken for analysis from ch f SHEROUK.

4th Race: 18. The Queen of the Hills Plate, Div.I – (About) 1200 Metres. Horses rated 00 to 25 (11 Runners):

ANKUSH (A Ayaz Khan) jumped out awkwardly, at the Start.

Jockey Shyam Kumar (CHE), the rider of GLEAM BELL was fined **Rs.1,000/-** for shifting out and causing interference to ALEXANDER MAXIMUS (Abhishek Mhatre), on his outside, passing the 350 Metres.

Jockey A Ayaz Khan, the rider of ANKUSH was reprimanded for riding an indifferent race.

An enquiry is being held into the running and riding of SAMARTH (S Imran), trained by Mr. K Aditya and ridden by Jockey S Imran in the above race.

ALEXANDER MAXIMUS (Abhishek Mhatre) sustained cut injury inside right hind thigh region.

GOLDEN STRIDE (N Ramesh Kumar) sustained bleeding cut on right nostril.

Surprise sample was taken for analysis from b g SAMARTH.

Routine sample was taken for analysis from the winner ch g NATURAL LIGHT.

5th Race: 19. The Obligado Trophy – (About) 1200 Metres. Horses rated 60 and above (11 Runners):

Trainer Mr. Mansoor Khan was fined a sum of **Rs.10,000/-** for having entered his charge NATURAL GOLD to run in the above race in an unfit condition. Subsequently permission was granted to him to scratch it from the above race.

PRINCE CORPORATE (K Rajesh) jumped awkwardly inwards and inconvenienced the horses on its inside viz. THE FLYING FEET (M Naveen) and SILVER SPRING (H Rahul), soon after jumping out of the Starting Gates.

Jockey S Antony Raj, the rider of WINTER AGENDA was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race **(1st Infraction)**.

An enquiry is being held into the running of WINTER AGENDA (S Antony Raj), trained by Mr. Vinesh V Naik, in the above Race.

CONSTANT VARIABLE (C Umesh) sustained bruises on both hind plantar fetlock.

Routine sample was taken for analysis from the winner b g DUES EX MACHINA.

6th Race: 20. The Seabiscuit Plate – (About) 1400 Metres. Horses rated 20 to 45, 5 years old and over (9 Runners):

WALTER (S Antony Raj) was extremely fractious inside the gates, ducked down and got cast inside the Starting Stalls for a considerable period of time. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

SARVOTTAM (P P Dhebe) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Rakesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Varun, the rider of BREAK AWAY reported that his mount was not galloping fluently throughout the race and ran detached after passing the 200 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Pratap Kamath M was informed to ensure better performance of his charge in future.

It was observed that KALLANIA (Prabhu Kumar M) ran detached from the field, after passing the 200 Metres. Trainer Mr. K S Mandanna was advised to ensure better performance of his charge in the future.

Routine sample was taken for analysis from the winner b h ABSOLUTE CONQUERER.

7th Race: 21. The Abide Plate – (About) 1200 Metres. Horses rated 20 to 45 (11 Runners):

As Jockey S Mubarak, the declared rider of D LORD was certified medically unfit to ride, permission was granted to Trainer Mr. Bipin V Salvi to substitute Jockey Md. Imran Ashraf to ride D LORD in place of the declared rider.

Trainer Ganesh J was fined **Rs.5,000/-** for the discrepancy in shoeing in respect of his charge DARING FALCON (Bharat Mal) in the above race **(1st infringement)**.

MOONLIGHT SPEED (P P Dhebe) was extremely fractious and refused to be stalled. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

TRUMP BABY (A Ayaz Khan) jumped out awkwardly, at the Start.

Jockey Shankar Lal H, the rider of MARK ONE was fined **Rs.2,000/-** for shifting in and causing interference to TO HOT TO TOUCH (Abhishek Mhatre) on his inside which in turn passed it onto VANDHIYATHEVAN (C Umesh), along the rails, passing the 1000 Metres.

Jockey Shyam Kumar (CHE), the rider of SUPER SEXY was fined **Rs.1,000/-** for shifting in and causing interference to QUEEN STAR (Shreyas Singh), on his inside, approaching the 950 Metres.

GENTLEMAN'S WORD (K Sai Kiran) – Took a fly jump.

ANKUSH (A Ayaz Khan) – Jumped out awkwardly.

5th Race: 19. The Obligado Trophy (About) 1300 Metres:

EXUBERANCE (Ram Nandan Manji) – Was slowly away and lost few lengths

6th Race: 20. The Seabiscuit Plate (About) 1400 Metres :

WALTER (S Antony Raj) – Was permitted to be withdrawn before coming Starters Order, as the gelding was very fractious inside the stall and hind leg got cast for considerable period of time.

SARVOTTAM (P PDhebe) – Was planted and lost many lengths.

7th Race: 21. The Abide Plate (About) 1200 Metres :

MOONLIGHT SPEED (P P Dhebe) – Was withdrawn before coming under Starters Order, as the filly was extremely fractious at the gates and refused to be stalled. The Starting Stall Certificate is revoked.
