EIGHTH DAY, WEDNESDAY, 06th JULY 2022

RACING INCIDENTS

(Race No. 52 - 59)

GOING : Good
Penetrometer Reading : 3.3 Cms
Positioning of Railings : Railings are positioned from 1600 Metres upto the Winning Post with an average width of 3 Metres.

1st Race: 52. The Doddaballapura Plate (About) 1400 Metres. Horses rated 00 to 25 (10 Runners):

Jockey Sarvan Kumar, the rider of SO FAR reported that his mount was extremely fractious in the gates whereby it reared up several times due to which his right rein got entangled and after jumping out he could not offer sufficient assistance to his mount throughout the race. After due examination of the equipment after the race which was found to be in serviceable condition; no action was taken beyond noting the incident.

Jockey S Imran, the rider of TOP RANK was reprimanded for travelling wide from the 700 Metres till rounding the final bend for no apparent reason.

Jockey Akshay Kumar, the rider of SAINT LUCIA reported that his mount was not galloping fluently after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported.

It was observed that INNOVATION (L Alex Rozario) crashed into the railings and collapsed passing the 250 Metres. On immediate examination by the Club's Veterinary Officer it was found to have burst its blood vessels, suffered from cardiac arrest and died.

It was reported after the race that CHARLIE HEBDO (H Zeeshan) burst its blood vessels during the race. Trainer Mr. Vishal Yadav was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

2nd Race: 53. The Shantikoppa Plate (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over (13 Runners):

EWANDOR (K Sai Kiran) was extremely fractious, reared up and flipped over in the gates. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders. In view of its behaviour, Trainer Mr. Vikram Appachu was informed that he must not accept with it again until its

behaviour improved to the satisfaction of the Stipendiary Stewards in **Two Jump Outs** on Starting Gate practice days.

PERCIVALE (H Zeeshan) planted, lost many lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

It was observed that LUCKY POINT (Angad) jumped out awkwardly, throwing its head about whereby the rider got unbalanced and lost his right stirrup which he regained within a few strides, and as such, it lost many lengths at the start. In view of its behaviour, Trainer Mr. Girinath C was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

SCARLET PRINCESS (Siddaraju P) jumped awkwardly inwards and inconvenienced IMPELLING POWER (B Harish), on its inside, soon after jumping out of the Starting gates.

Jockey Vivek G, the rider of COUNTRY'S FLASH was fined **Rs.2,000/-** for drifting out alarmingly and causing interference to AMAZING SAFARI (Arul J H) on his outside passing the 300 Metres.

Jockey Vishal N Bunde, the rider of SPIRITUAL FORCE reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination and on examination of the mouth revealed sharp molars. Trainer Mr. Helleal Moses was fined **Rs.3,000/-** for his negligence (**1st Infringement**).

3rd Race: 54. The Itarsi Plate – Div. II (About) 1400 Metres. Horses rated 20 to 45. No Whip. (9 Runners):

VIJAYA SURABHI (P Kiran Rai) was extremely fractious, dropped the rider and bolted on the way to the starting gates. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

TWIN FLAME (Sarvan Kumar) jumped awkwardly inwards and bumped WHISKEY SOUR (J Paswan) on its inside soon after jumping out of the Starting gates.

It rained heavily after the 3rd Race and as a result, the start of the 4th Race was delayed.

4th Race: 55. The Kemmannugundi Plate (About) 1600 Metres. Horses rated 40 to 65 (9 Runners):

Permission was granted to Trainer Mr. Ashwin S Rao to **withdraw** D LORD (P Sai Kumar) on veterinary grounds as it fell at the saddling yard and got injured on its left hind. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Owing to continuous rain rendering the underfoot conditions of the Race Track not conducive to continue racing, the Stewards decided to cancel the remainder of the Day's Races.

VIJAYA SURABHI (P Kiran Rai) – Was permitted to be withdrawn before coming under Starter's Order as the filly bolted on its way to the Starting Gate.

4th Race: 55. The Kemmannugundi Plate (About) 1600 Metres :

SIXTH DAY, WEDNESDAY, 22nd JUNE, 2022

RACE NO. 40: THE KODLIPET PLATE – (ABOUT) 1400 METRES. FOR HORSES RATED 40 TO 65, 5 YEARS OLD AND OVER:

The Stipendiary Stewards reported Jockey S Imran to the Stewards, vide Charge Sheet No. 285, dated 2nd July, 2022 for breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing [Unsatisfactory Riding], on his mount CHEROKEE MOON, in the above Race; The Stewards, at their meeting held on Wednesday, 6th July, 2022, examined Trainer of the horse, Mr. S. Ramesh and the rider of the horse, Jockey S Imran;

The Stewards considered the following;

- a) The transcripts of evidence dated 24th June, 2022, tendered by Jockey S Imran and Trainer Mr. S Ramesh, before the Stipendiary Stewards;
- b) The Charge Sheet No. 285 dated 2nd July, 2022, issued to Jockey S Imran;
- c) The Submissions made on this day, i.e., 6th July, 2022, before the Stewards by Jockey S Imran and Trainer Mr. S Ramesh;

After repeatedly watching the CCTV footage of the above Race and after due deliberations, the Stewards decided to suspend the Jockey's License granted to Jockey S Imran, **from 16-07-2022 to 10-08-2022** [both days inclusive] for Unsatisfactory Riding [breach of Rule No.161(ii) of the Mysore Race Club Limited Rules of Racing] on his mount, CHEROKEE MOON, in the above Race [He is permitted to ride work and was informed of his right to appeal].

SEVENTH DAY, WEDNESDAY, 29th JUNE, 2022

RACE NO. 51: THE WHITEFIELD PLATE – DIV.I (ABOUT) 1100 METRES. FOR HORSES RATED 20 TO 45:

The Stipendiary Stewards reported Jockey P Kiran Rai to the Stewards, vide Charge Sheet No. 286, dated 2nd July, 2022 for breach of Rule No.161(i) of the Mysore Race Club Limited Rules of Racing [Dangerous Riding], on his mount INFINITEPOSSIBILITY, in the above Race, in that, as a rider of INFINITEPOSSIBILITY, a) He badly shifted in, approaching the 300 Metres, with the use of the whip in his left hand, thereby causing severe interference

to horses on his inside, viz., FLAMINGO DANCER (A Imran Khan), SUPER SEXY (P Ajeeth Kumar) and FLYING FALCON (J H Arul), resulting in a chain reaction and as such, FLYING FALCON (J H Arul) which was galloping along the rails, received a severe interference, had to be checked and pulled out by its rider and make a run on the wide outside, to avoid a bad accident; **b)** Thereafter, in the final 100 Metres, he has continued to use the whip with his left hand, shifted in again and took the ground of FLAMINGO DANCER (A Imran Khan); **c)** He has shown sheer ignorance and utter disrespect towards the safety of his fellow colleagues, throughout the Straight, in the above Race; The Stewards, at their meeting held on Wednesday, 6th July, 2022, examined the rider of the horse, Jockey P Kiran Rai; After repeatedly watching the CCTV footage of the above Race and after due deliberations, the Stewards decided to suspend the Jockey's License granted to Jockey P Kiran Rai, **from 25-08-2022 to 09-09-2022** [both days inclusive] for Dangerous Riding [breach of Rule No.161(i) of the Mysore Race Club Limited Rules of Racing] on his mount, INFINITEPOSIBILITY, in the above Race [He is permitted to ride work and was informed of his right to appeal].
