(Under My. R. C. Rules of Racing)

FIRST EXTRA DAY, WEDNESDAY, 8th FEBRUARY, 2023

RACING INCIDENTS

(Race No. 96 - 102)

Weather : Clear
Track Condition : Good Going
Penetrometer Reading : 2.7 cms
Positioning of Railings : Railings fixed at its original position.

1st Race: 96. The Vesuvius Plate (About) 1400 Metres. Horses rated 20 to 45, 6 years old and over (9 Runners):

AL JAWAAD (Vivek) was extremely fractious while saddling and could not be saddled. Under the circumstances, permission was granted to Trainer Mr. G T Surrender to withdraw it from the above race.

Jockey Koshi Kumar, the rider of SURPRISE PACKAGE was fined **Rs.2,000/-** for shifting in and causing interference to WINTER STORM (P Kiran Rai) on his inside along the rails passing the 350 Metres.

It was observed that D THIRTEEN TWELVE (S John) completely stopped galloping in the final 200 Metres of the race. The horse was impounded for Veterinary examination and on examination by the Club's Veterinary Officer it was reported to have burst its blood vessels. Trainer Mr. Monnappa C D was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that SURPRISE PACKAGE (Koshi Kumar) pulled up lame on left fore. Trainer Mr. Pratap Kamath M was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Surprise Sample was taken for analysis from the winner b m WINTER STORM.

2nd Race: 97. The Nanjangud Plate (About) 1200 Metres. Horses rated 00 to 25 (14 Runners):

Permission was granted to Trainer Mr. Dinesh Pujar to withdraw SHOOTING VENUS (Arshad Alam) on Veterinary grounds as it was found to be trotting lame on right hind due to injury and inflammation. He was informed that he

must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

ENGELBERG (K Mukesh Kumar) took a fly jump.

UDUKAI (Saqlain S) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M Eshwer was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Gate Jump** on a Starting Gate practice day.

It was reported after the race that UDUKAI (Saqlain S) pulled up lame on left fore. Trainer Mr. M Eshwer was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Jockey V R Jagadeesh, the rider of JAGUAR reported that his mount was trying to run out throughout the race. The horse was impounded for Veterinary examination but no abnormality was reported.

THE ARTERY (Afsar Khan) was impounded for Veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m DOMITIA.

3rd Race: 98. The Sriharikota Plate Div II - (About) 1200 Metres. Horses rated 20 to 45 (15 Runners):

MULLINER (Janardhan Paswan) walked out of the gates, did not raise a fluent gallop and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Monnappa C D was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

TWIN FLAME (Angad) planted, lost many lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Vikram Appachu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

Jockey Koshi Kumar, the rider of THE FLYING FEET was fined **Rs.2,000/-** for shifting in and casing interference to FERRETTI (Saqlain S) on his inside soon after jumping out of the Starting Gates.

It was reported after the race that MULLINER (Janardhan Paswan) pulled up lame on left fore. Trainer Mr. Monnappa C D was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

ELEVADO (V R Jagadeesh) sustained gum injury.

O MANCHALI (Likith Appu K G) was impounded for Veterinary examination but no abnormality was reported.

KESARI QUEEN (Darshan Anthony B) was impounded for Veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b f KESARI QUEEN.

4th Race: 99. The Sriharikota Plate Div I - (About) 1200 Metres. Horses rated 20 to 45 (14 Runners):

N R I MILLENIUM (Vivek G) was extremely fractious while loading as a result the bridle snapped at the gates. Under the circumstances it was permitted to be withdrawn before coming under Starter's Orders.

STAR JEWEL (Arshad Alam) jumped out awkwardly, swerved right, did not raise a fluent gallop and lost many lengths at the start. In view of its behaviour, Trainer Mr. Ramesh S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

DALHOUSIE (Salman Khan) planted, lost many lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

It was observed that COUNTRY'S LEGEND (J Paswan) ran detached after passing the 1000 Metres. Trainer Mr. Feroz M Khan was advised to ensure better performance of his charge in future.

GUNDUZ (A Ayaz Khan) sustained gum injury.

Trainer Mr. Ramesh S was charged a condonation fee of **Rs.10,000/-** for the usage of mobile phone in the saddling enclosure (Restricted area) during the saddling of his charge STAR JEWEL (Arshad Alam) in the above race.

5th Race: 100. The MyRC Bookmakers Association Million 2023 (About) 1200 Metres. For Indian horses 4 years old and over (12 Runners):

Permission was granted to Trainer Mr. Pradeep Annaiah to withdraw TOUGH COOKIE (Salman Khan) as it refused to load into the float to travel to Mysore.

HAVELOCK CRUISE (Arshad Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Surender G T was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Gate Jump** on a Starting Gate practice day.

Jockey Imran Chisty, the rider of GOLDEN GUEST was fined Rs.2,000/- for shifting in and causing interference to WILD SPELL (Janardhan Paswan) on his inside which in turn passed it onto MOGUL (Neeraj Rawal) before passing the red marker post.

Jockey Imran Chisty, the rider of GOLDEN GUEST reported that his saddle shifted back soon after the start. After due examination of the equipment which was found to be in serviceable condition, Trainer Mr. M Eshwer (deputizing on behalf of Trainer Mrs. Parvati Byramji) was fined Rs.3,000/- for this lapse.

O HANSINI (Saqlain S) sustained injuries on both hind inter bulbar region.

PRINCE SATSUMA (P Sai Kumar) sustained injury on right fore front hoof wall.

Routine Sample was taken for analysis from the winner b g COOL RIDER.

6th Race: 101. The Mauritius Pearl Plate (About) 1600 Metres. Horses rated 60 and above (15 Runners):

Permission was granted to Trainer Mr. Pratap Kamath M to withdraw TRUST BOND (A Ayaz Khan) on Veterinary grounds as it was found to be trotting awkwardly due to severe sore back. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was observed that Jockey Salman Khan, he rider of SOUND OF CANNON'S had to check his mount to avoid clipping the heels of the front runner NOTORIETY (Angad) and shift out thereby inconveniencing POWER OF KANTARA (Y S Srinath) on his outside approaching the 500 Metres. He was severely cautioned to exercise sufficient control over his mount in the future.

7th Race: 102. The Panaji Plate (About) 1400 Metres. Horses rated 40 to 65 (Runners):

Jockey Saqlain S, the rider of SARVOTTAM reported that his mount was hanging in after entering the straight. The horse was impounded for Veterinary examination but no abnormality was reported.

Permission was granted to Trainer's M/s M Eshwer and S Narredu to deputize on behalf of Trainer M/s Parvati Bramji and Rajesh Narredu respectively who were unable to attend the races.
