RACING INCIDENTS

(Race No. 103 - 109)

Weather : Clear
Track Condition : Good Going
Penetrometer Reading : 2.7 cms
Positioning of Railings : Railings fixed at its original position.

1st Race: 103. The Himalayas Plate (About) 1400 Metres. Horses rated 00 to 25, 6 years old and over (8 Runners):

NEWS MAKER (Sameer Qureshi) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Rakesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Gate Jump** on a Starting Gate practice day.

Jockey Darshan Anthony B was fined **Rs.1,000/-** for not maintaining a straight course thereby allowing his mount to drift out between the 400 Metres and 100 Metres.

It was observed that KING'S COMMAND (Inayat) accidentally brushed the running rails passing the 1000 Metres.

It was reported after the race that CHILLY BREEZE (Koshi Kumar) pulled up lame on left fore. Trainer Mr. Srinivas Babu G was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that PETER RABBIT (M J Gautam Raj Urs) pulled up lame on right fore. Trainer Mr. Ranjeet Shinde was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Surprise Sample was taken for analysis from the winner b m IRONIC HUMOUR.

2nd Race: 104. The Vijayawada Plate - Div II (About) 1600 Metres. Horses rated 20 to 45 (10 Runners):

MASHA (P Kiran Rai) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Girinath C was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

Jockey Inayat, the rider of IMPERIUS was fined **Rs.2,000/-** for shifting in and causing interference to the horses on his inside viz. CITY OF HUSTLE (Vivek G) and SQUANTO (Angad) before passing the red marker post.

Jockey Salman Khan, the rider of MEADOW FLOWER was fined **Rs.3,000/-** for not making sufficient effort in riding out his mount after entering the straight.

MAXIMILIANO (Mukesh Kumar) ran detached from the field after passing the 1000 Metres. Trainer Mr. Monnappa C D was advised to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner ch f IMPERIUS.

3rd Race: 105. The Bird Sanctuary Plate (About) 1200 Metres. Horses rated 20 to 45, 6 years old and over (10 Runners):

Permission was granted to Trainer Mr. Monnappa C D to withdraw VALKYRIE (L Alex Rozario) on Veterinary grounds as it was found to be trotting lame on left fore due to tendonitis. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Jockey Angad, the rider of SWISS TIGRESS was fined **Rs.3,000/-** for not improving position in the early part of the race and for not infusing adequate vigour in riding out his mount after entering the straight.

4th Race: 106. The Vijayawada Plate - Div I (About) 1600 Metres. Horses rated 20 to 45 (10 Runners):

Jockey V R Jagadeesh, the rider of WHITE RIVER reported that his mount was not galloping fluently throughout the race. The horse was impounded for Veterinary examination and on examination by the Club's Veterinary Officer immediately after the race it was reported to have pulled up lame on right fore. Trainer Mr. Vinesh V Naik was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

GREAT HOPE (L Alex Rozario) jumped awkwardly outwards and inconvenienced DEEMED TO FIRE (P Kiran Rai) soon after jumping out of the Starting Gates.

COYOTE GIRL (Inayat) did not get a clear run between the 450 Metres and 350 Metres due to a closely packed field.

Jockey Vivek G, the rider of SAMAY BALWAN reported that his mount was not galloping fluently throughout the race. The horse was impounded for Veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b m N R I PLAN.

5th Race: 107. The Victory Zone Trophy (About) 1200 Metres. For Maiden Indian horses 3 years old only (13 Runners):

Permission was granted to Trainer Mr. M Eshwer to withdraw BRIGHTEST STAR on Veterinary grounds as it was found to be trotting lame on right fore due to shoulder sprain. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

As Jockey Mukesh Kumar, the declared rider of TOM CRUISER was certified medically unfit to ride, permission was granted to Trainer Mr. Helleal R Moses to substitute Jockey P Sai Kumar to ride TOM CRUISER in place of the declared rider.

ANKUSH (Angad) was extremely fractious in the gates, reared up and got cast for a considerable period of time. Under the circumstances it was permitted to be withdrawn before coming under Starter's Orders.

Jockey Janardhan Paswan, the rider of MYSTIC BOND reported that he accidentally lost his whip approaching the 300 Metres.

Jockey Saqlain S, the rider of JANEIRO reported that his mount was running green throughout the race.

ANUSHTUBHA (Likith Appu K G) sustained injury inside right hock joint.

VICTORIANO (V R Jagadeesh) sustained superficial injury on right hock.

Surprise Sample was taken for analysis from the winner b c TOM CRUISER.

6th Race: 108. The Pattadakal Plate (About) 1200 Metres. Horses rated 60 and above (14 Runners):

EDDIE THE EAGLE (R N Darshan) accidentally stumbled at the start.

Jockey Vivek G, the rider of KING T'CHALA reported that he accidentally lost his whip in the final 150 Metres of the race.

It was reported after the race that REVELATOR (R Shiva Kumar) pulled up lame on right fore. Trainer Mr. P C Tejaswi was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f GALLERY QUEEN.

7th Race: 109. The Chitradurga Plate (About) 1200 Metres. Horses rated 40 to 65, 6 years old and over (13 Runners):

As Jockey Chandrashekar M, the declared rider of BLACK COFFEE could not arrive to fulfill his riding engagements due to reasons beyond his control, permission was granted to Trainer Mr. Joseph B Awale to substitute Jockey Tousif Khan to ride BLACK COFFEE in place of the declared rider.

JOHNNY BRAVO (Janardhan Paswan) planted and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Bobby M was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day on the race track.

Jockey Arshad Alam, the rider of LORD COMMANDER was fined **Rs.2,000/-** for shifting in and causing interference to CEFFINA (L Alex Rozario) which in turn passed it onto AMAZING SAFARI (Likith Appu K G) and DEIMUS (Angad) passing the 1000 Metres.

It was reported after the race that TENALI (Mohammed Mushraf) burst its blood vessels during the race. Trainer Mr. Vikram Appachu was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

It was reported after the race that AMAZING SAFARI (Likith Appu K G) pulled up lame on left fore. Trainer Mr. Md. Sajid Qureshi was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

LORD COMMANDER (Arshad Alam) sustained clipped injury on left hind outer bulb of the heel.
