<u>1st Race: 79. The Mangalore Plate (About) 1600 Metres. Horses rated 00</u> to 25 (10 Runners):

Permission was granted to Trainer Mr. Rakesh to **withdraw** RAISE A BUCK (Shamaz Shareef) on veterinary grounds as it was observed to be suffering from colic. He was informed that he must produce a **<u>Fitness Certificate</u>** from the Club's Veterinary Officer before accepting with it again.

PERCIVALE (J Paswan) was not galloping fluently throughout the race and ran detached from the field. The horse was impounded for veterinary examination and it was reported by the Club's Veterinary Officer that had it had sustained 2" diameter bruise behind girth on left chest wall. Trainer Mr. Vishal Yadav, was informed that he must produce a **<u>Fitness Certificate</u>** from the Club's Veterinary Officer before accepting with it again.

Jockey P Sai Kumar, the rider of HERE I COME, reported that he accidentally dropped his whip passing 400 metres.

Jockey Afsar Khan, the rider of THE SIZABLE was reprimanded for exulting before passing the Winning Post.

Jockey Dhanu Singh Deora, the rider of GODS POWER, reported that his saddle shifted in front, passing the 1000 Metres, and as such, he could not offer any assistance to his mount thereafter; After due examination of the equipment, which was found to be in serviceable condition, Trainer Mr. Bobby M was fined a total sum of **Rs.5,000/-** for faulty saddling.

It was reported after the Race that VANDAN (Md. Imran Ashraf) pulled up lame on right fore. Trainer Mr. Rakesh, was informed that he must produce a **<u>Fitness</u> <u>Certificate</u>** from the Club's Veterinary Officer, before accepting with it, again.

Routine Sample was taken for analysis from the winner, b m THE SIZABLE.

2nd Race: 80. The Hampi Plate – Div. II (About) 1400 Metres. Horses rated 20 to 45, 6 years old and over (11 Runners):

WAR SONG (P Kiran Rai) planted and lost many lengths at the start; In view of its behaviour, Trainer Mr. Ramesh S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

It was observed that COORG GENERAL (Salman Khan) was lugging out from 800 metres and after entering the straight, shifted further out and finished the race on the outer part of the Race Track.

VIJAYA SARATHI (B Harish) ran detached from the field throughout the race. Trainer Mr. Ramesh S was informed to ensure better performance of his charge in future.

<u>3rd Race: 81. The Bababudan Giri Plate – Div. II (About) 1100 Metres.</u> <u>Horses rated 40 to 65, 6 years old and over (11 Runners)</u>:

FIRST IMPRESSION (Mohammed Mushraf) jumped awkwardly `outwards' at the start.

Jockey Siddaraju P, the rider of DALLAS was reprimanded for shifting `out' slightly and as such AURELE (R N Darshan) which was travelling directly behind clipped the front runner and stumbled within 50 metres from the start.

<u>4th Race: 82. The Hampi Plate – Div. I (About) 1400 Metres. Horses rated</u> <u>20 to 45, 6 years old and over (9 Runners)</u>:

Permission was granted to Trainer Mr. Bobby M to **withdraw** CODE OF HONOUR (Dhanu Singh Deora) on veterinary grounds as it got hurt in the Stables and was bleeding from both nostrils; He was informed that he must produce a **<u>Fitness</u> <u>Certificate</u>** from the Club's Veterinary Officer before accepting with it again.

SKY STORM (M Rajesh Kumar) took a fly jump at the start.

It was observed that DORNISH (Shamaz Shareef) was not galloping fluently in the initial part of the Race. The horse was impounded for veterinary examination, but, no abnormality was reported.

BLUE BLOSSOM (Mohammed Mushraf) broke down nearing 700 Metres and it was reported by the Club's Veterinary Officer that the horse had sustained a fracture of left fore fetlock. As such, GUIDING FORCE (Anil Bandaal) had to shift `out' to avoid the former and HERODOTUS (B Harish) had to be checked to slow down to avoid striking the front-runner, BLUE BLOSSOM (Mohammed Mushraf). Under the circumstance, the horse BLUE BLOSSOM was euthanized on humanitarian grounds.

An enquiry is being held into the reversal of form of DORNISH (Shamaz Shareef), trained by Mr. G T Surender, the winner of the above Race, as

compared to all its four previous runs, during the Mysore Winter Races 2023-24, where it had run unplaced.

ANALECT (P Kiran Rai) sustained gum injury.

Routine Sample was taken for analysis from the winner, b g DORNISH.

5th Race: 83. The Andolana Trophy – Div. I (About) 1200 Metres. Horses rated 20 to 45 (12 Runners):

D LORD (Kiran Naidu) stumbled while jumping out of the Starting Gates.

Jockey Shreyas Singh, the rider of DAVIDS DELIGHT reported that his mount slightly stumbled approaching the 800 Metres.

ALGOZE (Saqlain S) pulled up lame on right fore; Trainer Mr. M Eshwer was informed that he must produce a **<u>Fitness Certificate</u>** from the Club's Veterinary Officer before accepting with it again.

HIDDEN PLEASURE (P Kiran Rai) sustained cut inside left hind inside cannon.

Routine Sample was taken for analysis from the winner, b g SEOLFOR BULLET.

<u>6th Race: 84. The Sri Kanteerava Narasimharaja Wadiyar Memorial Million</u> (About) 1400 Metres. For Indian 3year old horses foaled in 2021 (5 <u>Runners</u>):

SHE'S UNSTOPPABLE (P S Chouhan) jumped awkwardly `inwards' thereby inconveniencing ALLURING BEAUTY (Shamaz Shareef) and ROADRUNNER (Saqlain S) on his inside at the start.

7th Race: 85. The Bababudan Giri Plate – Div. I (About) 1100 metres. Horses rated 40 to 65, 6 years old and over (9 Runners) :

As Jockey Dhanu Singh Deora, the declared rider of MARCH TO VICTORY, was certified medically unfit to ride after his ride in the Fifth Race, permission was granted to Trainer Mr. Bobby M to substitute Jockey S Saqlain to ride MARCH TO VICTORY, in place of the declared rider.

As Jockey Mohammed Mushraf, the declared rider of the WELLINGTON was certified medically unfit to ride after his ride in the Fourth race and as no suitable rider was available, permission was granted to Trainer Mr. P C Tejaswi to **withdraw** his charge from the above race.

OCHRE (Abhishek Mhatre) jumped out awkwardly at the start.

PERFECT JUSTICE (M Rajesh Kumar) did not raise a fluent gallop soon after jumping out of the Starting Gates.

BLUE ORIGIN (Faiz) sustained gum injury.

<u>8th Race: 86. The Andolana Trophy – Div. II (About) 1200 Metres. Horses</u> rated 20 to 45 (12 Runners):

RUMOUR LADY (Tousif Khan) planted and lost many lengths at the start; In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

Jockey Anil Bandaal, the rider of REAP THE BOUNTY for shifting `in' and thereby, inconveniencing POLAR QUEEN (P Sai Kumar), on his inside, passing 350 metres.

Jockey Shreyas Singh, the rider of ARIGATO was reprimanded for shifting `in' and thereby, inconveniencing RUNNING BOLT (Siddaraju P) on his inside passing 300 metres.

Jockey M Rajesh Kumar, the rider of TOWER QUEST reported that his mount was hanging till entering the straight; The horse was impounded for veterinary examination, but, no abnormality was reported; However, Trainer Mr. Ramesh S was informed to take appropriate corrective measures before accepting with it again.

TENTH DAY, FRIDAY, 6th OCTOBER, 2023

RACE NO. 69: THE JAYACHAMARAJA WADIYAR GOLF CLUB MYSORE 2000 GUINEAS 2023 (GRADE III) (ABOUT) 1600 METRES. FOR 3 YEAR OLD INDIAN HORSES [FOALED IN 2020

The Board of Appeal, at its meeting held on Tuesday,16TH February, considered the Appeal, dated 20th December, 2023 filed by Jockey M Prabhakaran against the decision of the Stewards to suspend his license from **<u>29-12-2023 to 31-03-2024</u>** and if Jockey M Prabhakaran were to apply for grant of a Jockey's License for the year 2024-25, the same shall be suspended from **<u>01-04-2024 to 28-06-2024</u>** (both Days inclusive) for breach of Rule No. 161 (i) of the My.R.C. Ltd., Rules of Racing [Foul Riding], on his mount STAR CONCEPT, in the above Race.

In this connection, the Board considered the following:

a] The Minutes of the Meeting of the Stewards of the Mysore Race Club Limited, held on 28th October and 19th December

b] The written Grounds of Appeal, dated 12th February, 2024 submitted by Jockey M Prabhakaran

c] The oral submissions made by Mr Rakesh, spokesperson for Jockey M Prabhakaran, on this day, Friday, 16th February, 2024;

The Board further examined Jockey M Prabhakaran himself on this day, Friday, 16th February, 2024.

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a] To partially allow the appeal so as to modify the order of the Stewards as follows;

"To suspend the Jockey's License granted to Jockey M Prabhakaran from <u>10-03-2024 to 31-03-2024</u> (both days inclusive). Further, if he were to apply for grant of a Jockey's License to ride under the My.R.C. Ltd., Rules of Racing, for the year 2024-25, the same shall remain suspended from <u>01-04-2024 to 09-06-2024</u> (both days inclusive) for breach of Rule No. 161 (i) of the My.R.C. Ltd., Rules of Racing [Foul Riding], on his mount STAR CONCEPT, in the above Race".

c] To forfeit the deposit of Rs.10,000/- paid by Jockey M Prabhakaran

The relevant Rules of Racing are reproduced below;

<u>Rule No. 161</u>: Any Rider shall be punished either by fine, suspension from riding or by disqualification for such period as teh Stewards may think fit if, in the opinion of the Stewards, :-

(i): The rider of any horse rides in a dangerous, careless, reckless, improper, negligent or foul manner;

The Board authorised Secretary Board of Appeal to issue a detailed order to Jockey M Prabhakaran.

The Board of Appeal, at its meeting held on Friday ,16th February, 2023 considered the Appeal, dated 22nd December, 2023, filed by Trainer Mr. S.Ramesh, against the decision of the Stewards to suspend the Trainer's Licence granted to Trainer Mr. S.Ramesh for the period from <u>29-12-2023 to 31-03-2024</u> (both days inclusive) for breach of Rule No. 114 (b) (i), read with Calendar Notification, under the heading "TRAINERS' AND JOCKEYS' LEAVE OF ABSENCE" and Clause 3 of the Calendar Notification, under the heading, TRAINERS LICENSES [Negligence in the discharge of his duties as a licensed Trainer pertaining to Stable Management] and Rule No 202 (i) of the Mysore Race Club Ltd., Rules of Racing [Improper Practice];

The Board considered the following:

a] The Minutes of the Meeting of the Stewards of the Mysore Race Club Limited, held on 12th December, 2023

b] The written Grounds of Appeal, dated 12th February, 2023 submitted by Trainer Mr. S.Ramesh

c] The oral submissions made by Trainer Mr. S.Ramesh, on this day, Friday, 16th February, 2024;

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a] To partially allow the appeal so as to modify the Order of the Stewards on Trainer Mr S Ramesh as follows;

"To Severely caution Trainer Mr. S Ramesh for his negligence in executing his responsibilities as licensed trainer, pertaining to Stable Management, thereby breaching Rule No. 114 (b) (i), read with Calendar Notification, under the heading "TRAINERS' AND JOCKEYS' LEAVE OF ABSENCE" and Clause 3 of the Calendar Notification, under the heading, TRAINERS LICENSES [Negligence in the discharge of his duties as a licensed Trainer pertaining to Stable Management] read with Rule No 202 (i) of the Mysore Race Club Ltd., Rules of Racing [Improper Practice]".

b] To forfeit the deposit of Rs.10,000/- paid by Trainer Mr. S.Ramesh.

The Board also informed him that such negligence in executing his responsibilities as a licensed trainer will be dealt in a very stringent manner, in future.

The relevant Rules of Racing are reproduced below;

<u>RULE NO. 114</u>

(a) Any person, training a horse in contravention of this Rule, may be warned off the course and then shall be subject to all disabilities specified under the Rules.

(b) In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-

CALENDAR NOTIFICATIONS OF THE MYSORE RACE CLUB LTD., RULES OF RACING, UNDER THE HEADING TRAINERS' AND JOCKEYS' LEAVE OF ABSENSE AND TRAINERS LICENSES;

TRAINERS' AND JOCKEYS' LEAVE OF ABSENSE

All Trainers and Jockey shall first obtain permission from the Stipendiary Stewards when they wish to leave station during the Racing Season.

TRAINERS LICENSES

Clause 3 of the Trainer's License:

To take full responsibility of the horses in his charge and to be responsible to the Stewards of the Club for any irregularities or breaches in the Rules, Regulations or Notices in connection with any of the horses in his charge.

RULE NO. 202:-

The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any dishonest, corrupt, fraudulent, or improper practice or dishonourable action in connection with racing anywhere.

read with Calendar Notification, under the heading CARRYING OF IDENTIFICATION CLOTH WITH NUMBERS ON HORSES WORKING ON THE TRACKS OR ANY PART OF THE PREMISES OF THE RACECOURSE in that, one of his charge, "INEXHAUSTIBLE" had carried a wrong saddle cloth number, when it came out to work on the morning of the 11th of December, 2023.

The Board considered the following:

a] The Minutes of the Meeting of the Stewards of the Mysore Race Club Limited, held on 19th December, 2023

b] The written Grounds of Appeal, dated 13^{th} February, 2024 submitted by Trainer Mr. C Girinath

c] The oral submissions made by his spokesperson and Trainer Mr. C Girinath himself, on this day, Friday, 16th February, 2024;

After consideration of all the above and after detailed deliberations, the Board of Appeal decided as follows:

a] To partially allow the appeal so as to;

b] To modify the Order of the Stewards on Trainer Mr C Girinath as follows;

"If Trainer Mr. C Girinath were to be granted an "A" Trainer's License to Train under the My. R.C. Ltd., for the year 2024-25, the same shall stand suspended from <u>15-05-2024 to 14-06-2024</u> (both days included), for breach of Rule No. 114 (b) (i) of the My.R.C. Ltd., Rules of Racing read with Calendar Notification, under the heading CARRYING OF IDENTIFICATION CLOTH WITH NUMBERS ON HORSES WORKING ON THE TRACKS OR ANY PART OF THE PREMISES OF THE RACECOURSE, in that, one of his charge, "INEXHAUSTIBLE" had displayed a wrong saddle cloth number, when it came out to work on the morning of the 11th of December, 2023'.

c) To fine him a sum of Rs 20,000/- (Rupees Twenty Thousand only) for the above breach in the Rules of Racing and to severely caution trainer Mr. C Girinath to be more careful in future while presenting his charges for Track Work and to present them with the right Track Number, when they turn out for Morning Track Work and that, a repetition of a similar manner of of offence would be dealt with appropriately by the Stewards.

d] To forfeit the deposit of Rs.10,000/- paid by Trainer Mr. C Girinath

The relevant Rules of Racing are reproduced below;

<u>RULE NO. 114</u>

(b) In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards:-

(i) If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing;

CARRYING OF IDENTIFICATION SADDLE CLOTH WITH NUMBERS ON HORSES WORKING ON THE TRACKS OR ANY PART OF THE PREMISES OF THE RACECOURSE:

The Stewards have decided that all horses that are worked at any time on the tracks or any part of the premises of the Racecourse must carry an identification saddle cloth carrying a number. These numbered saddle clothes will be supplied and replaced when necessary by the office. **The two year olds will be supplied with saddle clothes of red background with white numbering, three years old and over with green background with white numbering and all outstation horses with yellow background and black numbering. All numbers allotted will remain in force for the season.**
