1st Race: 61. The Dupont Plate – Div. II (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over, confined to Mysore based horses (9 Runners):

Trainer Mr. Somashekar K (being deputized by Trainer Mr. J S Pillay) was fined **Rs.2,000/-** for not using the declared colors in respect of his charge TOWER QUEST (K Sai Kiran) in the above race. Subsequently emergency colors(All Black) were permitted to be used.

SAFFRON BREEZE (Anil Baandal) jumped out awkwardly and lost few lengths at the start. In view of its behaviour, Trainer Mr. Yogesh R was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

ABNEGATOR (L Alex Rozario) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dhyan Subbaiah K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

SEA OF ADVENTURE (Asirvatham) jumped awkwardly inwards and bumped SECRET SHADOW (Ankit Pal) on its inside soon after jumping out of the Starting Gates.

Jockey S Imran, the rider of BREAK AWAY was fined **Rs.1,000/-** for coming in and causing interference to ANUSHTUBHA (S Antony Raj) on his inside passing the 1100 Metres.

Routine Sample was taken for analysis from the winner dk b g SEA OF ADVENTURE.

2nd Race: 62. The Dupont Plate – Div. I (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over, confined to Mysore based horses (8 Runners):

ONE DIAMOND (Faiz) was permitted to be $\underline{\text{withdrawn}}$ on compassionate grounds.

Jockey Afsar Khan, the rider of THEWHISPERQUIETLY reported that his mount was not galloping fluently throughout the race. The horse was impounded for

veterinary examination but no abnormality was reported. However, Trainer Mr. Majid Khan was informed to ensure better performance of his charge in future.

Jockey S Imran, the rider of AUTHENTIC BELL was fined **Rs.3,000/-** for the undesirable practice of exulting before passing the Winning Post.

An enquiry is being held into the reversal of form and the resultant improved performance of AUTHENTIC BELL, trained by Mr. Ganesh J and ridden by Jockey S Imran, the winner of the above race as compared to its previous run in Race No. 40. i.e The Psychic Strength Plate (about) 1600 Metres, for horses rated 20 to 45 (confined to Mysore based horses) run on Sixth Day, Friday, 19th September, 2025 when ridden by Jockey Akash Agarwal it ran unplaced.

Routine Sample was taken for analysis from the winner b m AUTHENTIC BELL.

3rd Race: 63. The Gool & Soli Poonawalla Memorial Trophy (About) 1400 Metres, For Maiden Indian Horses 3 years old only (12 Runners):

Trainer Mr. Rajesh Narredu (being deputized by Trainer Mr. S Narredu) was fined **Rs.2,000/-** for not using the declared colors in respect of his charge BLIND FAITH (A A Vikrant) in the above race. Subsequently emergency colors (All Black) were permitted to be used.

VIBRANT QUEEN (L Alex Rozario) jumped awkwardly outwards at the Start, thereby inconveniencing TEFILLAH (Vinod Shinde) due to which the latter jumped awkwardly outwards onto COORG HILLS (Neeraj Rawal) which fiercely shied outwards and took out QUEEN MAXIMA (N Tauseef Ahmed) on its outside soon after the start. As the occurrence was accidental no action was taken beyond noting the incident.

Jockey N B Kuldeep, the rider of SALT N PEPPER reported that he accidentally dropped his whip passing the 300 Metres.

It was observed that RAHA (K Sai Kiran) was trying to run out throughout the race and also ran detached from the field after passing the 600 Metres. On immediate examination by the Club's Veterinary Officer after the race it was reported to have burst its blood vessels during the race. Trainer Mr. Bipin V Salvi was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

Jockey H Rahul, the rider of SILVER QUEST reported that his mount was trying to run out after entering the straight. The horse was impounded for veterinary examination and the examination of the mouth revealed sharp molars. Trainer Mr. Vishal Yadav was fined **Rs.3,000/-** for his negligence (1st infringement).

4th Race: 64. The Chief Minister's Cup (About) 1600 Metres. Horses rated 20 to 45 (11 Runners):

CARTER (L Alex Rozario) was extremely fractious inside the gates whereby it reared up and it's right fore leg got stuck in the gates for a considerable period of time. On immediate examination by the Club's Veterinary Officer it was reported to have sustained bleeding cut on right fore fetlock. Under the circumstances it was permitted to be **withdrawn** on veterinary grounds before

coming under Starter's orders. Trainer Mr. Md. Sajid Qureshi was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

MONEY EXCHANGE (A Ayaz Khan) was slowly away and lost many lengths at the start. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Akshay Kumar, the rider of POWER OF GOLD reported that his mount was not galloping fluently after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported.

MONEY EXCHANGE (A Ayaz Khan) sustained bleeding injury on right fore pastern.

Surprise Sample was taken for analysis from b g POWER OF GOLD.

5th Race: 65. The Hotel R R R Trophy (About) 1200 Metres. Horses rated 40 to 65 confined to Mysore based horses (12 Runners):

Jockey Faiz, the rider of OCEAN was fined **Rs.3,000/-** for coming in sharply and causing interference to LIKE MY CHILD (Vinod Shinde) on his inside which in turn passed it onto SPARKLING NIGHT (Pavan) along the rails before passing the **Red Marker Post**.

Jockey Vinod Shinde, the rider of LIKE MY CHILD was fined **Rs.1,000/-** for shifting out and taking out MARENAD BEAUTY (L Alex Rozario) which in turn took out SPARKLING NIGHT (Pavan) on its outside approaching the 250 Meters.

The Stewards ordered and held an enquiry with particular reference to the fall of Jockey Aleemuddin, the rider of THALAIVAA in the above race. The Stewards observed that THALAIVAA (Aleemuddin) had clipped the heels of the runner in front of it, viz., O MANCHALI (Rajesh K) thus dislodging its rider. The Stewards examined Jockey Aleemuddin and Jockey Rajesh K, the rider of O MANCHALI. After repeatedly viewing the CCTV replay of the above race, taking into consideration the explanations tendered by both the Jockeys and after due enquiry and detailed discussion, the Stewards, noting that the incident was purely accidental, decided not to alter the placings as declared by the Judge.

SWAGHATHAM (H Rahul) sustained bruise on right hind back of fetlock.

LIKE MY CHILD (Vinod Shinde) sustained injuries on right hind hock and cannon and left hind fetlock.

SHERPA (Anil Baandal) sustained bruises on both hind back of fetlock.

6th Race: 66. The Coorg Plate(About) 1100 Metres. Horses rated 40 to 65, 5 years old and over (8 Runners):

Permission was granted to Trainer Mr. Faraz Arshad to <u>withdraw</u> SOUTHERN FORCE (N Arvind Kumar) on veterinary grounds as it was found to be trotting lame due to right capped elbow. He was informed that he must produce a

<u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with again.

Jockey Vinod Shinde, the rider of GOLDEN TIME reported that his mount was hanging in throughout the race. Trainer Mr. Lokanath V was informed to take appropriate corrective measures before accepting with it again.

It was reported after the race that WORDS WORTH (B Darshan Anthony) apparently lost its left foe shoe during the race.

Permission was granted to trainers M/s Ranjeet Shinde, Mansoor Khan, Pillay J, S Lokanath V and S Narredu to deputise on behalf of Trainers, M/s Srriram Komandur, M Eshwer, Somashekar K, Prasanna Kumar P and Rajesh Narredu respectively who were unable to attend the Day's Races.

After due deliberations and after repeatedly viewing the CCTV replay of the above Race, having taken into consideration the submissions made by Jockey Antony Raj S and the Trainer of the horse, Mr. Dominic S before them and the submissions made by them before the Stipendiary Stewards on 19th September, 2025 and acting on their own observations, the Stewards decided as follows;

- **a)** To fine Jockey Antony Raj S <u>a sum of Rs.50,000/- (Rupees Fifty Thousand only)</u> for breach of Rule No. 161 (ii) of the Mysore Race Club Ltd., Rules of Racing, [Unsatisfactory Riding] pertaining to his riding, on his mount JERSEY KING, in the above Race;
- **b)** To caution Jockey Antony Raj S that they, the Stewards after having taken into consideration the fact that he has been riding extremely well with a lot of success in races all over the country, he was given the benefit of a grave doubt. He was also cautioned that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;
- c) To accept the explanations tendered by Trainer Mr. Dominic S.

Jockey Antony Raj S was informed that he is permitted to ride work and was also informed of his Right to Appeal.

- **a)** To fine Trainer Mr. Ranjeet Shinde <u>a sum of Rs.25,000/- (Rupees Twenty Five Thousand only)</u> for breach of Rule No. 114 (b) (i) of the Mysore Race Club Ltd., Rules of Racing, [Negligence in the discharge in the discharge of his duties as a Licensed Trainer] pertaining to the reversal of form, inconsistent running and the resultant improved performance of his charge ECO SYSTEM, the winner of the above Race as compared to its previous run in Race No. 23 of the Mysore Monsoon Races 2025, run on 4th Day, Friday, 12th September, 2025 when ridden by Jockey N Ramesh Kumar, it ran unplaced;
- **b)** To caution Trainer Mr. Ranjeet Shinde to be more judicious in the future running of his charges and that the Stewards, after having taken into consideration the fact that he was not a habitual offender, he was being given the benefit of a grave doubt. He was also cautioned that a repetition of a similar manner of offence in future would entail severe action against him by the Stewards;

Trainer Mr. Ranjeet Shinde was informed of his Right to Appeal.

Ltd., Rules of Racing, for the year 2025-26, for 4 Mysore Race Days, i.e., on 25th October, 2025, 26th October 2025 and the first two Race Days of the Mysore Winter Races 2025-26, (the dates shall be confirmed later), for breach of Rule No. 161 (ii) of the Mysore Race Club Ltd., Rules of Racing, [Unsatisfactory Riding] pertaining to his riding, on his mount JANNAT, in the above Race;

- **b)** To caution Jockey Varun that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;
- c) To accept the explanations tendered by Trainer Mr. Himanshu.

EIGHTH DAY, FRIDAY, 26th SEPTEMBER 2025

RACE NO. 50: THE MAJ. SARDAR L MAHADEVAIAH MEMORIAL TROPHY (ABOUT) 1200 METRES. HORSES RATED 40 TO 65 CONFINED TO MYSORE BASED HORSES:

Trainer Mr. Ranjeet Shinde and Jockey A Ramu were questioned by the Stipendiary Stewards pertaining to the running and riding of SQUARE CUT, in the above Race. The Trainer stated as follows;

- a). He had told his rider that his charge SQUARE CUT does not have initial speed;
- **b)** He had instructed his rider to take a good jump and settle it wherever he is comfortable, to pull it out in the straight and to ride it out;
- **c)** His rider had done so and despite his efforts to ride it out in the straight, it could only improve to finish 5th, about 7 lengths from the winner;
- d) He was satisfied with the way his charge was ridden by Jockey A Ramu.

Jockey A Ramu corroborated the statements of Trainer Mr. Ranjeet Shinde. Their explanations were noted for future reference.

RACE NO. 53: THE HAVERI PLATE (ABOUT) 1200 METRES. HORSES RATED 40 TO 65, 5 YEARS OLD AND OVER CONFINED TO MYSORE BASED HORSES:

Trainer Mr. Ranjeet Shinde was questioned by the Stipendiary Stewards pertaining to the relative improved performance of BORN DANCER [Shyam Kumar (CHE)], the winner of the above race as compared to its previous run in Race No. 59 of Mysore Summer Races 2025, i.e., The Mudigere Plate (About) 1400 Metres for horses rated 20 to 45 (No Whip), run on Wednesday, 16th July 2025, when ridden by Jockey N Ramesh Kumar it ran unplaced. The Trainer stated as follows;

- **a)** This horse came to him on 20th August 2025 and that this was its first run under him;
- **b)** Its earlier run was under Trainer Ganesh J;
- **c)** He had given it ample rest and time to settle down and had chosen this race which was run over 6 furlongs and a higher class, as compared to the previous run which was run over 7 furlongs;
- **d)** He chose to run it in this class to take advantage of the bottom weight; e) He had fancied his charge to run a good Race and at least finish within the 1,2,3 in this set so he had instructed his rider to go to the front and to ride out in the Straight, but he did not think that his charge could win the Race, but with 200 Metres less to run, his charge ran very well and won the above Race quite comfortably.

His explanations were noted.
