RACING INCIDENTS

(Race No. 70 - 75)

Weather : Cloudy
Track Condition : Good Going
Penetrometer reading : 2.9Cms.
Positioning of Railings : Railings are positioned from 1600 Metres upto the Winning Post with an average width of 7 metres from its original position.

1st Race: 70. The Lalithamahal Plate (About) 1100 Metres. Horses rated 00 to 25, confined to Mysore based horses (11Runners):

As Mukesh Kumar K, the declared rider of ARIGATO, was certified medically unfit to ride and as no suitable rider was available to ride, permission was granted to Trainer, Mr. Helleal Moses to **withdraw** his charge, ARIGATO, from the above race.

ICE ON FIRE (Akimasa Phanthura) planted and lost many lengths at the Start; In view of its behaviour, Trainer Mr. Pratap Kamath was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

CALIFORNIA GOLD (Arvind Kumar N) sustained gum injury.

Routine Sample was taken for analysis from the winner, b g COUNTRY'S LIGHT.

2nd Race: 71. The Lokapavani Plate (About) 1400 Metres. Horses rated 20 to 45, [No whip], confined to Mysore based horses (12 runners):

Permission was granted to Trainer Mr. Pratap Kamath M to substitute Jockey Akash Agarwal to ride COYOTE GIRL in place of Jockey Dhanu Singh Deora, the declared rider.

It was reported after the Race that THE GOLDEN SUNRISE (S Imran) had apparently lost its left fore shoe, during the race.

It was reported after the Race that DALI'S GOLD (Salman Khan) had apparently lost both its fore shoes, during the race.

REAL LEGEND (P Kiran Rai) sustained small cut on left fore outer fetlock.

3rd Race: 72. The Sri Kanteerava Narasimharaja Sports Club Trophy (About) 1400 Metres. Horses rated 40 to 65, (9 runners):

Permission was granted to Trainer Mr. Joseph B Awale to substitute Jockey Alex Rozario L to ride HAND OF GOD in place of Jockey Mukesh Kumar K, the declared rider.

Permission was granted to Trainer Mr. Aditya K to substitute Jockey S Imran to ride MY LIFE MY RULES in place of Jockey Dhanu Singh Deora, the declared rider.

HIS EMINENCE (M J Gautam Raj Urs) jumped awkwardly `inwards' thereby inconveniencing IGNORANCE IS BLISS (Abhishek Mhatre), on his inside, at the start.

SHEROUK (A Sandesh) jumped awkwardly `inwards' thereby inconveniencing HIS EMINENCE (M J Gautam Raj Urs), on his inside, at the start.

Jockey Angad the rider of BENGHAZI was fined **Rs.3,000/-** for not infusing sufficient effort to ride out is mount after entering the straight.

HAND OF GOD (Alex Rozario L) drifted out alarmingly after entering the straight and despite the efforts of the rider, cut across ASHWA VEDHA (Vinod Shinde) and finished the race on the outer portion of the Race track. Trainer Mr. Joseph B Awale was informed to take appropriate remedial measures before accepting with it, again.

SHEROUK (A Sandesh) was endoscoped after the last Race and was reported to have suffered from Grade III EIPH. Trainer Mr. Pillay J S was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner, b f ASHWA VEDHA.

4th Race: 73. The Mysore Dasara Sprint Championship 2024 (Grade II)(About) 1200 Metres. For Indian horses 3 years old and over (8 Runners):

As Jockey Saqlain S, the declared rider of O HANSINI, could not arrive to fulfill his riding engagements for the day due to reasons beyond his control, permission was granted to Trainer Mr. Rakesh to substitute Jockey J Paswan to ride O HANSINI in place of the declared rider.

Permission was granted to Trainer Mr. Helleal Moses to substitute Jockey Koshi Kumar to ride TOM CRUISER in place of Jockey Mukesh Kumar K, the declared rider.

Jockey Angad, the rider of AMRELI, was fined **Rs.2,000/-** for repeatedly shifting in and causing interference to O HANSINI (J Paswan), on his inside, between the 450 Metres and the 250 Metres.

Jockey Vinod Shinde the rider of POLISHED GIRL was fined **Rs.3,000/-** for shifting `in' and causing interference to ALDGATE (S Antony Raj) on his inside passing 400 metres of the race.

5th Race: 74. The Urs Kar Trophy (About) 1200 Metres. Horses rated 60 and above (8 Runners):

Permission was granted to Trainer, Mr. Rakesh to **withdraw** BRAVE TROOPER (Saqlain S) from the above race, as there was no suitable rider available to ride his charge, in place of the declared rider.

Permission was granted to Trainer Mr. Joseph B Awale to substitute Jockey L Alex Rozario to ride VIJAYA FALCON in place of Jockey Mukesh Kumar K, the declared rider.

ABSOLUTECHALLENGER (Md. Imran Ashraf) jumped awkwardly `outwards' at the start.

PRINCE CORPORATE (Abhishek Mhatre) accidentally brushed the railings approaching the 1000 Metres.

6th Race: 75. The Triveni Plate (About) 1200 metres. Horses rated 40 to 65, 5 years old and over, confined to Mysore based horses (8 Runners):

Permission was granted to Trainer Mr. Helleal Moses to substitute Jockey Koshi Kumar to ride SPIRITUAL FORCE in place of Jockey Mukesh Kumar K, the declared rider.

Permission was granted to Trainer Mr. Md. Sajid Qureshi to substitute Jockey S Antony Raj to ride N R I TOUCH in place of Jockey Saqlain S, the declared rider.

Jockey Koshi Kumar the rider of SPIRITUAL FORCE was fined **Rs2,000/-** for shifting `out' and causing interference to N R I TOUCH (S Antony Raj) on his outside passing the 350 Metres.

Jockey Abhishek Mhatre the rider of PROUD reported that his mount was not galloping fluently. Trainer Mr. Ranjeet Shinde was informed to ensure better performance of his charge, in future.

SARO GOLD MINE (L Alex Rozario) ran detached from the field throughout the Race. Trainer Mr. Somashekar K was informed to ensure better performance of his charge, in future.

Routine Sample was taken for analysis from the winner, b m MIRACULOUS GIRL.

Permission was granted to Trainer Mr. Rajesh Narredu to deputise on behalf of Trainer Mr. S Narredu, who could not attend the Day's Races.
