### 1<sup>st</sup> Race: 22. The Bidadi Plate (About) 1600 Metres. Horses rated 20 to 45 (7 Runners):

Routine Sample was taken for analysis from the winner, b f SAPIENT.

It started to rain steadily during the Race and post the above Race and continues to do so.

# 2<sup>nd</sup> Race: 23. The Arakalgudu Plate (About) 1200 Metres. For Maiden Indian Horses 3 years old only (10 Runners):

The start of the 2<sup>nd</sup> race was delayed due to heavy rain that began shortly before the scheduled start time.

NATURAL LOOK (Ankit Pal) was slowly away, did not raise a fluent gallop, thereby losing many lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

COSETTE (A Ashhad Asbar) drifted out after rounding the final bend and completed the race on the outer portion of the grass track.

ZILFEE (H Rahul) drifted out after rounding the final bend and completed the race on the outer portion of the grass track.

Jockey A Ashhad Asbar, the rider of COSETTE was fined **Rs.3,000/-** for excessive use of the whip on his mount during the Race **[First infringement].** 

### 3<sup>rd</sup>Race: 24. The Chaitanya Chakram Plate (About) 1200 Metres. Horses rated 00 to 25, 5 years old and over (9 Runners):

Jockey H Rahul, the rider of NATURAL FLY was reprimanded for dropping hands in the final 100 metres of the race.

Routine sample was taken for analysis from the winner, b m GOLDEN BIRD.

### 4<sup>th</sup>Race: 25. The Kollegal Plate - Div. I (About) 1200 metres. Horses rated 40 to 65, No Whip (8 Runners):

SQUARE CUT (Bharat Mal) was slowly away and lost few lengths at the Start. In view of its behaviour, Trainer Mr. Santosh S Rao was informed not to accept with it again, until its behaviour improved to the satisfaction of the Stipendiary Steward in **One Jump Out** on a Starting Gate Practice Day.

# 5<sup>th</sup>Race: 26. The Dr. N M Srinivas Memorial Trophy(About) 1400 metres. Horses rated 60 and above (11 Runners):

KONTTY PATTON (A Sandesh) was very fractious and did not cooperate to fasten the Tongue Strap. Under the circumstances permission was granted to Trainer Mr. Purshotham to **withdraw** KNOTTY PATTON (A Sandesh) from the above Race.

D GOLD STAR (R Shiva Kumar) reared up as the gates opened and lost many lengths and, thereafter, it ran detached from the field; In view of its behaviour, Trainer Mr. Rakesh [Deputising on behalf of Trainer Mr. Vishal Yadav] was informed not to accept with it again, until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

KANYA RASHI (S Antony Raj) took a fly jump at the Start.

Due to the inclement weather (Steady rains) and diminishing light, the Stewards of the Mysore Race Club Ltd., decided to cancel the last two races of the Day, i.e., 6<sup>th</sup> Race and 7<sup>th</sup> Race.
