<u>1st Race: 15. The Squanderer Plate – Div. II (About) 1100 Metres.</u> <u>Horses rated 00 to 25 (12 Runners)</u>:

D UNITED (Angad) knuckled at the Start.

Jockey Dhanu Singh Deora the rider of EPSOM DOWNS was fined **<u>Rs.2,000/-</u>** for shifting `in' and causing interference to D UNITED (Angad) on his inside at the Start.

Jockey Abhishek Mhatre the rider of MEGHANN reported that his saddle shifted in front within 50 metres from the Start, and as such, he could not offer any assistance to his mount thereafter; After due examination of the equipment, which was found to be in serviceable condition, Trainer Mr. Warren Singh was fined **Rs.3,000/-** for faulty saddling.

Jockey Afsar the rider of CHIRAAG was reprimanded for shifting `out' and inconveniencing THE ANGEL POWER (Afsar Khan) and BURST OF BLAZE (P Sai Kumar), on his outside, passing the 800 Metres.

Jockey K Sai Kiran, the rider of GENTLEMAN'S WORD, was fined **<u>Rs.2,000/-</u>** for shifting out and taking out CHIRAAG (Afsar), on his outside, between the 800 Metres and the 700 Metres.

It was reported after the Race that MIGHTY PRINCE (Salman Khan) pulled up lame on right fore. Trainer Mr. Helleal Moses R was informed that he must produce a **<u>Fitness Certificate</u>** from the Club's Veterinary Officer before accepting with it again.

JUST BLUES (R Shiva Kumar) sustained bleeding cut on right fore outer cannon.

<u>2nd Race: 16. The Shivakashi Plate (About) 1200 Metres. Horses rated</u> <u>00 to 25, 5 years old and over confined to Mysore based horses (12</u> <u>Runners)</u>:

Trainer, Mr. Bipin V Salvi was fined <u>Rs.5,000/-</u> for discrepancy in shoeing with respect to his charge, ELEVADO (A R Pradeep) [1st Infringement].

Jockey G Manikandan the rider of MIRACLE HONEY was fined **Rs.1,000/-** for shifting `out' and causing interference to CZAREVITCH (M J Gautam Raj Urs) on his outside soon after the Start.

Jockey Dhanu Singh Deora the rider of SHOOTING VENUS reported that his saddle shifted in front over the wither in the final 800 metres of the race, and as such, he could not offer any assistance to his mount thereafter; After due examination of the equipment, which was found to be in serviceable condition, and this being the second offence during the season, Trainer Mr. Dinesh Pujar was fined **Rs.5,000/-** for faulty saddling.

Jockey K Sai Kiran the rider of SQUARE CUT reported that his mount was not galloping fluently rounding the bend and after entering the straight. The horse was impounded for veterinary examination, but no abnormality was reported. However, Trainer Mr. Santosh Rao S was informed to ensure better performance of his charge, in future.

It was reported after the Race that EVERLY (P Kiran Rai) burst its blood vessels. Trainer Mr. Vikram Appachu was informed that he must produce a **<u>Fitness</u>** <u>**Certificate**</u> from the Club's Veterinary Officer before accepting with it again.

ELEVADO (A R Pradeep) was found to have bruises on both hind back of fetlock.

Routine Sample was taken for analysis from the winner b m SUPER SEXY.

Surprise Sample was taken for analysis from b g SQUARE CUT.

<u>3rd Race: 17. The Squanderer Plate – Div. I (About) 1100 Metres.</u> <u>Horses rated 00 to 25 (12 Runners)</u>:

CROISSANTINO (Ikram Ahmed) was slowly away, did not raise a fluent gallop, soon after jumping out of the Starting Gates and lost few lengths at the Start and thereafter, it ran detached from the field; In view of its behaviour, Trainer Mr. Kishan Thomas was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in <u>One</u> <u>Jump Out</u> on a Starting Gate Practice Day.

Routine Sample was taken for analysis from the winner dk b g CELERIO.

<u>4th Race: 18. The Dennis & Yvonne Jarvis Memorial Trophy – Div. I</u> (About) 1200 Metres. Horses rated 20 to 45. No whip (11 Runners):

It was reported that GILDED BUTTERFLY (Mohammed Mushraf) was extremely fractious inside the Stalls and as such, the Stirrup iron broke. Under the circumstances, it was permitted to be **withdrawn**, before coming under Starter's Orders.

KOALA (Brahmmesh S) jumped awkwardly `outwards' at the Start.

NATURAL HUNTER (Rajesh K) accidentally brushed the railings between 1100 metres & 1000 metres of the race.

KOALA (Brahmmesh S) accidentally brushed the railings approaching 1000 metres of the race.

Jockey L Alex Rozario the rider of SAINT EMILION was reprimanded for shifting `out' and inconveniencing EMERALD QUEEN (Abhishek Mhatre), on his outside, between the 400 Metres and the 300 Metres of the race.

Jockey Faiz the rider of FLYING FALCON was reprimanded for shifting `out' and inconveniencing EMERALD QUEEN (Abhishek Mhatre) on his outside in the last 100 metres of the race.

SAINT EMILION (L Alex Rozario) sustained bruise on right hind fetlock.

It was reported after the Race that RISING SUN (M Rajesh Kumar) had apparently lost its right fore shoe during the race and also was reported to have sustained clipped injury on left fore inner bulb of heel.

Surprise Sample was taken for analysis from the winner b m SAINT EMILION.

5th Race: 19. The M S Suresh Memorial Trophy (About) 1400 Metres. Horses rated 40 to 65 (8 Runners):

Permission was granted to Trainer Mr. C D Monnappa, to **withdraw** his charge D FRONX (Koshi Kumar) on compassionate grounds, from the above Race.

Jockey Mr. M Chandrashekar the declared rider of MAGIC CIRCLE, was fined **Rs.2,000/-** for not making the declared weight at the scales; Under the circumstances, permission was granted to Trainer Mr. Bipin V Salvi to substitute Jockey G Manikandan to ride MAGIC CIRCLE, in place of the declared rider.

Jockey G Manikandan, the rider of MAGIC CIRCLE, complained of giddiness, behind the Starting Gates and was certified medically unfit to ride the above Race. Under the circumstances, MAGIC CIRCLE was permitted to be **withdrawn**, before coming under the Starter Orders of the above Race.

HIS EMINENCE (M J GautamRajUrs) did not raise a fluent gallop soon after jump out of the Starting Gates; In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in <u>One Jump Out</u> on a Starting Gate Practice Day.

TERMINATOR (V R Jagdeesh) was slowly away and lost few lengths at the Start; In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey K Sai Kiran, the rider of DYNAMIC FORCE, was fined **<u>Rs.2,000/-</u>** for shifting 'in' and causing interference to TERMINATOR (V R Jagdeesh), on his inside, in the last 150 metres of the race.

IGNORANCE IS BLISS (Abhishek Mhatre) sustained cut inside left fore arm.

Routine Sample was taken for analysis from the winner ch g DABEET.

<u>6th Race: 20. The Dennis & Yvonne Jarvis Memorial Trophy – Div. II</u> (About) 1200 Metres. Horses rated 20 to 45. No whip (12 Runners):

Jockey Vivek G the rider of NATURAL LIGHT, reported that his mount was inclined to run out throughout the race. The horse was impounded for veterinary examination, but no abnormality was reported. However, Trainer Mr. Mansoor Khan was informed to take appropriate corrective measures before accepting with it again.

<u>7th Race: 21. The Dennis & Yvonne Jarvis Memorial Trophy – Div. III</u> (About) 1200 Metres. Horses rated 20 to 45. No whip (12 Runners):

ARMAMENT (M J Gautam Raj Urs) was slowly away and lost few lengths at the Start; In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

NOBLE PURSUIT (Brahmmesh S) jumped awkwardly `outwards' at the Start.

RUN HAPPY RUN (S Imran) drifted out alarmingly in the Start and despite the efforts of the rider to keep it on a straight course, the horse further drifted and completed the the race on the outer Sand Track; Trainer Mr. Ruban P was informed to take appropriate corrective measures before accepting with it again.

Jockey M J Gautam Raj Urs, the rider of ARMAMENT, was fined **<u>Rs.2,000/-</u>** for shifting 'in' and causing interference to SEA GOD (V R Jagdeesh) on his inside passing the 200 Metres of the above race.

ADDITIONAL REPORT

MYSORE WINTER RACES 2023-24

ORDER OF THE STEWARDS

The Stipendiary Stewards reported Trainer Mr. M Eshwer to the Stewards, vide Charge Sheet No. 332, for breach of Rule No. 114 (b) (i) read with Calendar Notification under the heading "CARRYING OF IDENTIFICATION CLOTH WITH NUMBERS ON HORSES WORKING ON THE TRACKS OR ANY PART OF THE PREMISES OF THE RACE COURSE", in that, as a Licensed Trainer, he has brought in his charge BRYSON (Original Track No. 185) by sporting the wrong saddle Cloth Number (No. 200), proceeded a few metres and returned, at 6.15 am, on 16th January, 2024.

The Stewards, at their meeting held at the Board Room of the Club, on 12th September, 2024, considered the Charge Sheet No. 332 and examined the Trainer concerned, Mr. M Eshwer. After due enquiry and after detailed discussions, the Stewards decided as follows;

a) To fine Mr. M Eshwer as sum of **Rs.30,000/- (Rupees Thirty Thousand only)** for his negligence in bringing in one of his charge BRYSON, into the Track by sporting the wrong Saddle Cloth Number, thus breaching Rule No. 114 (b) (i) read with Calendar Notification under the heading "CARRYING OF IDENTIFICATION CLOTH WITH NUMBERS ON HORSES WORKING ON THE TRACKS OR ANY PART OF THE PREMISES OF THE RACE COURSE";

b) To caution him to be very careful while saddling his charges for morning Track Work in future and that the very fact that the mistake was noticed by his stable employees very early and taken the horse back to change the Number Cloth, before it went out for work, saved him from an even bigger punishment.

He was informed of his right to appeal.
