1st Race: 01. The Nanjangud Plate (About) 1200 Metres. Horses rated 00 to 25 (12 Runners):

Permission was granted to Trainer Mansoor Khan to use the Emergency Colours All Black in respect of his charge CLYDE STAR (Ankit Pal) in the above race.

BOLD AND BEAUTIFUL (Salman Khan) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey M Prabhakaran, the rider of PEARL OF MYSORE was reprimanded for shifting out and inconveniencing GENTLEMAN'S WORD (Shyam Kumar) on his outside soon after the start.

Jockey Ankit Pal, the rider of CLYDE STAR was reprimanded for shifting in and inconveniencing EIFFEL TOWER (Koshi Kumar) on his inside soon after the start.

Jockey Ankit Pal, the rider of CLYDE STAR was fined **Rs. 3,000/-** for shifting in and causing interference to EIFFEL TOWER (Koshi Kumar) on his inside which in turn passed it onto GLEAM BELL (J Paswan) on its inside approaching the 600 Metres.

Jockey B Darshan Anthony, the rider of CITY OF HUSTLE was reprimanded for exulting before passing the winning post.

It was reported after the race that GLEAM BELL (J Paswan) burst its blood vessels during the race. Trainer Mr. Pillay J S (deputizing for Trainer Mr. K Somashekar) was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

It was reported after the race that EYE THE MIND (Abhishek Mhatre) pulled up lame on right fore. Trainer Mr. Ranjeet Shinde was informed that he must produce a <u>Fitness Certificate</u> from the Club's veterinary Officer before accepting with it again.

It was reported after the race that EIFFEL TOWER (Koshi Kumar) pulled up lame on left fore. Trainer Mr. P Ruban was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

ARIANNE (Ganesh Shingade) sustained bleeding injury inside left stifle.

The Stipendiary Stewards reported Jockey Koshi Kumar to the Stewards, vide Charge Sheet No. 387 dated 19th November, 2025, for breach of Rule No. 161 (i) of the Mysore Race Club Ltd., Rules of Racing, [Foul Riding] pertaining to his riding, on his mount EIFFEL TOWER, trained by Mr. Ruban P, in the above Race. The Stewards held an enquiry immediately after the last race on 19th November, 2025, and examined Jockey Koshi Kumar and the Trainer of the horse, Mr. Ruban P.

After due deliberations and after repeatedly viewing the CCTV replay of the above Race, having taken into consideration the submissions made by Jockey Koshi Kumar and the Trainer of the horse, Mr. Ruban P before them and acting on their own observations, the Stewards unanimously decided as follows;

- **a)** To suspend the Jockey's License granted to Jockey Koshi Kumar under the My.R.C. Ltd., Rules of Racing from **29/11/2025 to 28/2/2026 (both days inclusive)** (**not permitted to ride work)** for breach of Rule No. 161 (i) of the Mysore Race Club Ltd., Rules of Racing, [Foul Riding] pertaining to his riding, on his mount EIFFEL TOWER, in the above Race;
- **b)** To caution Jockey Koshi Kumar that they, the Stewards, after having taken into consideration the fact that he has admitted to the breach of the above Rule and the Charges, they have taken a lenient stand. He was further cautioned that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;
- c) To accept the explanations tendered by Trainer Mr. Ruban P.

Jockey Koshi Kumar was informed of his Right to Appeal.

2nd Race: 02. The Big Deal Plate (About) 1400 Metres. Horses rated 20 to 45, 5 years old and over (12 runners):

It was observed that FLYING FALCON (B Darshan Anthony) dropped back alarmingly after being very prominent in the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Bipin V Salvi was informed to ensure better performance of his charge in future.

Routine Sample was taken for analysis from the winner b m GOLDEN BIRD.

3rd Race: 03. The Fantasy Dream Plate – Div.II (About) 1200 Metres. Horses rated 20 to 45 (12 runners):

BALAHAKA (Koshi Kumar) and MAJOR SAAB (R Shiva Kumar) jumped awkwardly outwards at the start.

Jockey Afsar Khan, the rider of GOLDEN STRIDE reported that his mount was hanging out rounding the final bend. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Surender G T was informed to take appropriate corrective measures before accepting with it again.

Routine sample was taken for analysis from the winner, b g BALAHAKA.

4th Race: 04. The S M Attaollahi Memorial Trophy (About) 1200 Metres. Horses rated 40 to 65 (12 runners):

SHEEBA (S G Prasad) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Feroz M Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

LADYLION (A R Pradeep)planted for a while and later bucked around throwing the Jockey off the saddle and thereafter ran on rider-less In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

LITTLE MINISTER (S Imran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Ganesh J was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

An enquiry is being held in to the reversal of form and the resultant improved performance of MANDOLIN, trained by Mr. Helleal R Moses and ridden by Jockey S Sachin, the winner of the above race as compared to its previous run in Race No. 78 otthe Mysore Monsoon Races 2025, i.e The Original Vel Racing Trophy – Div I (about) 1200 Metres, for horses rated 40 to 65, 5 years old and over, when ridden by Jockey Noorulla it ran unplaced.

Routine Sample was taken for analysis from the winner ch g MANDOLIN.

5th Race: 05. The Rajyotsava Plate (About) 1400 Metres. For horses rated 60 and above (11 runners):

SPECTACULAR (B Darshan Anthony) was permitted to be <u>withdrawn</u> on veterinary grounds as it was found have sustained injury on left hind pastern when examined by the Club's Veterinary Officer at the Saddling Enclosure. Hence Trainer Mr. Aditya K was fined <u>Rs.10,000/-</u> by the Stewards for bringing his charge SPECTACULAR (B Darshan Anthony) to run in the above Race in an unfit condition. He was informed that he must produce a <u>Fitness</u> <u>Certificate</u> from the Club's Veterinary Officer before accepting with again.

D GOLD STAR (K Sai Kiran) reared up as the gates opened and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

It was observed that Jockey S Antony Raj, the rider of KANYA RASHI pulled up his mount and dismounted from it, after passing the 400 Metres. On immediate examination by the Clubs Veterinary Officer it was reported to have pulled up lame on left fore. Trainer Mr. Vinesh V Naik was informed that he must produce a <u>Fitness Certificate</u> from the Club's veterinary Officer before accepting with it again.

It was observed that SHERSHAH (Akash Agarwal) completely stopped galloping and hereafter ran detached from the field, in the last 150 Metres of the Race. Trainer Mr. Dhyan Subbaiah K was informed to ensure better performance of his charge in future.

Jockey C Umesh, the rider of VANDHIYATHEVAN was fined Rs.3,000/- for the excessive use of the whip on his mount in the above race (1st Infringement).

6th Race: 06. The Fantasy Dream Plate - Div.I (About) 1200 Metres. Horses rated 20 to 45 (12 runners):

SANDAL QUEEN (Ganesh Shingade) jumped out awkwardly, at the Start.

FLASH BACK (Abhishek Mhatre) jumped awkwardly outwards, at the start.

Jockey S G Prasad, the rider of KNOTTY IN BLUE was fined **Rs.3,000/-** for the excessive use of the whip on his mount in the above race **(1st Infringement).**

It was reported after the race at TOWER QUEST (J Paswan) pulled up lame on right fore. Trainer Mr. Pillay J S (deputizing for Trainer Mr. K Somashekar) was informed that he must produce a <u>Fitness Certificate</u> from the Club's veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b f BEAUTIFUL BLOOM.

7th Race: 07. The B.R. Hills Plate (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (11 runners):

As Jockey J Paswan, the declared rider of TIME FOR VICTORY was certified medically unfit to ride after his ride in the 6^{th} Race and as no suitable substitute rider as available, permission was granted to Trainer Mr. J S Pillay (deputizing for Trainer Mr. K Somashekar) to <u>withdraw</u> TIME FOR VICTORY from the above race.

NEVADA GOLD (S Imran) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey C Umesh, the rider of REIGN OF TERROR reported that his was mount was hanging in after entering the Straight. The horse was impounded for Veterinary examination but no abnormality was reported. However, Trainer Mr. Mandanna K S was informed to take appropriate corrective measures before accepting with it again.

Permission was granted to trainer Mr. Pillay J S to deputise on behalf of Trainer, K Somashekar who was unable to attend the Day's Races.

The Stipendiary Stewards reported Jockey Vinod Shinde to the Stewards, vide Charge Sheet No. 385 dated 8TH November, 2025, for breach of Rule No. 166 (a) of the Mysore Race Club Ltd., Rules of Racing, read with Calendar Notification under the heading "USE OF WHIPS" pertaining to the excessive use of whip on his mount JADE MOUNTAIN, in the above Race [Third Infringement]. His first infringement was on D GOLDEN CUP in Race No. 8 and his second infringement was on TOM CRUISER in Race No. 77 of the Mysore Monsoon Races 2025. The Stewards, at their meeting held on 11th November, 2025, held an enquiry and examined Jockey Vinod Shinde.

After due deliberations the Stewards decided to suspend the Jockey's License granted to Jockey Vinod Shinde, under the My. R.C. Ltd., Rules of Racing, for the year 2025-26, for the first two Race Days of the Mysore Winter Races 2025-26, i.e., on 19th November, 2025 and 26th November 2025 for breach of Rule No. 166 (a) of the Mysore Race Club Ltd., Rules of Racing, read with Calendar Notification under the heading "USE OF WHIPS" pertaining to the excessive use of whip on his mount TOM CRUISER, in the above Race [Third Infringement].
