1st Race: 37. The Alberetto Plate - Div. II (About) 1100 Metres. Horses rated 00 to 25 (9 Runners):

[There was a steady drizzle, before the commencement of the 1st race].

Trainer Mr. G T Surender, was fined **Rs.2,000/-** for the delay in bringing his charge AMRON TIGRESS (P Vikram), to the Paddock, to complete the Paddock formalities.

Jockey M Prabhakaran, the rider of COUNTRY'S FIRE was fined **Rs.2,000/-** for shifting out and taking out ARIGATO (Shyam Kumar [CHE]) on his outside till about passing the 1000 Metres.

Jockey Faiz, the rider of NIMBLE SPIRIT reported that he accidentally dropped his whip passing the 350 Metres.

Jockey J Paswan, the rider of QUEEN OF COMEBACKS was reprimanded for riding an indifferent race.

It was reported after the race that THE ARTERY (P Sai Kumar) burst its blood vessels. Trainer Mr. Santosh Rao S was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

AMRON TIGRESS (P Vikram) sustained multiple small cuts inside left hind cannon.

Routine Sample was taken for analysis from the winner b f PHOENIX GOLD.

2nd Race: 38. The Heggadadevanakote Plate (About) 1400 Metres. For Maiden Horses 3 years old only (11 Runners):

BOUNTIFUL BEAUTY (P P Dhebe) was slowly away, swerved left after jumping out and lost many lengths at the start. In view of its behaviour, Trainer Mr. Rakesh was informed that he must not accept with it again until its behaviour

improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey C Umesh, the rider of MISTY WARRIOR was fined **Rs.1,000/-** for shifting in and causing interference to ONE NATION (S Antony Raj) on his inside passing the 200 Metres.

Jockey M S Deora, the rider of MYSORE PHARAOH was fined **Rs.2,000/-** for shifting out and taking out the horses on his outside viz. ONE NATION (S Antony Raj), MISTY WARRIOR (C Umesh) and NATURAL LOOK (Ankit Pal), in the closing stages of the race.

Jockey Varun, the rider of MIND GAMES was reprimanded for not maintaining a straight course in the closing stages of the race. He was also fined **Rs.1,000/-** for exulting before passing the Winning Post.

Jockey M S Deora, the rider of MYSORE PHARAOH reported that his mount was hanging out in the closing stages of the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Pratap Kamath M was advised to take appropriate corrective measures before accepting wit it again.

It was reported after the race that COSETTE (A Ashad Asbar) burst its blood vessels. Trainer Mr. Saddam Iqbal was informed that he must produce a **Fitness Certificate** from the Club's veterinary Officer before accepting with it again.

3rd Race: 39. The Alberetto Plate - Div. I (About) 1100 Metres. Horses rated 00 to 25 (7 Runners):

Permission was granted to Trainer Mr. G T Surender to <u>withdraw</u> EPSOM DOWNS (Arvind Kumar N) on veterinary grounds as it was found to have an inflammation of left side neck region. He was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with again.

ALEXANDER MAXIMUS (Abhishek Mhatre) was extremely fractious while loading as a result the bridle strip snapped. Under the circumstances, it was permitted to be **withdrawn** before coming under Starter's Orders.

LADY EMPORIO (N Ramesh Kumar) drifted out badly after passing the 300 Metres and went onto the outer sand track. The horse was impounded for veterinary examination but no abnormality was reported. In view of its behaviour, Trainer Mr. Ganesh J was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey Madhu Sudhan S, the rider of BEAUTIFUL BLOOM was reprimanded for shifting in and inconveniencing ECO SYSTEM (Ganesh Shingade) on his inside in between the 800 Metres and 700 Metres.

4th Race: 40. The Kapila Plate(About) 1600 Metres. Horses rated 20 to 45, 5 years old and over (8 Runners):

LUCKY POINT (Dhanu Singh Deora) jumped out awkwardly at the Start.

It was observed that Jockey Shyam Kumar (CHE), the rider of DAVID'S DELIGHT accidentally dropped his whip approaching the 400 Metres.

Jockey S G Prasad, the rider of QUICK WITTED was reprimanded for the undesirable practice of dropping hands and completely easing up his mount in the final 300 Metres of the race.

Jockey P Sai Kumar, the rider of D DON KING was reprimanded for the undesirable practice of dropping hands and completely easing up his mount in the final 100 Metres of the race.

An enquiry is being held into the running and riding of MAGIC CIRCLE, trained by Mr. Bipin V Salvi and ridden by Jockey K Sai Kiran in the above race.

DAVID'S DELIGHT (Shyam Kumar [CHE]) sustained small cut on right hind cannon and inner bulb of the heel.

Routine Sample was taken for analysis from the winner ch g SERDAR.

5th Race: 41. The S V Subramaniam Memorial Trophy (About) 1200 Metres. Horses rated 60 and above (11 Runners):

Trainer Mr. G T Surender was fined **Rs.10,000/-** for having entered his charge EXUBERANCE to run in the above race when it was under Veterinary treatment. Subsequently the entry of the horse was scratched from the above Race.

Jockey H Rahul, the rider of SPECTACULAR was fined **Rs.2,000/-** for shifting out and causing interference to the horses on his outside viz. DEUS EX MACHINA (Hasib Alam) and MIDSUMMER STAR (Sham Kumar) on his outside soon after jumping out of the Starting gates.

It was observed that DEUS EX MACHINA (Hasib Alam) veered out passing the 350 Metres towards the outer sand track, dropped its rider and collapsed. On immediate examination by the Club's Veterinary Officer it was reported to have burst its blood vessels and suffered a cardiac arrest and died. Blood sample was collected for analysis from the dead horse, viz., b g DEUS EX MACHINA.

It was reported after the race that SMART CADILLAC (M S Deora) pulled up lame on Right fore. Trainer Mr. Pratap Kamath M was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with it again.

SPECTACULAR (H Rahul) sustained bleeding cut on left fore coronet.

6th Race: 42. The Ranibennur Plate (About) 1600 Metres. Horses rated 40 to 65 (9 Runners):

[It started to rain, before the commencement of the 6th Race]

As Jockey Hasib Alam, the declared rider of IGNORANCE IS BLISS was certified medically unfit to ride after his fall in the 5th Race and as no suitable substitute rider was available, permission was granted to Trainer Mr. Ranjeet Shinde to **withdraw** IGNORANCE IS BLISS from the above race.

SQUARE CUT (P Sai Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Santosh Rao S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

NATURAL WARRIOR (Ankit Pal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Routine Sample was taken for analysis from the winner b g TIGNANELLO.

7th Race: 43. The Goa Plate (About) 1400 Metres. Horses rated 20 to 45 (8 Runners):

Permission was granted to Trainer Mr. J S Pillay to <u>withdraw</u> DRISANA (Anil Baandal) on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a <u>Fitness Certificate</u> from the Club's Veterinary Officer before accepting with again.

Permission was granted to Trainer Mr. Fahad Khan to <u>withdraw</u> WAR EMBLEM (H Rahul) on veterinary grounds as it was found to be suffering from right fore infected capped elbow. He was informed that he must produce a <u>Fitness</u> <u>Certificate</u> from the Club's Veterinary Officer before accepting with again.

As Jockey G Umesh, the declared rider of SHE'S UNSTOPPABLE was certified medically unfit to ride, permission was granted to Trainer Mr. Bipin V Salvi to substitute Jockey Ganesh Shingade to ride SHE'S UNSTOPPABLE in place of the declared rider.

Jockey R Shiva Kumar replaced the indisposed Jockey Hasib Alam on MADUVA THALAIVI.

It was observed that OCEAN (S Antony Raj) was extremely fractious in the Starting stalls whereby it reared up, flipped over inside the gates and got cast inside for a considerable period of time, as a result Jockey M Prabhkaran, the rider of SANDAL KING (Drawn 4) was also injured. Under the circumstances OCEAN (S Antony Raj) and SANDAL KING (M Prabhakaran) were permitted to be **withdrawn** before coming under Starter's Orders.

YUKIKAZE (Rajesh K) did not raise a fluent gallop soon after jumping out of the Starting Gates and lost many lengths at the Start and thereafter, ran on the outer portion of the Grass Track. In view of its behaviour, Trainer Mr. Rakesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race day, on the Race Track.

It was observed that MADHUVA THALAIVI (R Shiva Kumar) ran detached from the field. Trainer Mr. Vishal Yadav was informed to ensure better performance of his charge in future.

An enquiry is being held into the performance of LITTLE MINISTER, trained by Ganesh J and ridden by Jockey M S Deora in the above race.

Routine Sample was taken for analysis from the winner b g LITTLE MINISTER.

ORDER OF THE BOARD OF APPEAL

ELEVENTH DAY, WEDNESDAY, 22ND JANUARY 2025

RACE NO. 71: THE UJIRE PLATE - DIV (II) (ABOUT) 1100 METRES. HORSES RATED 00 TO 25:

The Board of Appeal, at its meeting held on Wednesday, 25th June, 2025, considered the Appeal dated 3rd May, 2025, filed by Trainer Mr. Surender G T, against the decision of the Stewards, which had declared Trainer Mr. Surender G T a disqualified person, for the period from **06-06-2025 to 05-06-2026** (both days inclusive), for breach of Rule Nos., 6, 7, 13 (b) (c) & (f), 19, 20, 21, 23 (c), 24 (1) (a)(b)(c) and 27 of the Medication Rules of the Mysore Race Club Ltd., under the heading "MEDICATION AND TREATMENT OF HORSES IN TRAINING AND RACING AND ANTI-DOPING CONTROL" read with Rule Nos. 114 (a), (b)(i) and 202 (i), (vi), (vii) & (x)(a)(i), of the Rules of Racing of the My.R.C. Ltd., with regards to blood oozing out from the left jugular vein due to needle prick, observed at the Gates, pertaining to his charge **AMRON TIGRESS (Vinod Shinde)**, in the above race.

The Board examined the Trainer Mr. Surender G T along with his spokesperson Mr. Dinesh T and took on record the submissions made by them on this day, i.e., Tuesday, 25th June, 2025;

The Board considered the following:

- (a) Charge Sheet No. 354 dated 22nd January, 2025 issued to Trainer Mr. G T Surender;
- **(b)** Veterinary Report dated 22nd January, 2025, issued by Dr K N Somashekar, Veterinary Officer, My.R.C. Ltd.,
- **(c)** Veterinary Report dated 22nd January, 2025, issued by Dr. Rajesh Boranna Pujrod, Veterinary Officer, My.R.C. Ltd.;
- **(d)** Enquiry Notice dated 3rd January, 2025, intimating Trainer Surender G T to appear before the Stipendiary Stewards;
- (e) Letter dated 31st May, 2025, enclosing the Order of the Stewards;
- **(f)** Appeal dated 3rd May, 2025 (received on 4th June, 2025) submitted from Trainer Surender G T;
- **(g)** Letter dated 6th June, 2025, enclosing the Order of the Board of Appeal dated 5th June, pertaining to the Grant of Stay to the Order of the Board of Appeal;
- **(h)** Letter dated 17th June, addressed to Trainer Mr. Surender G T, enclosing the Minutes of the Stewards Meeting held on 27th May, 2025;
- (i) Letter dated 20th June, 2025 intimating Trainer Mr. Surender G T to appear before the Board of Appeal on 25th June, 2025;
- (i) Past records of Trainer Mr. Surender G T;
- **(k)** Grounds of Appeal submitted on 21^{st} June, 2025, submitted by Trainer Mr. Surender G T;
- (I) Letter dated 24th June, 2025, requesting that Mr. Dinesh T will be representing Trainer Mr. Surender G T as his spokesperson;

(m) The Submissions made by Mr. Dinesh T, the spokesperson of Trainer Mr. Surender G T as well as Trainer Mr. Surender G T himself before the Board of Appeal, on this day, the 25th of June, 2025;

After consideration of all the above and after detailed and due deliberations, the Board of Appeal decided as follows:

- a] To partially allow the appeal preferred by Trainer Mr. Surender G T against the Order of the Stewards by modifying the punishment. Accordingly, the Trainer's license granted to Trainer Mr. Surender G T, under the My.R.C. Ltd., Rules of Racing, for the year 2025-26, now stands suspended for a period from 29-06-2025 to 28-07-2025 (both days inclusive), for breach of the relevant Rules of the Club;
- b] To forfeit the deposit of Rs.10,000/- (Rupees Ten Thousand only) plus GST paid by Trainer Mr. Surender G T;
- c] During the period of suspension the under mentioned disabilities shall be applicable to Trainer Mr. Surender G T:
- 1. No horse under the care of a suspended Trainer shall be permitted to race;
- 2. The suspended Trainer shall not be permitted to come to the Race Course and/or attend racing and/or stables;
- 3. The suspended Trainer shall not be permitted to attend track work at any time.
