<u>1st Race: 1. The Balmuri Plate (About) 1400 Metres. Horses rated 00 to</u> <u>25 (15 Runners):</u>

FIFTY GRAND (R Shiva Kumar) jumped awkwardly inwards and inconvenienced CITY OF HUSTLE (P Siddaraju) on its inside soon after jumping out of the Starting Gates.

Jockey H Rahul, the rider of COUNTRY MAGIC was fined **<u>Rs.1,000/-</u>** for shifting in and causing interference to RUMOUR LADY (Saqlain S), on his inside, which had to be checked by its rider and hence dropped back, approaching the 900 Metres.

It was observed that the saddle on CONSPIRACY (C A Brisson) shifted back rounding the final bend and as such the rider had considerable difficulty in the handling of his mount till passing the Winning post. After due examination of the equipment which was found to be in serviceable condition Trainer Mr. C D Monnappa was fined **Rs. 3,000/-** for his negligence in saddling (1st Infringement).

Surprise Sample was taken for analysis from the winner b g WHITE LIES.

2nd Race: 2. The Prince Regent Plate (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over (15 Runners):

VENEZUELA (R Shiva Kumar) planted and lost many lengths at the start. In view of its behavior, Trainer Mr. P C Tejaswi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

It was observed that MANY MOONS (K Sai Kiran) gradually dropped back after passing 1000 metres and ran detached thereafter. Jockey K Sai Kiran was questioned in the presence of Trainer Mr. Dinesh Pujar as to why his mount had dropped back so drastically. He replied that his mount was not galloping fluently and that every time he tried to exert some pressure on his mount he felt that it was trying to go down and hence he had to pull it up to keep it from not stumbling and dislodging him. Thereafter he said that his mount dropped pace and literally came to a trot. When questioned, Trainer Mr. Dinesh Pujar replied that his charge was a problematic horse and that it had suffered from a chipped knee on the right fore for which a surgery was done. He had changed its work pattern and kept it on very light work, due to which the weight of the horse had increased. While noting their explanations, Trainer Mr. Dinesh Pujar was advised to have the mare examined by the Club's Veterinary Officer, to ensure that he does not run it immediately and give it more time to recover. He was also advised to produce a <u>**Fitness Certificate**</u> from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b m CATALINA.

<u>3rd Race: 3. The Obligado Plate – Div II (About) 1400 Metres. Horses</u> rated 20 to 45 (11 Runners):

Jockey M Rajesh Kumar, the rider of SWISS TIGRESS was reprimanded for cutting across the field sharply before passing the **<u>Red Marker Post</u>**.

Jockey C A Brisson, the rider of D ROMAN REIGNS was reprimanded for shifting in and inconveniencing MILOS (J H Arul), on his inside, in the final 100 Metres of the race.

Jockey Shreyas Singh, the rider of SUNLIGHT STORM reported that his mount was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. C D Monnappa was informed to take appropriate corrective measures before accepting with it again.

4th Race: 4. The Kolar Plate (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (13 Runners):

D DEAR (Salman Khan) planted and lost many lengths at the start. In view of its behavior, Trainer Mr. C D Monnappa was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

N R I PLAN (M Shahid) walked out of the gates and lost many lengths at the start. In view of its behavior, Trainer Mr. Md. Sajid Qureshi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in <u>One Mock Race</u> on a Race Day on the race track.

It was observed that the saddle on WENCHENG (M J Gautam Raj Urs) shifted back passing the 400 Metres and as such the rider had considerable difficulty in the handling of his mount till passing the Winning post. After due examination of the equipment, which was found to be in serviceable condition, Trainer Mr. M Eshwer was fined **Rs. 3,000/-** for his negligence in saddling. (1st Infringement).

SOCRATES (R Shiva Kumar) sustained small cut inside right hind cannon.

Routine Sample was taken for analysis from the winner b g CLETUS.

5th Race: 5. The Star Supreme Trophy (About) 1400 Metres. Horses rated 60 and above (12 Runners):

HIS EMINENCE (M J Gautam Raj Urs) ran detached from the field after rounding the final bend. Trainer Mr. Ranjeet Shinde was informed to ensure better performance of his charge in future.

PERFECT PERFECTO (R Shiv Kumar) ran detached from the field after passing the 300 Metres. Trainer Mr. P C Tejaswi was informed to ensure better performance of his charge in future.

6th Race: 6. The Red Satin Plate (About) 1200 Metres. Horses rated 40 to 65 (15 Runners):

The Stipendiary Stewards reported Jockey Arjun, the rider of TRACER BULLET, to the Stewards vide Charge Sheet No.322, for "Dangerous Riding" [breach of Rule No. 161 (i) of the My.R.C. Ltd., Rules of Racing] on his mount, in the above Race, in that, as the rider of TRACER BULLET he came in sharply within the first 150 Metres of the race causing severe interference to SMART CADILLAC (R Rakesh) which had to be checked due to which he collided with the running rails and had to be checked and pulled out and as such KALAHARI GOLD (J H Arul) which was galloping directly behind the front running horse clipped the heels of the front running horse and shifted out onto SPARKLES (Likith Appu K G) and stumbled, thereby dropping the rider. The Stewards held an enquiry immediately after the last Race and examined Jockey Arjun and the Trainer of the horse, Mr. M Pratap Kamath. After repeatedly watching the CCTV footage of the above Race and after due deliberations, the Stewards decided as follows;

a) To suspend the Jockey's license granted to Jockey Arjun from <u>06-06-2023</u> to <u>16-06-2023</u> (both days inclusive), for "Dangerous Riding" [breach of Rule No. 161 (i) of the My.R.C. Ltd., Rules of Racing], on his mount TRACER BULLET, in the above Race;

b) To caution Jockey Arjun to be more careful while riding his mounts in future and that a similar manner of riding would be dealt with very severely;

c) Jockey Arjun was informed that he can ride work and was also informed of his right to appeal.

KALAHARI GOLD (J H Arul) sustained injury on left nostril and bruises on both hind back of fetlock.

7th Race: 7. The Obligado Plate – Div I (About) 1400 Metres. Horses rated 20 to 45 (10 Runners):

LUCKY POINT (H Rahul) was extremely fractious inside the starting gates whereby the stirrup belt snapped and as it could not be replaced due to the extremely fractious behaviour of the horse it was permitted to be **withdrawn** before coming under Starter's Orders.

KUSHAQ (J H Arul) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. M Eshwer was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

PERCIVALE (V R Jagadeesh) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey Vivek G, the rider of STEP UP GIRL, reported that his mount grabbed its bit on the left and was inclined to run out throughout the race despite his best efforts to keep in on an even course. The horse was impounded for veterinary examination but no abnormality was reported. However Trainer Mr. Md Sajid Qureshi was informed to take appropriate corrective measures before accepting with it again.

The Board of Appeal, at its meeting held on Friday, 24th March,2023 considered the Appeal, dated 12th Janaury,2023 filed by Trainer Vikram Appachu against the decision of the Stewards of the Mysore Race Club Limited, for declaring him a disqualified person from <u>20th January, 2023, till the end of the</u> <u>Mysore Summer Races 2023 [both the days inclusive]</u>, for the vastly improved performance as well as the relatively poor performance of his charge JEWEL THIEF, in the above Races [Negligence in the discharge of his duties as a licensed Trainer-Improper Practice.]. for contravention of RULE NO. 114(b)(i) read with RULE NO. 202(i) under MyRC rules of, pertaining to his charge JEWEL THIEF, in the above Races , reading as under

RULE NO. 114(b): In addition to or in lieu of any other penalties or

punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards. **114(b)(i)** If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing.

RULE NO. 202:- The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any dishonest, corrupt, fraudulent, or improper practice or dishonourable action in connection with racing anywhere;

The Board further examined Trainer Vikram Appachu.

After consideration of all the above and the oral submission made by Trainer Vikram

Appachu, and after detailed deliberations, the Board of Appeal decided as follows:

a] To partially allow the appeal so as to

b] To modify the Order of the Stewards issued to Trainer Vikram Appachu as follows:

To declare Trainer Vikram Appachu a disqualified person from 1st May, 2023 to 31st August, 2023(both days inclusive) under the Mysore Race Club Limited Rules of Racing for contravention of Rule no. 114(b)(i) read with Rule no. 202(i) of the MyRC rules of racing pertaining to his charge JEWEL THIEF, in race nos 56 and 62 of the Mysore Winter Races 2022-2023. The relevant Rules of Racing are reproduced here under.

RULE NO. 114(b): In addition to or in lieu of any other penalties or punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards.

114(b)(i) If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing.

RULE NO. 202:- The Stewards and/or the Stewards of the Club shall fine and/or punish and/or warn off and / or exclude and / or eject and / or disqualify and/or suspend or withdraw Licences, for any reason or reasons, from any Racecourse or place where these Rules are in force, any of the following persons viz.:

(i) Any person, who, in their opinion, has been guilty of any dishonest, corrupt, fraudulent, or improper practice or dishonourable action in connection with racing anywhere;

The Board of Appeal, at its meeting held on Monday, 1st May,, 2023 considered the Appeal, dated 27th Janaury, 2023 filed by Trainer Mr P.C.Tejaswi against the decision of the Stewards in unanimously deciding that Trainer Mr. P C Tejaswi was guilty of and in breach of Rule No. 114 (b) (i) read with Rule No. 202 (i) of the Mysore Race Club Ltd., Rules of Racing [Negligence in the discharge of his duties as a licensed Trainer – Improper Practice), for the vastly improved performance of his charge PERFECTIMAGINATION, in the above Race and passed an order stating that if a Trainer's license is granted to Mr. P C Tejaswi, under the My.R.C. Ltd., Rules of Racing, for the year 2023-24, the same shall remain suspended from 01-05-2023 to 30-09-2023 [both the days inclusive], for the vastly improved performance of his charge PERFECTIMAGINATION, in the above Race [Negligence in the discharge of his charge PERFECTIMAGINATION, in the above Race Inclusive].

The relevant Rules of Racing are reproduced hereunder;

RULE NO. 114(b): In addition to or in lieu of any other penalties or Punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards.

114(b)(i) If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing.

After consideration of all the above and the oral submission made by Trainer P.C.Tejaswi, and after detailed deliberations, the Board of Appeal decided as follows:

a] To allow the appeal so as to

b] To modify the order of the Stewards and charge him for reversal of form and inconsistent running pertaining to his charge PERFECTIMAGINATION thereby breaching rule no 114(b)(i) of MyRC Ltd Rules of Racing and fine Trainer P.C.Tejaswi a sum of Rs 10,000(Ten thousand only). Relevant Rules of Racing is reproduced here under:

RULE NO. 114(b): In addition to or in lieu of any other penalties or Punishments, as may be laid down under these Rules of Racing, a Trainer may be fined, suspended or disqualified by the Stewards.

114(b)(i) If his conduct or negligence or neglect in the performance of his duties as a licensed professional has led or could have led to a breach of the Rules of Racing.

c] To forfeit the deposit of Rs.10,000/- paid by Trainer P.C.Tejaswi
