### **SECOND DAY, FRIDAY, 26<sup>th</sup> AUGUST 2022**

#### **RACING INCIDENTS**

**(Race No. 8 - 13)**

<b>Weather</b>	<b>: Partly Cloudy</b>
<b>Track Condition</b>	<b>: Soft Going</b>
<b>Penetrometer reading</b>	<b>: 4.1 Cms.</b>
<b>Positioning of Railings</b>	<b>: Railings fixed at an average width of 4.5 at the 1400 Metres and gradually increasing to 8 Metres at the 1000 Metres to the Winning Post.</b>

#### **1<sup>st</sup> Race: 8. The Talakadu Plate (About) 1400 Metres. Horses rated 00 to 25 confined to Mysore based horses (15 Runners):**

As Jockey Md. Imran Ashraf, the declared rider of GABRIELLA was certified medically unfit to ride, permission was granted to trainer Mr. Ramesh S to substitute Jockey B Harish to ride GABRIELLA in place of the declared rider.

BHRIGU (K Sai Kiran) reared up as the gates opened and lost many lengths at the start. In view of its behavior, Trainer Mr. Vikram Appachu was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

JAMESON (Nazar Alam) planted and lost many lengths at the start. In view of its behavior, Trainer Mr. M Bobby was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

SPIRITUAL QUEEN (N B Kuldeep) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. P C Tejaswi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

It was observed that CLOVER CRUZ (S R Santosh Kumar) drifted out passing the 400 Metres and went on to the outer sand track despite the best efforts of the Jockey to keep it on an even course.

At the behest of the Stipendiary Stewards, a Stewards Enquiry was held immediately after the Race, with particular reference to the Start of the Race, where Jockey K Sai Kiran, the rider of BHRIGU (Drawn – 5) reported that he was not ready on his mount, when the Start of the Race was given.

The Stewards examined Jockey K Sai Kiran as well as the Starters, Mr. Kiran M and Mr. Shanmukha Swamy. After repeatedly watching the CCTV replay of the Start of the Race and after due enquiry, they decided that the horse, BHRIGU reared up, just as the Start was effected and that it was purely accidental. Taking this into consideration and that of the opinion of the Stipendiary Stewards, the Stewards decided that there shall be no changes in the Judges' placings, in the above Race.

**2<sup>nd</sup> Race: 9. The Full Speed Plate – Div. II (About) 1100 Metres. Horses rated 20 to 45 confined to Mysore based horses (10 Runners):**

EWANDOR (Angad) was extremely fractious, reared up and flipped over inside the Starting Stalls. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Order.

ENCHRICHMENT (B Darshan Antony) planted and lost many lengths at the start. In view of its behavior, Trainer Mr. S Ramesh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

Jockey Arul J H, the rider of ORIENTAL LILLY was fined **Rs.1,000/-** for shifting out and taking out BONITO (M Prabhakaran) on his outside approaching the 200 Metres.

Jockey Nazerul Alam, the rider of SUPREME ANGEL was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race (1<sup>st</sup> Infringement).

SHOOTING VENUS (R N Darshan) sustained gum injury.

Routine Sample was taken for analysis from the winner dk b g ROYAL CROWN.

**3<sup>rd</sup> Race: 10. The Ranga Family Trophy (About) 1400 Metres. Horses rated 40 to 65, 5 years old and over (11 Runners):**

GIN TOKI (Angad) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Monnappa C D was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

D BROTHER (S Anthony Raj) accidentally stumbled approaching the 1200 Metres.

Jockey S Anthony Raj, the rider of D BROTHER was fined **Rs.2,000/-** for shifting in and causing interference to WHITE RIVER (Afsar Khan), on his inside, approaching the 1100 Metres.

Jockey K Sai Kiran, the rider of NOTORIETY reported that he accidentally lost his whip passing the 500 Metres.

An objection was lodged by Jockey K Sai Kiran, the rider of NOTORIETY, placed Third by the Judge against Jockey Angad, the rider of GINTOKI placed Second by the Judge for, "at 200 Metres, he cut across me sharply whereby I had to stop riding which cost me the race". The Stewards held an enquiry immediately after the Race and examined Jockey K Sai Kiran and Jockey Angad; After due deliberations and after repeatedly watching the CCTV replay of the Race, the Stewards decided to **uphold** the objection and revised the order of placing as under:

**An enquiry is being into the manner of riding of Jockey Angad on his mount GINTOKI in the above race.**

**An enquiry is being held into the running and riding of PERFECT PERFECTO, trained by Mr. P C Tejaswi and ridden by Jockey N B Kuldeep in the above race.**

D WARRIOR (R Shiva Kumar) sustained clip injury on right hind back of cannon.

MARCH TO VICTORY (Saqlain S) sustained injury inside right hind gaskin.

Routine Sample was taken for analysis from the winner b g TREMENDOUS.

**4<sup>th</sup> Race: 11. The Srikantadatta Narasimharaaja Wadiyar Memorial Million 2022 (About) 1400 Metres (5 Runners):**

Trainer Mrs. Parvati D Byramji was fined **Rs.10,000/-** by the Stewards for having accepted her charge RAVISHING FORM to run in the above race when it was under Veterinary ban. Subsequently the colt was not declared to start.

Permission was granted to Trainer Mr. Rakesh to **withdraw** INDIAN PATRIOT on veterinary grounds as it trotting lame on right fore due to shoulder sprain. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner b c ASHWA MAGADHEERA.

**5<sup>th</sup> Race: 12. The Full Speed Plate – Div. I (About) 1100 Metres. Horses rated 20 to 45 confined to Mysore based horses (11 Runners):**

As Jockey Mohammed Mushraf the declared rider of SULTAN SWORD did not arrive to fulfill his riding engagements for the day, permission was granted to Trainer Mr. P C Tejaswi to substitute Jockey B Harish to ride SULTAN SWORD, in place of the declared rider.

VENEZUELA (R Shiva Kumar) jumped awkwardly outwards and bumped SHIVALIK STYLE (H Rahul) on its outside soon after jumping out of the Starting Gates.

Jockey Salman Khan, the rider of FLYING FALCON was fined **Rs.2,000/-** for shifting in and causing interference to COUNTRY'S DELIGHT (S Anthony Raj) on his inside which in turn passed it onto SULTAN SWORD (B Harish) along the rails, passing the 950 Metres.

Jockey Saqlain S, the rider of MAYBURY was fined **Rs.2,000/-** for shifting in and causing interference to SUPER SEXY (Kiran Naidu) on his inside along the rails passing the 750 Metres.

Jockey Salman Khan, the rider of FLYING FALCON reported that his mount was hanging out throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Prashanth Pawar D was informed to take appropriate corrective measures before accepting with it again.

MAYBURY (S Saqlain) was impounded for veterinary examination and the Club's Veterinary Officer reported that on examination of the mouth of the horse revealed sharp molars. Hence Trainer Mr. M Bobby was fined **Rs.3,000/-** for his negligence **(1<sup>st</sup> infringement)**.

**6<sup>th</sup> Race: 13. The Regency Gold Plate (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over confined to Mysore based horses (12 Runners):**

Jockey B Harish replaced the indisposed Jockey Mohammed Mushraf on UNIMAGINABLE.

ROYAL TITLE (Nazar Alam) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Dinesh Pujar was informed that he must not accept with it again until its behaviour improved to the

satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

CALIFOIRNIA GOLD (Salman Khan) veered left after jumping out and lost many lengths at the start. In view of its behavior, Trainer Mr. Prashanth Pawar was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

Jockey Vijay Kumar, the rider of CHEROKEE MOON was fined Rs.**2,000/-** for allowing his mount to drift out under the use of the whip thereby taking out MY ONE AND ONLY (J Paswan) between the 400 Metres and 250 Metres.

Jockey B Harish, the rider of UNIMAGINABLE reported that he accidentally lost his whip passing the 200 Metres.

The Stipendiary Stewards questioned Trainer Mr. Vinesh V Naik and Jockey J Paswan as to the running and riding of MY ONE AND ONLY, in the above race. After due enquiry and after repeatedly watching the CCTV footage of the above Race the Stipendiary Stewards decided to a) Fine Jockey J Paswan **Rs.5,000/-** for not making sufficient effort to improve his position throughout the Race and for not infusing sufficient vigour in riding out his mount, in the closing stages of the Race; and b) Fine Trainer Mr. Vinesh V Naik **Rs. 5,000/-** for the unsatisfactory running of his charge, MY ONE AND ONLY and for the unsatisfactory explanation tendered by him during the enquiry. Both the Trainer and the Jockey were cautioned that a repetition of a similar manner of running and riding in future would entail them being reported to the Stewards for appropriate action.

EWANDOR (Angad) – Was withdrawn before coming under starters order as the gelding was extremely fractious inside the stall where by equipment (Bridal) came off. **The starting stall certificate is revoked.**

ENRICHMENT (B. Darshan Anthony) – Planted and lost many lengths.

TWIN FLAME (Sarvan Kumar) – Was slowly away.

**3<sup>rd</sup> Race: 10. The Ranga Family Trophy. Horses rated 40 to 65 :**

POWER OF THEA (B Harish) - } Were Slowly away.
