1st Race: 47. The Valaroso Plate (About) 2000 Metres. Horses rated 20 to 45 (4 Runners):

Permission was granted to Trainer Mr. J S Pillay to **withdraw** SAPIENT on veterinary grounds as it was found to have right fore cannon inflammation due to injury. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

SUNDANCE KID (A R Pradeep) took a fly jump at the Start.

SUNDANCE KID (A R Pradeep) ran detached from the field after rounding the final bend. Trainer Mr. Purshotham K was advised to ensure better performance of his charge in future.

Jockey S Antony Raj, the rider of CEREMONIAL reported that his mount was hanging in after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Arjun Mangalorkar was informed to take appropriate corrective measures before accepting with it again.

Routine Sample was taken for analysis from the winner b g UNFORGETTABLE STAR.

2nd Race: 48. The Son of the Light Plate (About) 1400 Metres. Horses rated 00 to 25, 5 years old and over confined to Mysore based horses (11 Runners):

EYE THE MIND (S Imran) was extremely fractious whereby it reared up and flipped over inside the gates and the saddle got loose. Under the circumstances it was permitted to be **withdrawn** before coming under Starter's Orders.

RUN HAPPY RUN (Sham Kumar) planted lost many lengths at the start. In view of its behaviour, Trainer Mr. Ruban P was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

FOREST VIEW (Faiz) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. C D Monnappa was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

THE ANGEL POWER (N Ramesh Kumar) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Varun, the rider of BUNDELKHAND QUEEN was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race (**1st Infraction**).

3rd Race: 49. The Jayanagara Plate (About) 1200 Metres. Horses rated 20 to 45, 5 years old and over (8 Runners):

Jockey C Umesh, the rider of EMPRESS BELLA reported that his mount was hanging out from the 800 Metres. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Kishan Thomas was informed to take appropriate corrective measures before accepting with it again.

Jockey Salman Khan, the rider of D ROMAN POWER reported that his mount was hanging 'in' after entering the straight. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Bipin V Salvi was informed to take appropriate corrective measures before accepting with it again.

Jockey Ankit Pal, the rider of SORRENTO SECRET was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race (**1st Infraction**).

An enquiry is being held into the running and riding of SUNWAY LAGOON, trained by Mr. Ranjeet Shinde and ridden by Jockey A Ramu in the above race.

MEGHANN (Laxman Singh) sustained small injury on left hind below stifle.

4th Race: 50. The Maj. Sardar L Mahadevaiah Memorial Trophy (About) 1200 Metres. Horses rated 40 to 65 confined to Mysore based horses (9 Runners):

An enquiry is being held into the running and riding of SQUARE CUT, trained by Mr. Ranjeet Shinde and ridden by Jockey A Ramu in the above race.

Routine Sample was taken for analysis from the winner ch g FALCON FURY.

5th Race: 51. The Mysore 1000 Guineas 2025 (Grade III) (About) 1600 Metres For 3 year old Indian Fillies (Foaled in 2022) (12 Runners):

ZIVA (R N Darshan) sustained cut injury on left hind inside pastern.

Compulsory Samples were taken from the First, Second and Third placed horses viz.

6th Race: 52. The M B Appaya Memorial Trophy (About) 1400 Metres. Horses rated 60 and above (9 Runners):

NEVADA GOLD (S G Prasad) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

SPECTACULAR (Suhas K) knuckled at the start.

POWER OF BEAUTY (S Antony Raj) took a fly jump and stumbled whereby the rider was momentarily unbalanced and lost a few lengths at the start. As the incident was purely accidental no action was taken beyond noting the incident.

Surprise Sample was taken for analysis from b g POWER OF BEAUTY.

7th Race: 53. The Haveri Plate (About) 1200 Metres. Horses rated 40 to 65, 5 years old and over confined to Mysore based horses (9 Runners):

IGNORANCE IS BLISS (P Siddaraju) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Suhas K, the rider of GRACE was fined **Rs.1,000/-** for shifting in and causing interference to MOONLIGHT QUEEN (S Antony Raj) on his inside approaching the 300 Metres.

It was observed that Madhu Sudhan S, the rider of SILVER DAYS AGAIN momentarily lost his left rein which he regained within a few strides in the final 100 Metres of the race.

An enquiry is being held in to the relative improved performance of BORN DANCER [Shyam Kumar (CHE)] trained by Mr. Ranjeet Shinde, the winner of the above race as compared to its previous run in Race No. 59 of Mysore Summer Races 2025 run on Wednesday, 16th July 2025 when ridden by Jockey N Ramesh Kumar it ran unplaced.

Routine Sample was taken for analysis from the winner, b m BORN DANCER.

Permission was granted to trainers M/s Bobby M and James Mckeown to deputise on behalf of Trainers, M/s Arjun Mangalorkar and S Padmanabhan respectively who were unable to attend the Day's Races.

RACE NO. 66: THE SHUNTIKOPPA PLATE – DIV. II (ABOUT) 1400 METRES. HORSES RATED 60 AND ABOVE:

The Stipendiary Stewards reported Trainer Mr. S Narredu and Jockey Suraj Narredu to the Stewards pertaining to the running and riding of DIVINE ART, in the above Race. The Stewards, at their meeting held on Friday 26th September, 2025 examined Trainer S Narredu and Jockey Suraj Narredu as also Trainer Mr. Rajesh Narredu, who deputised on behalf of Trainer S Narredu on that day. Trainer Mr. S Narredu stated as follows;

- i)** His charge DIVINE ART won a Class III race at BTC and had gone one class up;
- ii)** In its two runs in Class II at BTC, it did not perform at all;
- iii)** He thought that he would race it at My.R.C. Ltd., in the hope of picking a Race in a weaker set, but did not expect that his charge would open at such a short price and attributed this short price to the fact that it was ridden by Jockey Suraj Narredu;
- iv)** But despite the best efforts of Jockey Suraj Narredu who the whip excessively on his charge, for which the rider was fined, his charge could only finish 3rd, about 3/4th of a length behind the winner. Jockey Suraj Narredu corroborated the explanations tendered by Trainer Mr. S Narredu.

The Stewards, after taking into consideration the explanations tendered by Mr. S Narredu, after repeated viewing the CCTV replay of the above Race and after due deliberations, decided as follows;

- a)** To note the explanations tendered by Trainer Mr. S Narredu as also Trainer Mr. Rajesh Narredu and the explanations tendered by Jockey Suraj Narredu;
- b)** To caution Trainer S Narredu to ensure that his charges run more consistently in future.

RACE NO. 68: THE MYSORE SUMMER MILLION 2025 (ABOUT) 1400 METRES. FOR INDIAN HORSES, 4 YEARS OLD AND OVER:

The Stipendiary Stewards reported Trainer Mr. S Narredu and Jockey Suraj Narredu to the Stewards pertaining to the running and riding of CASTEEL, in the above Race. The Stewards, at their meeting held on Friday 26th September, 2025

examined Trainer S Narredu and Jockey Suraj Narredu as also Trainer Mr. Rajesh Narredu, who deputised on behalf of Trainer S Narredu on that day. Trainer Mr. S Narredu stated as follows;

- i) His charge, CASTEEL had run in the Maharaja's Cup in its previous run at BTC, which was run over a distance of 2200 Metres where it ran a poor 10th;
- ii) His charge had run over 1400 Metres at My.R.C. Ltd., during the Mysore Monsoon Races 2024 and had won that Race;
- iii) Keeping that in mind, he had entered CASTEEL to run in the above Race;
- iv) But during the Race one of the testicles of his charge had gone up which is very painful for any horse and the same was noticed soon after the horse came back from the Race;
- v) Maybe, in his opinion, this could have affected the performance of his charge CASTEEL. Jockey Suraj Narredu corroborated the statements of Trainer Mr. S Narredu and had nothing else to add.

The Stewards also sought an explanation from the Club's Chief Veterinary Officer, whether the pulling up of one of the Testicles of CASTEEL into the "Inguinal Canal", as reported by the latter, had any effect on the horse. The Stewards, after taking into consideration the explanations tendered by the three of them, after repeated viewing the CCTV replay of the above Race and after due deliberations, decided as follows;

- a) To note the explanations tendered by the Club's Chief Veterinary Officer;
- b) To note the explanations tendered by Trainer Mr. S Narredu as also Trainer Mr. Rajesh Narredu and the explanations tendered by Jockey Suraj Narredu;
- c) To caution Trainer S Narredu to ensure that his charges run more consistently in future.

G Prasad and the Trainer of the horse, Mr. Mansoor Khan and acting on their own observations, the Stewards decided as follows;

- a) To suspend the Jockey's License granted to Jockey S G Prasad for **Four Race Days of the Mysore (Monsoon) Races 2025, i.e., 09-10-2025, 10-10-2025, 16-10-2025 and 17-10-2025 respectively**, for breach of Rule No. 161 (ii) of the Mysore Race Club Ltd., Rules of Racing, [Unsatisfactory Riding] pertaining to his riding, on his mount NIMBLE SPIRIT, in the above Race;
- b) To caution Jockey S G Prasad that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;
- c) To accept the explanations tendered by Trainer Mr. Mansoor Khan.

Jockey S G Prasad was informed that he is permitted to ride work and was also informed of his Right to Appeal.

- b) To caution Jockey Gagandeep Maan to make every effort to improve his riding and that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;
- c) To accept the explanations tendered by Trainer Mr. Ganesh J.

a) To suspend the Jockey's License granted to Jockey Afsar for **Two Race Days of the Mysore (Monsoon) Races 2025, i.e., 09-10-2025 and 10-10-2025 respectively**, for breach of Rule No. 161 (i) [Careless Riding] and Rule No. 161 (ii) [Incompetent Riding] of the Mysore Race Club Ltd., Rules of Racing, pertaining to his riding, on his mount STAR SYMPHONY, in the above Race; and

b) To caution Jockey Afsar to make every effort to improve his riding and that a repetition of a similar manner of riding in future would entail severe action against him by the Stewards;

Jockey Afsar was informed that he is permitted to ride work and was also informed of his Right to Appeal.
