RACING INCIDENTS

Positioning of Railings : Railings fixed at its original position.

1st Race: 95. The Royal Calcutta Turf Club Trophy Div. II (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (8 Runners):

Permission was granted to Trainer Mr. K Dhyani Subbaiah to **withdraw** ASTAPOR on veterinary grounds as it was found to be suffering from right fore infected capped elbow. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

Trainer Mr. Darius R Byramji was fined a sum **of Rs.10,000/-** (Rupees Ten Thousand only) by the Stewards for having accepted and declared his charge MEGHANN (Laxman Singh) to run in the above Race, without obtaining a valid Coggins certificate. Subsequently it was **withdrawn** from the above Race.

N R I Millenium (Imran Chisty) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. MdSajid Qureshi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

SARVOTTAM (Ankit Pal) was slowly away and lost few lengths at the start. In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate practice day.

Jockey Suhas K, the rider of SLING SHOT was fined **Rs.1,000/-** for shifting in and causing interference to SARVOTTAM (Ankit Pal) on his inside along the rails approaching the 700 Metres.

Jockey Akshay Kumar, the rider of SHEER BLISS reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Purushotham K was informed to ensure better performance of his charge in future.

SLING SHOT (Suhas K) sustained clipped injury on left hind outer bulb of the heel.

CHISOX (Aleemuddin) sustained bleeding injury on right hind chestnut.

Routine Sample was taken for analysis from the winner ch r CHISOX.

2nd Race: 96. The Delhi Race Club Trophy (About) 1200 Metres. Horses rated 00 to 25 (12 Runners):

Jockey R Ravi, the rider of GLOWING MOONLIGHTS was reprimanded for riding an indifferent race.

Jockey M J Gautam Raj Urs, the rider of KNOTTY METHODS was reprimanded for riding an indifferent race.

It was reported after the race that AMAZING STORM (Aleemuddin) pulled up lame on left fore. Trainer Mr. S Inayathulla was informed that he must produce a Fitness Certificate from the Club's veterinary Officer before accepting with it again.

KNOTTY METHODS (M J Gautam Raj Urs) sustained injury on left hind coronet.

Routine Sample was taken for analysis from the winner b m COOL WINTER.

3rd Race: 97. The Royal Calcutta Turf Club Trophy Div. I (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (9 Runners):

Permission was granted to Trainer Mr. Yogesh R to **withdraw** SD QUEEN on veterinary grounds as it was found to be suffering from colic. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

It was observed that Jockey Prabhu Kumar M, the rider of SMILE OF BEAUTY momentarily lost his left stirrup soon after jumping out of the gates which he regained within a few strides.

It was observed that the saddle on MASTER WAY (Asirvatham) shifted back approaching the 800 Metres. After due examination of the equipment, trainer Mr. Umar Shariff S was fined **Rs.3,000/-** for faulty saddling **(1st Offence)**.

Jockey P Mani, the rider of ABLE ONE was reprimanded for checking his mount soon after jumping out of the Starting Gates, for no apparent reason.

SMILE OF BEAUTY (Prabhu Kumar M) sustained cuts inside right hind cannon.

4th Race: 98. The Madras Race Club Trophy Div. I (About) 1400 Metres. Horses rated 20 to 45 (12 Runners):

As Jockey Hindu Singh, the declared rider of SIRA was certified medically unfit to ride, permission was granted to Trainer Mr. M Eshwer to substitute Jockey P Ajeeth Kumar to ride SIRA in place of the declared rider.

Jockey Akshay Kumar replaced the indisposed Jockey Neeraj Rawal on ANCIENT HISTORY.

ANCIENT HISTORY (Akshay Kumar) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. ShobanBabu S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey B Darshan Anthony, the rider of HIGHER LOVE was reprimanded for traveling wide throughout the race for no apparent reason.

GOLDEN BEAST (Koshi Kumar) ran detached in the straight. Trainer Mr. M Bobby was advised to ensure better performance of his charge in future.

N R I VICTORY (Pavan) sustained small injury in right hind bulb of the heel.

5th Race: 99. The Royal Western India Turf Club Ltd. Trophy (About) 1200 Metres. Horses rated 40 to 65, 5 years old and over (10 Runners):

Trainer Mr. Narayana Gowda V was fined a sum of **Rs.10,000/-** (Rupees Ten Thousand only) by the Stewards for having accepted and declared his charge STRAVINSKY (Angad) to run in the above Race, without obtaining a valid Coggins certificate. Subsequently it was **withdrawn** from the above Race.

Trainer Mr. C D Monnappa was fined a sum of **Rs.10,000/-** (Rupees Ten Thousand only) by the Stewards for having accepted his charge MOONLIGHT QUEEN (Siddaraju P) when it was under BTF ban.

Jockey Vivek G, the rider of GOLDEN TIME reported that he accidentally dropped his whip passing the 1100 Metres.

Jockey Anish Anamo Hangal, the rider of AGERA was fined **Rs.1,000/-** for shifting in and causing interference to JASMINE (Abhishek Mhatre) on his inside passing the 900 Metres.

GOLDEN TIME (Vivek G) sustained injuries on right hind back of fetlock.

SUPER SAPPHIRE (G Praveen) sustained bruises above left hock.

Routine Sample was taken for analysis from the winner dk b g BEZWADA SULTAN.

6th Race: 100. The Bangalore Turf Club Trophy (About) 1200 Metres. Horses rated 80 and above (6 Runners):

Jockey B Darshan Anthony replaced the indisposed Jockey Hindu Singh on GOLD KITE.

It was observed that the saddle on KNOTTY BLUSH (Akshay Kumar) shifted back slightly during the race. After due examination of the equipment, trainer Mr. K Purushotham was fined **Rs.3,000/-** for faulty saddling **(1st Offence)**.

IRON CLAD (Pavan) was impounded for veterinary examination but no abnormality was reported.

DON CARLOS (P Trevor) was impounded for veterinary examination but no abnormality was reported.

KNOTTY BLUSH (Akshay Kumar) sustained small injury on left hind pastern.

7th Race: 101. The Mysore Derby 2025 (Grade I) (About) 2000 Metres. For 3 year old Indian horses (Foaled in 2022) (7 Runners):

MATISSE (Shreyas Singh) was impounded for veterinary examination but no abnormality was reported.

MOON STAR (Akshay Kumar) was impounded for veterinary examination but no abnormality was reported.

8th Race: 102. The Hyderabad Race Club Trophy (About) 1400 Metres. Horses rated 40 to 65 (12 Runners):

ALEXANDROS (K Sai Kiran) jumped awkwardly outwards at the Start.

9th Race: 103. The Madras Race Club Trophy Div. II (About) 1400 Metres. Horses rated 20 to 45 (12 Runners):

Trainer Mr. Narayana Gowda V was fined a sum of **Rs.10,000/-** (Rupees Ten Thousand only) by the Stewards for having accepted and declared his charge CR SEVEN (Angad) to run in the above Race, without obtaining a valid Coggins certificate. Subsequently it was **withdrawn** from the above Race.

ANKUSH (Salman Khan) was extremely fractious inside the gates whereby the rider was injured. Under the circumstances it was permitted to the **withdrawn** before coming under starter's orders.

Permission was granted to trainers M/s Bobby M and Rakesh to deputise on behalf of Trainers, M/s Arjun Mangalorkar and Pesi Shroff respectively who were unable to attend the Day's Races.
