#### **RACING INCIDENTS** **(Race No. 8 - 14)**

<b>Weather</b>	<b>: Clear</b>
<b>Track Condition</b>	<b>: Good Going</b>
<b>Penetrometer reading</b>	<b>: 3.0 Cms</b>
<b>Positioning of Railings</b>	<b>: Railings fixed at an average width of 2.5 Metres from 1600 Metres to the Winning Post from its original position.</b>

#### **1<sup>st</sup> Race: 08. The Gonikoppa Plate (About) 1200 Metres. For horses rated 00 to 25, 5 years old and over (10 runners):**

EXEMPLARY BLUES (Arvind Kumar N) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. G T Surender was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

GENTLEMAN'S WORD (Shyam Kumar) reared up as the gates opened and jumped out awkwardly at the start.

It was observed that EXEMPLARY BLUES (Arvind Kumar N) ran detached from the field, after entering the straight. Trainer Mr. G T Surender was advised to ensure better performance of his charge in future.

Jockey K Sai Kiran, the rider of BUNDELKHAND QUEEN reported that his mount was not galloping fluently throughout the race. The horse was impounded for veterinary examination but no abnormality was reported. However, Trainer Mr. Dhyan Subbaiah K was informed to ensure better performance of his charge in future.

Jockey Shyam Kumar, the rider of GENTLEMAN'S WORD was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race **(1<sup>st</sup> Infringement)**.

Jockey M J Gautam Raj Urs, the rider of KNOTTY METHODS was fined **Rs.3,000/-** for the excessive use of the whip on his mount during the race **(1<sup>st</sup> Infringement)**.

Routine sample was taken for analysis from the winner, b g SARVOTTAM.

#### **2<sup>nd</sup> Race: 09. The Pandavapura Plate (About) 1400 Metres. For horses rated 00 to 25 (12 runners):**

D ADMIRAL (B Darshan Anthony) was extremely fractious on the way to the Starting gates whereby it dropped the rider and bolted in anti clockwise direction. Under the circumstances it was permitted to be **withdrawn** before coming under Starters Orders.

SIAN (Sham Kumar) took a fly jump, did not raise a fluent gallop, lost many lengths at the start and ran detached from the field thereafter. In view of its behaviour, Trainer Mr. Yogesh R was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

ARMAMENT (M J Gautam Raj Urs) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Ranjeet Shinde was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey J Chinoy, the rider of MASTERCRAFT was fined **Rs.3,000/-** for shifting in and causing interference to NATURAL FLY (S Imran) on his inside along the rails, approaching the 300 Metres.

It was observed that MOON MILLY (Mukesh Kumar) ran detached from the field, after passing the 300 Metres. Trainer Mr. C D Monnappa was advised to ensure better performance of his charge in future.

**3<sup>rd</sup> Race. 10: The Treasure's Nest Plate (About) 1100 Metres. For horses rated 20 to 45, 5 years old and over (12 runners):**

ELEVADO (B Darshan Anthony) took a fly jump at the Start.

Jockey Rahil Akhtar, the rider of COORG GENERAL was reprimanded for travelling wide after rounding the final bend and thereafter for further drifting out and racing on the outer portion of the track for no apparent reason.

Jockey Rahil Akhtar, the rider of COORG GENERAL reported that he accidentally lost his whip passing the 400 Metres.

Jockey P Siddaraju, the rider of FASHIONISTA reported that he accidentally lost his whip passing the 350 Metres.

Jockey Ankit Pal, the rider of SECRET SHADOW was reprimanded for riding an indifferent race.

Jockey Shah Alam, the rider of VIJAYA STAR was reprimanded for riding an indifferent race.

THE GREY GERANIUM (Afsar Khan) was impounded for veterinary examination but no abnormality was reported.

Routine Sample was taken for analysis from the winner b g ARIKATTU.

**4<sup>th</sup> Race. 11: The Kakanakote Plate – Div.II (About) 1400 Metres. For horses rated 40 to 65 (10 runners):**

SAPIENT (L Alex Rozario) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. J S Pillay was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

GOLDEN BIRD (S Imran) planted and lost many lengths at the start. In view of its behaviour, Trainer Mr. Helleal R Moses was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey K Sai Kiran, the rider of SWAGHATHAM was reprimanded for riding an indifferent race.

It was reported after the race that ISABELLE (Brijesh Kumar V) apparently lost its left hind shoe during the race.

**5<sup>th</sup> Race. 12: The Dr. M N Doreswamy Memorial Trophy (About) 1200 Metres. For horses rated 60 and above (7 runners):**

Permission was granted to Trainer Mr. C D Monnappa to **withdraw** OCEAN (N Darshan) on veterinary grounds as it was found to be lame on left fore due to infected capped elbow. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

Jockey Shamaz Shareef was fined **Rs.2,000/-** for having accepted to ride MAGIC CIRCLE without having a valid Jockey's License to ride. As no suitable substitute rider as available, permission was granted to Trainer Mr. Bipin V Salvi to **withdraw** MAGIC CIRCLE from the above race.

Jockey Sai Kiran K, the rider of ABSOLUTE CHALLENGER, was reprimanded for shifting in and inconveniencing GRIZZLY (Shyam Kumar)[CHE] on his inside, which in turn went onto SEA OF ADVENTURE (Saman Khan) on its inside, due to which the latter horse shied away inwards at the Start. Thereafter, SEA OF ADVENTURE (Salman Khan) did not raise a fluent gallop and trailed the field till about the 700 Metres.

Jockey Sonu Mishra, the rider of MIDSUMMER STAR was reprimanded for allowing his mount to drift out passing the 650 Metres for no apparent reason and finished the race on the center of the track.

**An enquiry is being held into the running and riding of GRIZZLY, trained by Mr. Majid Khan and ridden by Jockey Shyam Kumar [CHE], in the above race.**

**6<sup>th</sup> Race. 13: The Manasagangotri Plate (About) 1600 Metres. For horses rated 20 to 45 (9 runners):**

GAJABO GRANDE (Salman Khan) was extremely fractious on the way to the Starting gates whereby the rider was injured. Under the circumstances it was permitted to be **withdrawn** before coming under Starters orders.

It was reported after the race that FREE TO WIN (Koshi Kumar) apparently lost its right fore shoe during the race.

**An enquiry is being held into the running and riding of SANDAL KING, trained by Mr. Feroz M Khan and ridden by Jockey M Prabhakaran in the above race.**

Routine sample was taken for analysis from the winner, ch g TIGERKING.

**7<sup>th</sup> Race. 14: The Kakanakote Plate – Div.I (About) 1400 Metres. For horses rated 40 to 65 (8 runners):**

SQUARE CUT (N Arvind Kumar) was examined at the Starting Gates by the Club's Veterinary officer was found to be trotting lame on right hind. Under the circumstances it was permitted to be **withdrawn** on veterinary grounds before coming under starter's orders. Trainer Mr. G T Surender was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with again.

GRACE (B Darshan Anthony) planted, lost many lengths at the start and did not take any practical part in the race. In view of its behaviour, Trainer Mr. Aditya Kwas informed he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the Race Track.

Jockey M J Gautam Raj Urs, the rider of MIRACULOUS GIRL was reprimanded for riding an indifferent race.

Jockey A R Pradeep, the rider of BRAVE TROOPER was reprimanded for riding an indifferent race and he was further cautioned that a similar manner of riding will entail him being reported to the Stewards for strict disciplinary action.

D ADMIRAL (B Darshan Anthony) – Was permitted to be withdrawn before coming under Starters Order, as the gelding bolted on its way to Starting Gate.

SIAN (Sham Kumar) – Took a fly jump ad lost many lengths.

ARMAMENT (M J GautamRajUrs) – Planted and lost many lengths.

#### **3<sup>rd</sup>Race: 10. The Treasure's Nest Plate (About) 1100 Metres:**

ELEVADO (B Darshan Anthony) – Took a fly jump.

#### **4<sup>th</sup> Race: 11. The Kakanakote Plate – Div. II (About) 1400 Metres:**

SWAGHATHAM (K Sai Kiran) } – Were slowly away.  
NATURAL WARRIOR (Rajesh K) }

GOLDEN BIRD (S Imran) } – Both planted and lost few lengths.  
SAPIENT (L Alex Rozario) }

#### **5<sup>th</sup> Race: 12. Dr. M N Doreswamy Memorial Trophy (About) 1200 Metres:**

GRACE (B Darshan Anthony) – Planted and took no practical part. The Starting Stall Certificate revoked.

### **ORDER OF THE BOARD OF APPEAL**

#### **STAY ORDER**

#### **RACE NO. 1: THE NANJANGUD PLATE (ABOUT) 1200 METRES. FOR HORSES RATED 00 TO 25:**

In deference to the request of Jockey Koshi Kumar vide his appeal letter dated 21<sup>st</sup> November, 2025, the Board of Appeal of the Mysore Race Club Limited has **decided to stay** the operation of punishment meted out to him by the Stewards of the Mysore Race Club Limited at their meeting on 19<sup>TH</sup> November, 2025, wherein the Stewards had suspended the Jockey's License granted to Jockey Koshi Kumar under the My.R.C. Ltd., Rules of Racing, for the year 2025-26, for 3 months, i.e., from **29<sup>th</sup> November, 2025 to 28<sup>th</sup> February, 2026** (both days inclusive) (not permitted to ride work) for breach of Rule No. 161 (i) of the Mysore Race Club Ltd., Rules of Racing [Foul Riding], pertaining to his riding on his mount EIFFEL TOWER, in the above race, until his appeal is finally heard and disposed off, by the Board of Appeal.
