RACING INCIDENTS

(Race No. 97 - 104)

Weather : Clear
Track Condition : Good Going
Penetrometer reading : 3.0 Cms.
Positioning of Railings : Railings are fixed at its original position.

1st Race: 97. The Royal Calcutta Turf Club Trophy – Div. II (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (11 Runners):

TWILIGHT FAME (M Rajesh Kumar) planted and lost many lengths at the start; In view of its behaviour, Trainer Mr. Ramesh S was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race**, on a Race Day on the race track.

MEGHANN (Abhishek Mhatre) jumped awkwardly `outwards', at the Start.

FACETS OF LIFE (Faiz) ran detached from the field after entering the straight. Trainer Mr. Monnappa C D was informed to ensure better performance of his charge, in future.

Jockey Angad, the rider of RISING SUN was fined **Rs.5,000/-** for excessive use of whip, on his mount, in the above Race (**2nd infringement**).

It was reported after the Race that PHOENIX SURPRISE (P Sai Kumar), had apparently lost its left fore shoe, during the race.

2nd Race: 98. The Royal Western India Turf Club Trophy (About) 1200 Metres. Horses rated 40 to 65, 5 years old and over (12 Runners):

Jockey Vivek G, the rider of GOLDEN TIME, was reprimanded for shifting `in' and inconveniencing PROUD (M J Gautam Raj Urs), on his inside, at the Start.

HIGH OPINION (P Sai Kumar) stumbled, soon after jumping out of the Starting Gates.

Jockey Koshi Kumar, the rider of HASTING SUNRISE was fined **Rs.3,000/-** for shifting `in' and causing interference to FLYING FALCON (Imran Chisty), on his inside which went onto KENSINGTON COURT (P Kiran Rai) and GOLDEN TIME (Vivek G), on its inside, after entering the straight.

Jockey R Shiva Kumar, the rider of WORLDLY WISE, reported that his mount was looking to run out throughout the bend and further drifted out while entering the Straight. The horse was impounded for veterinary examination, but no abnormality was reported. However, Trainer Mr. Surender G T was informed to take appropriate corrective measures, before accepting with it again.

3rd Race: 99. The Hyderabad Race Club Trophy (About) 1400 Metres. Horses rated 40 to 65 (13 Runners):

Permission was granted to Trainer Mr. M Bobby to **withdraw** MARZGOVEL on veterinary grounds as it reported to have burst its blood vessels after pace work on the morning of 24th October, 2024. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Permission was granted to Trainer Mr. J S Pillay to **withdraw** DABEET (Anil Baandal) on veterinary grounds as it was reported to have sustained a two inch long cut injury on its nasal bridge. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

TERMINATOR (M Prabhakaran) was slowly away and lost few lengths at the start; In view of its behaviour, Trainer Mr. Vishal Yadav was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

MAGIC CIRCLE (A R Pradeep) was slowly away and lost few lengths at the start; In view of its behaviour, Trainer Mr. Bipin V Salvi was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey A R Pradeep, the rider of MAGIC CIRCLE was fined **Rs.2,000/-** for not being alert at the Start.

Jockey Vinod Shinde, the rider of LG'S STAR was fined **Rs.3,000/-** for shifting 'in' and causing interference to BORN DANCER (Afsar Khan) on his inside 100 Metres from the start.

Jockey Akash Agarwal, the rider of LUCKY POINT was fined **Rs.3,000/-** for shifting 'in' sharply and causing interference to MAGIC CIRCLE (A R Pradeep), on his inside, passing the 1200 Metres.

Jockey Afsar Khan, the rider of BORN DANCER, reported that the saddle on his mount was not fastened properly and as such he felt that his saddle shifted slightly back, soon after the Start. After due examination of the equipment, particularly the Girth and Surcingle, which was found to be in an unserviceable condition, Trainer, Mr. P Ruban [deputizing on behalf of Trainer, Mr. J Ganesh] was fined **Rs.5,000/-** for using faulty equipment while saddling.

An enquiry was held by the Stipendiary Stewards into the inconsistent pattern of running and the resultant improved performance of FREE TO PLAY (A Prakash), trained by Mr. Kishan Thomas, the winner of the above Races as compared to its previous run in Race No. 87 of the Mysore (Monsoon) Races, 2024, i.e., The Alekona Trophy – (About) 1600 Metres, for horses rated 40 to 65, run on Fourteenth Day, Friday, 18th October, 2024, when ridden by Jockey Koshi Kumar, it ran unplaced. The Stipendiary Stewards examined the Trainer, Mr. Kishan Thomas, immediately after the above Race. Not satisfied with the explanations tendered by him, the Stipendiary Stewards decided as follows;

a) To fine Trainer Mr. Kishan Thomas a sum of **Rs.10,000/- (Rupees Ten Thousand only)** for the inconsistent pattern of running and the resultant improved performance of his charge, FREE TO PLAY (A Prakash), in the above Race; and

b) To caution Trainer Mr. Kishan Thomas that a repeat of a similar manner of running of his charges in future, would entail him being reported to the Stewards for appropriate action.

Routine Sample was taken for analysis from the winner, b g FREE TO PLAY.

4thRace: 100. The Bangalore Turf Club Trophy (About) 1200 Metres. Horses rated 80 and above (7 Runners):

Permission was granted to Trainer Mr. Aditya K to **withdraw** GOLD KITE (Imran Chisty) on veterinary grounds as it was observed to be suffering from colic. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

THE PERFECT CHOICE (Vinod Shinde) was slowly away and lost few lengths at the start; In view of its behaviour, Trainer Mr. Warren Singh was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

Jockey Faiz, the rider of BRAVE TROOPER, was fined **Rs.3,000/-** for repeatedly shifting in and squeezing STAR GLORY (M Prabhakaran) for room, on his inside, from the 800 Metres till about the 300 Metres.

It was observed that VIJAYA FALCON (Koshi Kumar) drifted 'out' under pressure, in the straight.

5th Race: 101. The Mysore Race Club Anniversary Cup – 2024 (About) 1400 Metres. For Indian horses 3 years old and over (5 Runners):

AMAZING A ONE (P Sai Kumar) ran detached from the field, in the last 400 Metres of the Race. Trainer Mr. Mansoor Khan was informed to ensure better performance of his charge, in future.

6th Race: 102. Cubic Mysore Derby 2024 (Grade I) (About) 2000 Metres. For 3 year old Indian horses [Foaled in 2021] (6 Runners):

Jockey S J Moulin, the rider of JOHN WICK was fined **Rs.5,000/-** not maintaining a proper course, in that, he shifted 'in', causing severe interference to MANDARINO (L Alex Rozario), on his inside, at the Mile Marker.

Jockey Suraj Narredu, the rider of BOURBONAIRE was fined **Rs.2,000/-** for shifting 'in' and inconveniencing THE LEADER (P Trevor), on his inside, in the closing stages of the Race.

It was reported after the Race that AMIGO (Akshay Kumar) pulled up lame on right fore. Trainer Mr. Magan Singh Parmer was informed that he must produce a

Fitness Certificate from the Club's Veterinary Officer before accepting with it again.

Compulsory Sample was taken for analysis from the following first three placed horses:

7th Race: 103. The Madras Race Club Trophy (About) 1600 Metres. Horses rated 20 to 45 (14 Runners):

Trainer Mr. Md. Sajid Qureshi was fined a sum of **Rs.10,000/- (Rupees Ten Thousand only)**, by the Stewards for having entered his charge SQUARE THE CIRCLE and not accepting it to run, in the above Race.

Permission was granted to Trainer Mr. Ramesh S to **withdraw** HIDDEN PLEASURE (Angad) on veterinary grounds as it was observed to be lame on left fore due to injury on the cannon bone. He was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

DORNISH (Imran Chisty) walked out of the gates and lost few lengths at the Start; In view of its behaviour, Trainer Mr. Aditya K was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Jump Out** on a Starting Gate Practice Day.

NATURAL LIGHT (Shyam Kumar) planted and lost many lengths at the start; In view of its behaviour, Trainer Mr. Mansoor Khan was informed that he must not accept with it again until its behaviour improved to the satisfaction of the Stipendiary Stewards in **One Mock Race** on a Race Day on the race track.

DORNISH (Imran Chisty) sustained small cuts inside both hind pastern.

8th Race: 104. The Royal Calcutta Turf Club Trophy – Div. I (About) 1100 Metres. Horses rated 20 to 45, 5 years old and over (11 Runners):

Jockey Afsar Khan, the rider of EXTRAORDINARY was fined **Rs.5,000/-** for not making sufficient effort to ride out his mount, throughout the race.

Jockey Angad, the rider of STAR JEWEL was fined **Rs.3,000/-** for riding an indifferent race.

It was reported after the Race that SILVER SWIFT (A Prakash) pulled lame on right fore. Trainer Mr. Kishan Thomas was informed that he must produce a **Fitness Certificate** from the Club's Veterinary Officer before accepting with it again.

Routine Sample was taken for analysis from the winner, b m SILVER DAYS AGAIN.

Permission was granted to Trainers M/s Mr.P Ruben and S Narredu to deputize on behalf of Trainer M/s Ganesh J and Rajesh Narredu respectively, who was unable to attend the Races.
