TERMS AND CONDITIONS

Sealed Tenders from experienced persons in the field of Hotel and Catering Services are invited for maintaining and running the canteen in the Mysore Race Club Eye Hospital premises at Siddhartha Layout subject to the following conditions.

1. Rs.500/- towards application fee.
2. The canteen will be operational in the canteen building situated in the hospital premises from 8.00 A.M to 6.00 P.M.
3. The period of permission to run the canteen will be for 01 year from 1st November,2022.
4. EMD of Rs.1000/- is payable through cheque in the name of MRC Charitable Trust by cheque.
5. An interest free Security Deposit of Rs.25,000/- is to be lodged with the MRC Charitable Trust by the successful bidder.
6. Tenderer to mention the offer of monthly fee payable to the Myrc Eye Hospital plus taxes applicable during the period of the contract.
7. The canteen shall be run in highly hygienic and clean condition.
8. The successful bidder shall have humane approach towards the patients, patients' attendees, staff members and customers who may visit canteen for the purpose of refreshments.

9. Hot Hygienic food shall be served in the canteen.
10. Fresh fruit juice be made available in the canteen for serving.
11. The Successful bidder shall serve filtered water for drinking purpose to the customers.
12. The successful bidder shall maintain clean and dust free atmosphere in the canteen.
13. The tables, chairs and vessels and Gas cylinder are to be arranged by the successful bidder.
14. The canteen premises shall be kept cleaned on regular basis every day to keep it free from flies and hovering the sweet articles and juice.
15. The food items may cover availability of idli, vade, chatni, sambar, Chappati Sagu, Dosa, Rice Bath, upma, kesaribath, bajji, bonda, coffee, tea, milk with and without sugar and other snacks.
16. The Successful bidder shall keep the delicious nature of food keeping in mind the health of the customers.
17. All the utensils of the canteen shall have to be washed in the hot water.
18. The Successful bidder shall not use plastic tumblers or polyethene covers, which are banned.
19. There shall not be sale of the Tobacco items in the canteen premises.
20. Successful bidder shall install a refrigerator at his own cost during the period of license.
21. The successful bidder shall not make any alternations in the building.

22.The successful bidder shall take back all the movable articles kept by him after the expiry period of contract.

23.Sealed and tamper proof envelopes containing tenders will have to be handed over to the Administrator on or before 5.00PM on 19.10.2022 .

24.The successful bidder will have to sign the undertaking containing the conditions as may be imposed by the trust.

25.The contract can be terminated by the trust with the notice 30 days and the contractor will have to vacate the canteen premises upon the expiry of the period of contract.

26.The Successful bidder shall not sub-let or induct third parties through any manner for running the business of canteen.
